I understand that monthly tuition payments are due on the first of each month and are late after the 15th. A \$50 late fee will be charged on all late payments. Tuition for withdrawals and late enrollment during the school year will be billed as follows: A two (2) week notice is REQUIRED. If less than two weeks notice is given, tuition charges may be levied. Tuition will be calculated on a per diem basis for days enrolled, taking the two (2) week notice into consideration. I. ____ Returned Checks: Checks that are returned from the bank are subject to a charge of \$40. After two returned checks in a school year, further payments must be made in cash, with a cashier's check, or money order. J. I understand that if my tuition account becomes more than 30 days past due my child(ren) will be excluded from classes until paid or satisfactory arrangements are made with the ESCS Finance Committee. Parent Service Requirement of 15 units is required annually. I understand that a \$100 deposit is required annually by September 1st. If the annual requirement of 15 units is fulfilled, the \$100 fee can be applied to the next school year. See The Parent Policy Handbook for details.
