- ✓ **Background Check** (every five years) *IRBC will email applicant a link to submit info for background check.*
- ✓ Child Safety Training (every two years)

 After submitting background check form you will receive a link to complete the online Child Safety

 Training. This training & quiz will take 65 minutes. This video training is required every two years.
- ✓ Counselor Training Weekend April 26-27, 2024

 All first time counselors must attend counselor training, returning counselors must attend every two years (but we strongly encourage you to attend each year!)
