### **All Counselors must complete these requirements before counseling at IRBC!**

- ✓ **Counselor Application** - with Pastor's Signature (every year)  
*Submit to IRBC via mail or email: [camp@irbc.org](mailto:camp@irbc.org) Due date: April 15, 2026*
- ✓ **Background Check** (every five years)  
*IRBC will email applicant a link to submit info for background check after Counselor Training.*
- ✓ **Child Safety Training** (every two years)  
*After submitting the background check form you will receive a link to complete the online Child Safety Training. This training & quiz will take 65 minutes. This video training is required every two years.*
- ✓ **Counselor Training Weekend** – April 24-25, 2026  
*All first time counselors must attend counselor training, returning counselors must attend every two years (but we strongly encourage you to attend each year!)*

### REQUIREMENTS:

1. All counselors must fill out current year's application form with signature of pastor.
2. **Counselors will receive an email with instructions on how to submit a background check. (Required every five years.)**
3. **Counselors are required to watch the online Child Safety Training and complete quiz BEFORE counseling.**  
*Due Date: June 1<sup>st</sup>! (Online training must be completed every two years.)*
4. **Junior Camp Counselors** must be 19 years old or have completed one year of Bible college.
5. **Junior High Camp Counselors** must be married or 21 years old or have completed one year of Bible college.
6. **Senior High Camp Counselors** must be married or 23 years old or be a Bible college graduate.
7. Counselors should be socially and emotionally balanced and able to fit into camp life.
8. Counselors should be spiritually mature, able to lead someone to Christ and to give Biblical counsel for the various other needs of young people.
9. Counselors must be a member of IARBC or an approved partnering church and in agreement with the Doctrinal Statement of Iowa Regular Baptist Camp.
10. **All first-time counselors** must attend IRBC Counselor Training.
11. Repeat counselors must attend IRBC Counselor Training at least every two years. *(You are strongly encouraged to attend every year.)*
12. **Assistant Counselors** must be within two years of the age required for a counselor of a particular camp.
13. As representatives of the camp staff for the week, agree to model modesty and discretion for our campers with your appearance and actions.
