## **1. Purpose of Agreement**

This Agreement outlines the terms and conditions under which the Student is permitted to park their vehicle on the Church's property during the specified school year.

## **2. Term of Agreement**

This Agreement shall commence September 2025 and shall terminate July 2026, unless terminated earlier as provided herein. This term covers the regular school year, excluding school holidays, summer breaks, and any other periods when the school is not in session, or as otherwise specified by the Church.

## **3. Parking Location**

The Student is permitted to park their vehicle in the designated parking areas of the Church property, as designated by their parking permit number or other agreed upon and documented space.

## **4. Parking Fees**

The fee for parking for the 2025-2026 school year is \$350 per year. Payments can be made check or online via Square.

- Checks should be made out to Regeneration Church with "RC – Parking" in the memo line.

## **5. Rules and Regulations**

The Student agrees to abide by the following rules and regulations while utilizing the Church's parking facilities:

- Designated Parking: Park only in areas specifically designated for student parking. Parking in fire lanes, handicapped spaces (without proper permit), reserved spaces, or blocking access will result in penalties.
- No Overnight Parking: Vehicles are not permitted to be parked overnight unless explicit written permission is obtained from the Church administration.
- Vehicle Condition: Vehicles must be in operating condition and display a current license plate and registration.
- Speed Limit: Observe all posted speed limits and no more than 10mph in the church parking lot.

- **Respectful Conduct:** Students and their passengers must conduct themselves respectfully while on Church property. Loud music, loitering, littering, or any disruptive behavior is strictly prohibited.
- **No Loitering:** The parking lot is for parking vehicles only. Students are not permitted to loiter in the parking lot before or after school hours.
- **Church Events:** The Church reserves the right to request the temporary removal of vehicles from the parking lot for special Church events. Advance notice will be provided whenever possible. Failure to move the vehicle may result in towing at the Student's expense.
- **Damage:** The Student is responsible for any damage caused by their vehicle to Church property.
- **Parking Permit/Identification:** If provided by the Church, the Student agrees to display the assigned parking permit/identification clearly on their vehicle at all times while parked on Church property.
- **Compliance with Laws:** The Student agrees to comply with all applicable local, state, and federal laws and ordinances while on Church property.

## **6. Enforcement and Penalties**

Violation of any terms of this Agreement may result in, but is not limited to, the following:

- Issuance of warnings.
- Revocation of parking privileges.
- Towing of the vehicle at the Student's expense.
- Reporting of serious infractions to school authorities or law enforcement.

## **7. Liability**

The Church is not responsible for any loss, theft, or damage to the Student's vehicle or its contents while parked on Church property. The Student parks at their own risk.

## **8. Termination of Agreement**

This Agreement may be terminated by the Church at any time, with or without cause, by providing written notice to the Student. The Student may terminate this Agreement by providing written notice to the Church. Upon termination, the Student must immediately cease parking on Church property.

There are no automatic refunds of parking fees.

## **9. Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of the State of Washington.
