CHURCH POLICIES:

Due to our Insurance carrier requirements, prudence, and good stewardship of God's provision, we require thefollowing:

- 1. All students participating in any church sponsored event will have this signed permission form returned to the church leaders responsible for the event.
- 2. Any exceptions to the policies will be handled and approved **before** the day of the event. Once the event has started, there will be no deviation from the policies unless an emergency situation arises.
- 3. The church leaders responsible for directing the event has the last word on all matters of direction and discipline. If it becomes necessary for a person to be asked to go home early, that person may forfeit participation in the next event and mandates parental contact.

We expect each student to conform to the following rules of conduct. It is the parent/guardian's responsibility to explain and ensure their student understand all rules and expectations prior to leaving Real Life Church:

- No possession or use of alcohol, drugs or tobacco
- No students can drive during Church sponsored activities
- No fighting, weapons, fireworks, lighters, or explosives
- No offensive or immodest language or clothing
- No boys in girls' sleeping quarters/restrooms and no girls in boys' sleepingquarters/ restrooms
- No Electronic Devices (See, Policy 2 above for Exception Policy)
- Participation with the group is expected
- Respect property and grounds
- Respect one another, staff, and adult leaders
- Respect and comply with event schedules

Students who fail to comply with these expectations may be sent home at their parents/guardians' expense.
