#### **BY-LAWS**

#### **ARTICLE I – ADMISSION INTO MEMBERSHIP**

#### A. BAPTIZED MEMBERSHIP

#### 1. Reception:

Baptized members are received into membership in this congregation through the Sacrament of Holy Baptism, through transfer, or with the consent of both parents or guardians in the case of children who have been baptized in another Christian congregation.

#### 2. Duties:

Baptized Members shall conform their lives to their baptismal vows.

#### **B. COMMUNICANT MEMBERSHIP**

#### 1. By confirmation

Confirmation itself being a reception into church membership, all who are thus received by this sacred act become communicant members.

#### 2. By transfer

Persons coming with a communicant letter of transfer from a congregation in church fellowship, provided they conform in all requirements of membership of this congregation, shall be received by the Pastor, whose action is to be approved in a subsequent meeting of the Voters' Assembly.

#### 3. By Declaration of Faith

Persons seeking membership and fellowship, holding membership in other Lutheran Bodies shall sign a Declaration of Faith, attend and complete an Adult Inquiry Class, and have their reception as members approved by the Voter's Assembly.

- E. The January regular meeting shall be designated as the annual meeting. The business of the annual meeting may be divided between the January meeting and special meetings in the preceding months of November or December.
- F. The meetings shall be conducted according to good Christian Order. Robert's Rules of Order may be followed for parliamentary procedure.
- G. No one shall bring to any meeting a charge or complaint against any member, or against the Pastor(s) or the teacher(s), unless he has first acted in accordance with Matthew 18: 15-20.
- H. Only Voting Members present at the meeting shall have the right to Vote. The Pastor and President are included in the voting membership.
- 1. In matters of doctrine and conscience, unanimity shall be required for final decision; but authority and jurisdiction to so decide shall be always subject to provisions of Article III and V of the Constitution. Except as specified in Article XIII of the Constitution and Article XII of the By-Laws, all other matters shall be disposed of by a majority vote.

The general order of business shall be:

- 3. Adoption of Minutes

- Reception of New Voting Members
- 6. Pastor's Report

- 8. Reports and resolutions of Board's and Offices
- 9. New business
- 10. Communications
- 11. Announcements
- 12. Adjournment and Prayer

#### ARTICLE V – ELECTION AND INSTALLATION OF OFFICERS

ach Otr A. The annual election of Officers shall be held during the regular October meeting of the Voters' Assembly. The election shall be by ballot and shall be held in such a manner that only one office at a time is elected. Nomination of candidates for respective offices shall be made by a nomination committee and from the floor.

- 10 Shall make and issue keys for church property and keep and review annually a list of keys issued.
- 11 Shall annually check adequacy of all types of insurance and negotiate insurance contracts.
- 12 Shall check all property twice a year for fire hazards.
- 13 Shall exercise good stewardship of congregational property by ongoing inspections.
- 14 Shall enlist work crews for special repair, improvement, cleaning, painting, decorating, landscaping and other projects.
- 15 Shall investigate and make recommendations on possibility of purchasing supplies cooperatively with neighboring church to achieve large-purchase economics.
- 16 Shall study and recommend policies regarding union labor, fair employment practices, etc., to be applied to suppliers and to the congregation.
- 17 Shall obtain legal information necessary for wise consideration of contracts, deeds, etc., by the congregation.
- 18 Shall sign official documents and contracts that have been negotiated and approved by the congregation.
- 19 Shall obtain legal information of the laws governing non-profit organizations.
- 20 Shall study and make recommendation on advisability of making voluntary payments for governmental services in lieu of taxes.

#### **BOARD OF FINANCE**

- 1. Shall consist of at least three members; Financial Secretary, Treasurer and the chairman of the Board of Trustees.
- 2. Shall prepare the congregational budgets and submit them for approval to the Voters' Assembly at the October Voters' Assembly. A member of the Board of Elders shall assist with considerations concerning church worker remunerations.

Boy Scout/Troop 128 Report

My report will explain and clarify new programs Boy Scouts of America has rolled out for 2018 and 2019. Then I will let you know about the accomplishments and activities so far this year with the Boy Scout troop we charter here at Grace.

Some of may or may have heard that BSA is allowing girls into the Scout program and they are calling it the "Scout Me In" campaign. This began in October 2017 with the younger Cub Scout levels (which serve youth ages 5 to 10). And they were able to officially enroll January of this year in an Early Adopter program, by Summer of this year, ALL councils will be able to register girls in Cub Scouts . Please note that for many years, Cub Scouting has been family-orientated and many Cub Scout Dens and Packs allowed the sisters of Cub Scouts to participate in their activities, but couldn't "officially" earn the belt loops and ranks. Cub Scout packs also conduct Family Camps where all have an opportunity to participate. This program will still be called Cub Scouts.

Recently, B.S.A. announced full rollout of registering girls into the Scout program serving ages 11 through 17. The name will be changed from "Boy Scouts" to "Scouts BSA". As you can imagine, this decision has ignited various reactions, pro and con from within the organization and without, such as Girl Scouts of America. I'd also like to mention here that B.S.A. has had co-ed programs for decades: Venturing, Exploring, STEM Scouts, and Sea Scouts. I participated for many years in the Exploring program in the late 1970's and 80's.

Here are some facts (from FAQ's):

- Scouts BSA program launches February 2019;
- Eligible age: completion of 5th grand and at least 10 years old; or earned Arrow of Light in Cub Scouts and at least 10 years old; or 11 years old, but not yet 18 years;
- Scout Program: curriculum will remain as it is currently offered;

**Adult leadership:** a boy troop and girl troop will *not* share the same Scoutmaster or Assistant Scoutmasters. The boy troop will have all male

adult leaders and the girl troop will consist of female adult leaders. Their roles, duties, and obligations to their respective troops will remain the same;

- Troop/Parent Committee: the chartered organization (such as Grace Lutheran Church, Ventura) can decide if they want the same or separate committees. This also applies to The Chartered Organization Representative;
- Youth: troops will consist of either all boys or all girls;
- Meetings: Based on the chartered organization preference, the boy troop
  and girl troop can meet at the same time and place; the opening and
  closing of the meetings can be together or separate, but the other
  components of a Scout meeting should be run separately;
- Events: boy troops and girl troops can attend events together, but the Patrol Leader's Councils of each troop should be responsible for planning their respective troop activities;
- Outings: boy troop and girl troop can coordinate outings together if they are Scout-related and follow the Guide to Safe Scouting and current Youth Protection guidelines;
- Courts of Honor: can be held jointly if the chartered organization chooses;
- Council and District Events: can be conducted for boy and girl troops if they and follow the Guide to Safe Scouting and current Youth Protection guidelines;
- Chartered Organization: is not required to offer a program for girls, but can decide which programs will best serve needs of their community. A C.O. can continue to offer Scouting for boys, or may choose to add an older girl unit.

That's pretty much summarizes the major points of this program. More information can be acquired on the B.S.A. website: <a href="www.scouting.org">www.scouting.org</a>.

Now, I would like acquaint you with what our Troop 128 has been doing this year.

The troop currently consists of 25 Scouts, the Scoutmaster,, 10 Assistant Scoutmasters, and a Parent/Troop Committee of several adults who conduct the behind-the-scenes business of the troop.

This troop has recently honored it's  $140^{th}$  Eagle Scout since it's original inception in 1965 with more boys working toward their Eagle rank.

### Activities and events since January of this year:

January - Winter Camp at Camp Wortman (about 60 miles east of Fresno)

- February 4 Scout Sunday was recognized during our church worship service followed by a pancake breakfast for church members prepared and served by our troop.
  - 10 Grace Service Project where Scouts and adults cleaned up around the portables and assisted with General Cleaning in the rooms and church;
  - 16 Winter Court of Honor ceremony held at Grace;
- March to May Kayak building sessions in preparation for the troop's mid-June 50 mile bi-annual Colorado River trip. Some of you may remember this troop was featured in last August's issue of Scouting Magazine about their previous trip;
- April 13 & 20 Participated multi-troop cleanup of McGrath State Beach in preparation for the Sespe District Camporee to be held there instead of Camp Willett in Ojai Valley due to fire and rain damage. I might add the State Park Service waived the campground fee because they did such an above and beyond fabulous job;
- May 11 Spring Court of Honor held at Grace;
- June 9 Grace Service Project where I'm working with the Trustee Board to

identify projects the troop can serve us here;
Following the service project, an Eagle Court of Honor and Bar-B-Q is planned here at Grace.

And, lastly, one of the Scouts from this troop received a citizen's Life Saving Citation Medal from the Ventura County Fire Department earlier this month at the Department's Annual Awards ceremony held at Padre Serra Church in Camarillo.

#### Speed bumps

We added two speed bumps to the church parking lot in April and May. This comes to \$120 a month, which is more than the \$1200 – but we are developing a schedule of reduced cleaning of the classrooms during the summer months, so we can stay within the Better Together donation and not go over our cleaning budget. Siding on portables

Siding was repaired on the portables and it looks so much nicer.

#### **Carpet Cleaning**

#### Floor stripping

Cleaning service has been stripping and resealing the floor in the kitchen and rooms 1-8.

#### Roof

During the rain in March & April, we developed several roof leaks – Room 5, Room 16, over the ficus in the entryway, over the choir & Scout room. Finally found the right roofer (third roofer was the charm), who came out the day after I called and repaired the leaks a week later.


