The organization's street outreach team conducted community events to address food insecurity by distributing meals and connecting individuals to partner agencies offering housing, employment, and health resources. The team also recruited, trained, and supported volunteer groups to operate mobile shower units, promoting hygiene and dignity for unhoused individuals. Additionally, the training team facilitated immersive and classroom-based learning experiences to equip individuals facing hardship and empower community members seeking to serve effectively.

The organization operated a wholesale coffee roasting initiative and a community cafe to support its exempt purpose of fostering cross-cultural connection, economic opportunity, and community engagement. The cafe provided a welcoming space for all individuals, created employment opportunities for people experiencing poverty, and supported a minority-owned small business through affordable rental space. These activities also served to raise awareness of the organization's mission and amplify the voices of marginalized community members through events and storytelling.
