The endowment fund remained well in 2023. Our invested monies exceeded our yearly payouts with the late year Financial market improvements. This is reflected in our treasurer's reporting in the Annual Report. The fund received \$180 designated to Endowment this past year. # Finance Report Pete Huber, Chairperson

Fiscal Year 2023 presented similar challenges for our congregation as we entered another year without a pastor. The unwavering financial response by the members of St Luke truly demonstrated our commitment to the mission of the church; yet again. **THANK YOU!!** Compared to 2022, St Luke regular giving increased by 3.5%; along with a 7.8% decrease in total operating expenses, resulted in an end of year **SURPLUS of \$54,890**. Our investment accounts finished the year positively.



St. Luke continues to be blessed by the generosity of our congregation. A few highlights and accomplishments of the congregation **beyond** our regular giving include:

- 4th quarter 2023 giving (\$46,636) was greatest quarter of generosity in St Luke history!!
- SLLC benevolence giving (\$7,078) met our 2023 SEPA-ELCA Benevolence Commitment (only short \$13)

In 2023, a further \$3,044 was designated **100<sup>th</sup> Anniversary Campaign**; with cumulative giving now exceeding \$118,000.

Social Ministry and Evangelism 2023 Annual Report

Our Community Clothing Rack is an asset to people in need of clothing. In addition to the Wednesday openings, our volunteers are available for emergencies. 2023 had requests for specific clients of Pottstown Salvation Army Shelter, Multi-Service, Opportunity House and the United Way Homeless Committee. Professional clothing was shared with PA Workwear for clients going back to work. Thank you to the dedicated volunteers who work in the CCR.

St. Luke members volunteer in several community organizations- Lions Club, Meals on Wheels, United Way, Multi Service, St. Luke Knolls Board, Rotary Club, and other service groups.

Many, many thanks go to St. Luke members who assist with all the Thrivent Action Team projects. We completed 18 grants in 2023. All it takes is an announcement in the bulletin for people to go to Memorial Hall after worship...and you come. You've filled bags for Meals on Wheels clients, emergency bags for Salvation Army and Multi-Service, "Bags of Blessings" for St. Luke Knolls residents, hygiene bags for the United Way Homeless task force and more. These projects are part of our social ministry commitment plus they also get the St. Luke name out in the community.

We sent "Thinking of You" cards to people in Bohodukhiv, Ukraine. Their students translated the cards for people in their community. Then the high school students sent us Christmas pictures which are on the hall bulletin board.

We donated food to Preston's Pantry at Multi-Service and the pantry at Salvation Army, warm clothing and socks to veterans, and Christmas gifts for Multi Service clients. You also provided new and gently used towels and linens to the Pottstown Salvation Army Family Shelter, plus suitcases for Safe Berks. The St. Luke knitters made hats for various groups. St. Luke is busy!

Thank you notes from various organizations are on the hall bulletin board.

None of this would be possible without your kindness and participation. Because of you the mission of St. Luke continues.

Each of these services requires a different type of bulletin. Therefore, lots of planning is done on a weekly basis! Communion? If an ordained pastor presides, it requires a different bulletin than if a Eucharistic Minister presides, and both require a different bulletin if a layperson, (when there is no communion) presides. If a Eucharistic Minister presides at a communion service, we need to make sure the wine and bread have been consecrated by an ordained pastor. Bulletins continued to be mailed to those who could not attend worship or didn't have internet accessibility. We continue to plan to have the most meaningful worship services we can, reaching out to as many people as we can, while trying to be as safe as we can in these times of covid, RSV, and the flu.

When the committee meets, we review past services, listen to ideas about "what's to come," and be as prepared as we can be for upcoming services. The committee also oversees ushers, acolytes, and any helpers who give of their time. Worship and Music also oversees Communion Assistants.

Then, there are the hymns and liturgy, and licensing for music so that we're sure it can be used when the service is mainstreamed. Many thanks to Lincoln Noecker, our Director of Music, for his thorough and wonderful work with this! Worship has been held in person, via livestream, and broadcast over 91.3 FM. Many thanks to our technicians, Mike Ferraro, Ron Hukari, Ron Ball, and Dave Janzow!

Many thanks to Linc for his many efforts in providing wonderful music for the most meaningful worship services we can offer our church. We also thank Val Schlegel who leads our bell choir. We thank them for their beautiful addition to our worship during special times of the year.

Our sacristans are responsible to make sure the correct paraments are in place, candles filled with oil, and communion vessels with wine and bread are set correctly on the altar and credence table. Donna Biehl has done a great job as leading our sacristans: Merrie Gephart, Sandi Quicksell, Valerie Schlegel, Donna Biehl, and Kathy Billger. ## St. Luke Knolls, Inc.

Kathy Billger, President

St. Luke Knolls, Inc. started with a vision from St. Luke Church thirty-six years ago to plan and develop a non-profit corporation to provide affordable housing for senior citizens from the surrounding area. We've now completed our 31st year of actual operation, and, there's currently a waiting list of 140 eligible applicants who would like to live at the Knolls. That's the good news!! The bad news is that there are forty units presently available, and all are occupied.

In 2011 a purchase of adjacent parcel #3 was made, rezoned to institutional. This parcel consists of 6.9 acres. This parcel will permit much needed housing expansion.

In April of 2022, the board, along with help of our Management Company, Grosse and Quade, and Judy Memberg, of Genesis Non-profit housing, completed an application to be submitted to the county for funds from the Pandemic Recovery Fund. We were thrilled to receive a grant of \$300,000.00. This, along with the land we currently own, will be a nice "start" to pursue additional affordable housing. We are currently working with a development company, HDC Mid—Atlantic, to see how we might work together to make a long time dream come true.

We worked towards a date of January 11, 2024, to submit an application to hopefully receive tax credits to be able to start building St. Luke Ridge, the 48 unit apartment building the architect for HDC drew up. Unfortunately, due to "a misunderstanding on the direction that we (HDC and St. Luke Knolls) want to achieve," the application will be held until the next round of applications, probably in late 2024.

This was our fifth year of operation without our longtime president, John G. Stasik, Jr. . The board of directors, along with help from Grosse and Quade Management Company, has seen fit to make some changes in the bylaws, and to elect officers. Those bylaw changes resulted in quarterly meetings as opposed to monthly, and more electronic communications between board members. A huge thank you to Stan Geiger, President of Grosse and Quade, and Pat Euston, Manager of St. Luke Knolls, for standing by the board, and helping with numerous details in this time of change and "moving forward."


