Treasurer's Report – income for the year was high

Thank You for the Generous large contributions

Marsha took unpaid leave. That's why \$ do not match.

Bobbie – we will be working on a retirement plan, health benefits are under Medicare. Bobbie commented she is happy with her compensation package.

Supply Pastors Sundays 16 for 2025 (once per month Bobbie is at St James per our sharing agreement; 4 for paid time off Sundays for Bobbie.

Parish Live items

XPO – billing error missed 2023, caught up now

2024 Budget Surplus (Lee Moyer), how to get members to continue to contribute if we had too much money. The surplus was high, because we did not have all the expenses of a fulltime Pastor. In the interim much of the proposed budget just wasn't spent. We did a remarkable job of continuing St Luke even without a Pastor for a long transition process. How can we manage our surplus funds?? Outreach, Education, other planning for future expenses.

Discussion: Dave Janzow – St Luke membership is getting older. Think about making donation to St Luke as a qualified charitable distribution QCD direct from your IRA counts toward required RMDs for that year. It is not considered income for tax purposes. You can then direct donations (\$50 minimum) to any qualified organization.

2025 – Planning

Endowment fund discussion 5% of year-end balance is designated for distributed for the new year. Checkbook balance for the year end is high, but Finance Committee will move funds to higher interest rate accounts. (i.e. Money Market Fund)

Discussion: We need to look at our current building and facilities so we can plan and budget for future maintenance.

Issue: Sandy Quicksell. Vent to outside in heater room, cold air causes problems and more heat cost.

Tom Undercuffler. Let him know of any maintenance needs. He added hot water unit to Sacristan's sink.

Stewardship – planning ahead, review money and how we can use it.

Auto allowance – Question; Why are we not paying for Auto Allowance St James is paying car expense, Bobbie doesn't does not need a car allowance from St Luke.

Property Expenses

- Telephone & Comcast-Business Internet increased, per contract. (We are always looking for promotions to lower this cost.)
- Oil prices are down, boiler efficiency up, so we cut the budget accordingly
- Water Testing is lower due to new contractor at ½ prior cost
- Office postage down due to less mailings, Donation envelope increased on lower number of boxes
- Technology spending up slightly.
- Worship Supplies lower are due to not using as many prefilled communion cups
- Bank charges increased – includes safe deposit box, Check scan, Vanco fee(Simply Giving)

Overall Expense Budget Increase 2% over 2024

Benevolence – Budgeted amount set by averaging last three years of giving.

Question: Lee Moyer asked if we have Cleaning Contractor; YES cost is \$175 / week

Discussion Bobbie: Christian Ed needed so we can reach out to families with children. How do we attract families? Consider being on one of the many committees to help develop and expand efforts.

The following are highlights from our busy year:

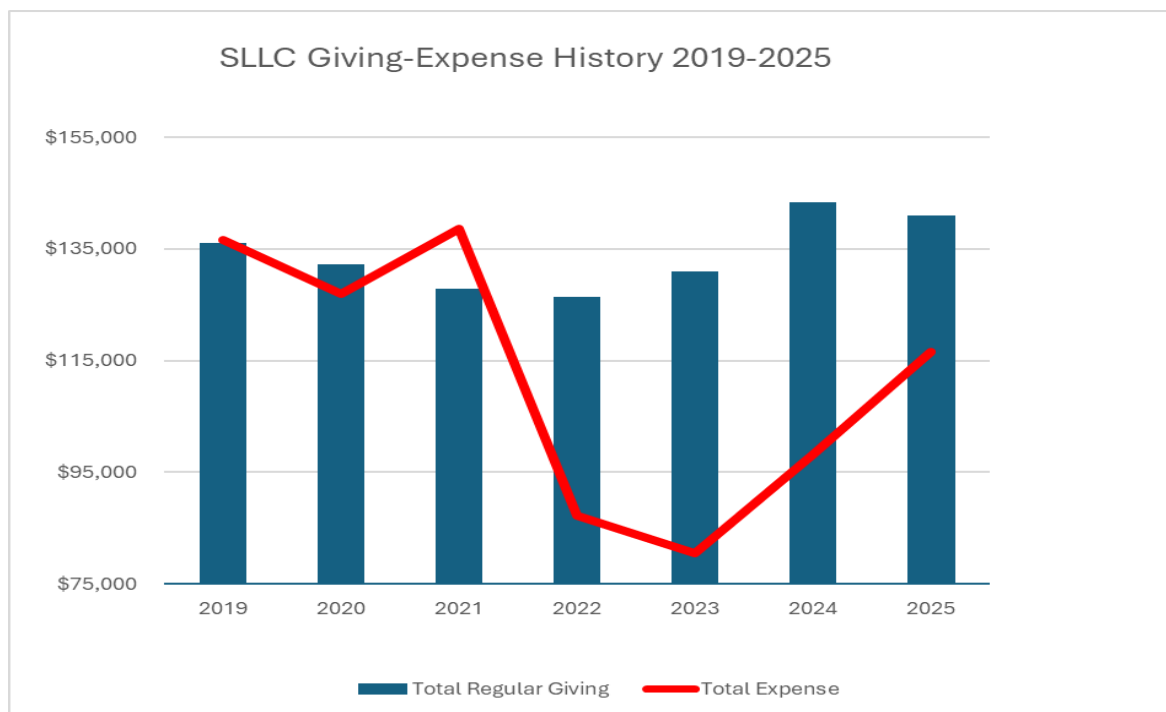

Fiscal Year 2025 presented similar challenges for our congregation as Minister Bobbie settled into her role as pastor of St. Luke, we wished Marsha Staub a retirement farewell and welcomed Christine Winsor into the office staff. The unwavering financial response by the members of St Luke truly demonstrated our commitment to the mission of the church. **THANK YOU AGAIN!** Compared to 2024, St Luke's regular giving decreased slightly by 1.6% while our operating expenses increased 18.7%; however, we were still ended 2025 with a **SURPLUS of \$24,364**. All our investment accounts continued to grow.



St. Luke continues to be blessed by the generosity of our congregation. A few highlights and accomplishments of the congregation **beyond** our regular giving include:

- 4th quarter 2025 giving (\$51,055) ranks 2nd in generosity for a quarter in St Luke history; with November giving totaled of \$25,844!! Maintaining a surplus in giving for 4 consecutive years.
- SLLC benevolence giving (\$6,351) was slightly short our 2025 SEPA-ELCA Benevolence Commitment (short \$524).

St. Luke Knolls, Inc.

St. Luke Knolls, Inc. started as a vision from St. Luke Church thirty-eight years ago to plan and develop a non-profit corporation to provide affordable housing for senior citizens from the surrounding area. We've now completed our 33rd year of actual operation, and, there's currently a waiting list of 149 eligible applicants who would like to live at the Knolls. That's the good news!! The bad news is that there are forty units and all are occupied.

In 2011 a purchase of adjacent parcel #3 was made, rezoned to institutional. This parcel consists of 5.9 acres. This parcel will permit much needed housing expansion.

In April of 2022, the board, along with help of our Management Company, Grosse and Quade, and Judy Memberg, of Genesis Non-profit housing, completed an application to be submitted to the county for funds from the Pandemic Recovery Fund. We were thrilled to receive a grant of \$300,000.00. This, along with the land we currently own, was a nice "start" to pursue additional affordable housing. We entered into numerous discussions with a development partner, HDC Mid-atlantic, in hopes of beginning to make our dream come true.

We worked towards a date of January 11, 2024, to submit an application to hopefully receive tax credits to be able to start building St. Luke Ridge, the 48 unit apartment building the architect for HDC drew up. Unfortunately, due to "a misunderstanding on the direction that we (HDC and St. Luke Knolls) wanted to achieve," the application would be held until the next round of applications, probably in late 2024. In March of 2024, we received word that the Sr. Vice-president of HDC, left the organization. We then met with the CEO in hopes of continuing our work with HDC. In early April, I received a voicemail, telling me that the board of HDC and she could not "find a pathway forward" with St. Luke Knolls.

As a result, we started looking for a new development partner. We are pleased to share the news with you that we are now working with Mission First. We've got architects' renderings of not one, but two apartment buildings. The first is named St. Luke Ridge, and the second, St. Luke Terrace. . We just received word that applications for tax credit applications will not be accepted until 2027.

This was our seventh year of operation without our longtime president, John G. Stasik, Jr. . The board of directors, along with help from Grosse and Quade Management Company, has seen fit to make some changes in the bylaws, and to elect officers. Those bylaw changes resulted in quarterly meetings as opposed to monthly, and more electronic communications between board members. A huge thank you to Stan Geiger,

President of Grosse and Quade, and Pat Euston, Manager of St. Luke Knolls, for standing by the board, and helping with numerous details in this time of change and “moving forward.” We also continue to “move forward,” thanks in large part to our consultant, Judith Memberg, of Genesis Housing Corporation. Now, we are again looking at our bylaws to make sure our actions are in keeping with those bylaws.

We were saddened by the loss of Jim Hollenbach, and by Dave Janzow's resignation from the board with his move to Tennessee.
