INCORPORATION UPDATE & DIRECTIVES

As a means of legal protection, *all local churches*, regardless of size, are encouraged to incorporate. Specific incorporation documents have been prepared for the Churches of God of Prophecy across the United States through an attorney, in conjunction with our International Office. Details on how to begin the incorporation process are in the Pastor's Resource Guide.

The attorney noted below is handling *all* Church of God of Prophecy incorporations across the United States. To keep the incorporation paperwork in alignment with our doctrinal guides, policies, etc., each local church is requested to go through this attorney for incorporation.

The cost of incorporation is approximately \$700 - \$1000.

STEPS FOR A CHURCH OF GOD OF PROPHECY LOCAL CHURCH TO INCORPORATE:

- 1. Pass in a local church business conference the decision to incorporate.
- 2. Send the "Local Church Request for Consent to Incorporate" form (copy attached) to the State Office, along with the local church business conference minutes.
- 3. A Letter of Consent will then be issued to the church from the State Office.
- 4. The local church will mail to the attorney (Steve Lentz, 381 Edwin Drive, Virginia Beach, VA 23462) the "Local Church Questionnaire" (attached) along with a copy of the Letter of Consent from the State Office.
- 5. The attorney's office will then be in contact with the local church/pastor for the remainder of the process All further dealings will be between the local church and the attorney.
