REPORT OF THE ANNUAL CONFERENCE MINUTES

GLD Conference Business Meeting | October 11, 2022 | The Chapel, St. Joseph MI

Presentation by Samaritan's Purse

Testimony by Vladimir, a native Ukrainian man. He spoke of his father, who was an underground pastor in Ukraine, and a life of scarcity as one of 9 children. Receiving an Operation Christmas Child shoebox was a delight to him because of the provisions, but especially because it contained the gospel.

- We thanked Samaritan's Purse for providing our business lunch today.
- Carlan Bounds welcomed the delegates.
- Lisa Bubar, GLD Secretary, gave the report of the Delegate Credentials Committee:

89 GLD Ministers
18 Lay Delegates
2 Affiliates
9 GLD Board
12 GLD Staff
29 Exhibitors (Not eligible to vote)
74 Conferees (Not eligible to vote)
229 Present at the Conference
130 Voters

These were approved by the delegates.

Approval of the 2021 Conference Minutes

Lisa reported that at the December, 2021 GLD Board meeting, the minutes from last year's GLD conference business meeting were approved.

• Superintendent's Report – Rick Thompson

- o Rick encouraged attendance at the Pastors' & Wives' Retreat at Das Essenhaus in April, 2023.
- Rick focused on 2 T's:

<u>Transition</u> – Rick has 2 years left to serve as Superintendent, planning to retire in January, 2025. The Transition Team has been working for the past year, coming up with a timeline to guide the process, and a GLD Superintendent Profile, stating the qualifications we are seeking in our next leader. We plan to devote much of our Staff/Board sessions in December to furthering the Superintendent search process. The Board is recommending that the Search Committee consist of 7 people, representing our District in various ways. In December, we will select those 7 people as a Board. The goal is to have the Committee formed by January. We trust God to lead this process.

The hope is for an internal search, tapping into the leaders who are already part of the GLD. We hope to have candidate name(s) identified by June, 2024.

<u>Transformation</u> – The word "transform" is only found 2 times in Scripture: Romans 12:1-2 and 2 Corinthians 3:18. What is a transformational church?

Church contributions are over budget, as of September 30, 2022! We have about an \$8,000 surplus, and a \$30,000 refund check from Brotherhood Mutual coming soon. Brett encouraged churches to consider using Brotherhood Mutual insurance, and they also have a payroll service.

The church planting fund is in a good position.

Report accepted. M-S-C

The 2023 operating budget was approved. M-S-C.

Brett thanked Carlan for his faithful leadership to the GLD for many years.

Motion was made to allow the GLD Board to approve today's minutes at their Dec, 2022 meeting. M-S-C.

Carlan thanked The Chapel and Amanda Bruney for all their work in planning and hosting this conference.

Next year's GLD conference is planned for October, 2023 at TEDS.

Pastor Phil Bubar closed the business meeting in prayer, asking God's blessing and guidance for the GLD Staff and Board in the year ahead.

PROPOSED CHANGES TO GLD ARTICLES OF INCORPORATION

ARTICLES OF INCORPORATION OF THE GREAT LAKES DISTRICT CONFERENCE OF THE EVANGELICAL FREE CHURCH OF AMERICA

SECTION II – GREAT LAKES DISTRICT CONFERENCE AFFILIATED ORGANIZATIONS

A. Definitions

1. An **Autonomous Affiliate** is an organization that wishes to unite with the Great Lakes District Conference. It is not a church; it is a ministry that has been formed to meet needs that are generally not being met by a single church. It is a corporation organized exclusively for charitable, educational or religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code. An Affiliate affirms the Statement of Faith and the Bylaws of the Great Lakes District Conference.

Current:

2. An **Ancillary Affiliate** is owned by the Great Lakes District Conference (such as a retirement center).

Change To:

2. An **Ancillary Affiliate** is owned by the Great Lakes District Conference (such as a retirement center).

A list of the Board of Directors and Officers, showing church affiliation, should be submitted to the Great Lakes District Conference on an annual basis, affirming that 51% of the Board of Directors of **Ancillary Affiliates** are members in good standing with The Evangelical Free Church of America.

- a. **Affiliate** board members are approved by the GLD Board
- b. Reports are to be provided to the district board on an annual basis.

Current:

3. A Dual Affiliate is an Autonomous Affiliate as defined in Section II-A-1, but has a relationship with another body.

Change: Remove item #3

B Procedures for Affiliation

Current:

- 1. All **Affiliate** Candidates will submit the following information to the Board of Directors of the Great Lakes District Conference.
 - a. A corporate resolution from the Board of Directors of the organization stating that they wish to become an Affiliate of the Great Lakes District Conference and will conform to all the requirements of becoming an Affiliate.
 - b. Copies of the bylaws of the corporation, the Articles of Incorporation and approval as a 501 (c) (3) organization from the Internal Revenue Service.
 - c. A list of names, addresses, telephone numbers and church affiliation of all officers and directors and a budget for the current fiscal year.
 - d. The organization's Mission Statement and methodology for accomplishing said plan.

Change: Remove Item #1

PROPOSED CHANGES TO GLD ARTICLES OF INCORPORATION

Current

2. An appointed person from the organization should meet with the Great Lakes District Conference Board to answer questions about the organization. If the organization is approved by the Board of Directors of the Great Lakes District Conference, the Board will present the applicant for affiliation at the next conference of the Great Lakes District Conference.

Change: This item will become #1 with above change

C. Accountability of Affiliates to the Great Lakes District Conference

Current:

1. A list of the Board of Directors and Officers, showing church affiliation, should be submitted to the Great Lakes District Conference on an annual basis, affirming that 51% of the Board of Directors of autonomous and ancillary Affiliates are members in good standing with The Evangelical Free Church of America.

Change To:

1. **Affiliates** are responsible to submit at least a one-page summary by August 15 for our GLD conference report and to send 2 delegates to our October annual conference who would be eligible to vote if they are members in good standing of an EFCA-GLD church.

Current:

"Dual Affiliation" will be addressed on a case-by-case basis by the Board of Directors of the Great Lakes
District Conference. The Board of Directors of the Great Lakes District Conference will determine the
requirements the Dual Affiliate must meet to become an Affiliate of the Great Lakes District Conference
subject to conference vote.

Change: Remove this item #2

Current:

3. Each Affiliate is entitled to one vote at the Annual Conference of Great Lakes District Conference. Voting delegates at the Annual Conference must be members in good standing in a member church of the Great Lakes District Conference.

Change: Remove this item #3

- 4. The Bylaws of the Affiliate must have a dissolution clause by law. Generally, the Great Lakes District Conference will be named as the recipient upon dissolution. However, if the Affiliate desires otherwise, non-exclusive dissolution clauses may be considered by the Board of Directors of the Great Lakes District Conference.
- D. Accountability of the Great Lakes District Conference to the Affiliate
 - 1. It is the responsibility of the Great Lakes District Conference to inform the member churches of Great Lakes District Conference of the Affiliates and their ministry.

PROPOSED CHANGES TO GLD ARTICLES OF INCORPORATION

Current:

This affiliation will provide the following benefits and resources to the Affiliate:

- a. Opportunities for fellowship with churches and other Affiliates.
- b. A basis for prayer support, fund raising and recruitment of staff and volunteer labor.
- c. A source of encouragement for the Affiliate.
- d. An avenue of communication for the Affiliate.

Change: Remove this statement

E. Withdrawal of an Affiliate

- 1. If for any reason an Affiliate can no longer continue in harmony with the Great Lakes District Conference as to doctrine, policies or practice, the Affiliate shall make its desires and reasons known to the Board of Directors. The Board of Directors shall consider the matter and counsel with the Affiliate concerning its reasons for withdrawing; determining whether or not the differences can be resolved.
- 2. If the differences cannot be resolved, the Board of Directors shall accept the request for withdrawal and recommend to the next conference that the Affiliate in question be released from Great Lakes District Conference.

F. Discipline or Dismissal of an Affiliate

- 1. Should an Affiliate be charged with being out of harmony with the Great Lakes District Conference in doctrine, decision or practice, such charges shall be presented to the Board of Directors.
- 2. If the evidence indicates that the charges are true, the Board of Directors shall seek to counsel with the Affiliate concerning such charges. Should there be a refusal to counsel with the Board, or if no agreement can be reached between the Affiliate and the Board, the Board of Directors shall decide whether the charges are serious enough to be reported at a subsequent Annual Conference.
- 3. Should the Board of Directors find it necessary to report the charges against such an Affiliate at a conference, the Affiliate shall be notified that such action is pending and shall be given the opportunity to defend itself before the Board of Directors at a stated time and place prior to the date of the conference. The Affiliate shall also have a right to a hearing in the presence of the conference delegates, but only by previous arrangement through the Board of Directors.
- 4. Action to dismiss an Affiliate from the Great Lakes District Conference affiliation shall be taken by the delegates at an Annual Conference upon recommendation of the Board of Directors.

G. Consequences of Withdrawal or Dismissal for an Affiliate

- 1. When an Affiliate has withdrawn or been dismissed from the Great Lakes District Conference, its chief administrator or the chief administrator's designated representative, cannot be credentialed as a delegate in any conference. It shall also cease to be affiliated with The Evangelical Free Church of America through the Great Lakes District Conference and shall lose the right to incorporate the words "Evangelical Free Church" as part or all of its name and shall not be endorsed by the Great Lakes District Conference and The Evangelical Free Church of America. Such organizations shall have no claim upon the funds or property of the Great Lakes District Conference or of The Evangelical Free Church of America.
- 2. If a withdrawing or dismissed Affiliate has at any time received a subsidy from the conference, it shall repay the amount of subsidy received in full or in part, as may be agreed and decided by the Board of Directors. Any unpaid loan owed to the Great Lakes District Conference or to any other branch of The Evangelical Free Church of America must also be repaid.

Notes to Financial Statement, December 31, 2022

Note A - Significant Accounting Policies

Nature of Operations: The mission of the Great Lakes District is to promote and strengthen the ministry of the Gospel of Jesus Christ by giving counsel, direction and encouragement to pastors and congregations, by extending the Gospel through the establishment of new churches and mutual ministry services and by guarding our statement of faith and preserving orthodoxy.

Accounting Method: These financial statements have been prepared on the accrual basis of accounting. Revenues are recognized when earned and expenses are recognized when incurred and not when received or paid. All revenue and support are considered to be available for unrestricted use unless specifically restricted by the donor.

Cash and Cash Equivalents: All highly liquid investments with maturities of three months or less when purchased are considered cash equivalents.

Fixed Assets: Fixed assets are stated at cost when purchased or fair market value at the time of contribution and are depreciated by the straight-line method over their estimated useful lives.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investments: Investments are carried at cost or fair market value at time of contribution.

Tax-exempt Status: The Great Lakes District is a tax-exempt organization under Internal Revenue Code Section 501 and, as such, is not subject to income taxes on net income from exempt purposes.

Note B - Concentration of Credit Risk

The organization maintains its cash balances in various financial institutions which at times may be in excess of the limits insured by the Federal Deposit Insurance Corporation.

Note C - Buildings in Trust

The membership of Grace Community Evangelical Free Church in Schiller Park, Illinois voted to close and give the church's assets (\$300,000) to the Great Lakes District for the establishment of a new church. In the spring of 2016 ownership of the church building and land located at 4244 Grace Street in Schiller Park, Illinois was transferred to the Great Lakes District. A new church is being planted at that location. Upon the establishment of the new church with Constitution and Bylaws in place, membership established, the church elder board and Senior Pastor affirmed, ownership will be transferred to this new interdependent, autonomous EFCA church.

In 2017, the GLD acquired property in Des Plaines, Illinois. The membership of Faith Bible Church (a non-EFCA church) in Des Plaines, Illinois voted to close and give the church's building to the Great Lakes District. In January 2017 ownership of the church building and land (\$250,000) located at 355 Bellaire Avenue in Des Plaines, Illinois was transferred to the Great Lakes District. The building is being held in trust until Eglise Evangelical Bethel Chicago is able to receive ownership of the building.

Note D - Subsequent Events

Management has evaluated subsequent events through July 24, 2023, the date on which the financial statements were available to be issued.

Effective District Strategy

What good is a district? Our Unique Value Proposition

Some say denominations are dying out like the dinosaurs. Our experience is that districts create critical connections with local churches that can be summarized into 7 critical areas.

1. Catalyze Church Planting

Brett Gleason oversees our ACTS system. He is the national leader of assessment.

"Assess" first. We pray to the Lord of the harvest for workers and we carefully assess every potential church planter to see if God is calling them to start a church. Business people who are faithful and fruitful make good starters. Pastors with previous experience and recent Bible College or seminary graduates are called to plant. Home grown leaders come from the womb of a mother church. Every starter is a unique story.

"Coach" second. Every approved lead church planter receives a personal coach and an elder caliber "oversight team." The coach and the oversight team do not attend the new church and they do not take responsibility for an area of the church plant. They provide wise counsel for the lead church planter in regular meetings. They give accountability until financial systems, elders, and members are in place. Oversight ends when members approve the elders. Personal coaching continues for a year.

"Train" third. Our movement sponsors a one week "Church Planting Boot Camp" for new church planters (reachnetwork.ministries.efca.org). Training is most effective when the planter, the coach and core group members attend together. The insights from assessment and boot camp inform the coaching provided. Boot camps emphasize lessons like developing a church planting plan, recruiting a team, analyzing a community, identifying disciple making pathways, types of evangelism, and the organizing of preview services and grand openings. The boot camp also clarifies a call to plant and filters out people who really should not plant.

"Send" is the final part. Churches plant churches. We look to local churches to send church starters. God sends and supplies faith-based missionaries to start churches. When our family moved to Moscow, Russia in 1997 as missionaries, God provided 20 churches and 25 families that made it possible for us to work full time in church planting. The responsibility of raising personal support for the mission of starting a church gives us the confidence to trust God for resources the rest of our lives.

By God's grace in the GLD, we have seen over 20 churches in ten years planted in this way.

2. Care for all the churches

"Besides everything else, I face daily the pressure of my concern for all the churches" (2 Corinthians 11:28). Our District Staff Team prays for our churches, builds trusting relationships, equips effective searches, facilitates credentialing, and our Superintendents come quickly when asked for help. We have 3 goals.

Supervision Received: District Superintendent

Span of Care: Area is 10 to 20 GLD churches, Regional is 30-50 GLD churches

Compensation: Mutually agreed upon salary and ministry expenses

Relational Role: A Superintendent cares as a "Shepherd of the Shepherds."

DISTRICT SUPERINTENDENT

Goal #1: "No Leader Left Alone" 80% of our pastors interdependently praying, proclaiming Christ and partnering in GLD groups framed by GLD team:

- 1:1 Coaching life on life encouragement toward Christ likeness
- 1:3 Trios a band of accountable believers who strengthen one another
- 1:7 Teams servant leaders working together on a clear mission
- 1:12 Mentoring guide from the side multiplying ministry fruitfulness
- 1:15 Ministerial geographically based groups who pray and encourage

Resourcing Role: A Superintendent catalyzes as a "Consultant to Churches."

Goal #2: "Serving your church's mission" by our team of area and regional superintendents multiplying care as measured by 40% of our churches growing in worship attendance (measured by at least a 10% increase every five years).

Goal #3: "Multiplying healthy churches among all people" measured by 36 healthy GLD churches multiplying 36 new churches that multiply new churches as a result of multiplication (2 Timothy 2:2) at every level of the ministry.

3. Connect our pastors and wives

Our Superintendent Team frames 17 ministerial and mentoring groups across five states so that no pastor is left alone as we are "shepherds of the shepherds" and catalysts for Gospel and Great Commission ministry. In 2023 we did a Pastor and Wife Retreat at The Essehaus with 20 couples. Pastor Scott Distler taught the Scriptures on the theme of Ministry from <u>The Cave: When Ministry Becomes Misery</u>. Everyone resonated and reflected on the tough times of pastoral ministry. Dr. Nicolas Perris took us to the story in Luke on Mary and Martha, set the context, and brought us powerful biblical insights. We are grateful for his service at TIU.

4. Consult with church boards

Pastoral transitions are the greatest time a district can serve a church. We recommend interims, introduce tools like <u>pastorsearch.efca.org</u> connect to EFCA recovery churches, and coach strategic planning. Several of our churches are using a new search firm with EFCA roots, Chemistry Staffing.

Our Superintendents are available for church consultations. Sometimes there is serious moral failure where we can give insight. We provide tools for strategic planning and help in revising a constitution (see our posted example of an effective constitution: (bit.ly/3ObMU0T)

Knute Larson is a GLD Church Consultant. He leads a learning community that prepares sermons for Christmas and Easter. Knute also posts valuable insights for churches on our website (gld-efca.org/resources).

Words like coaching and mentoring are soft terms without a single definition. There are fifty ways to fry these fish. My favorite way to coach one on one is Bob Logan's coaching process (loganleadership.com and *Coaching 101*). He emphasizes the five "R" approach. Coaching is God ordained **relationships** between Christians that **reflects** on God's work in one another, **refocuses** on God given goals, **resources** one another to fulfill our responsibilities by pointing us to the resources we need, and **reviews** our progress periodically.

5. Cross Cultural Ministries

The Great Lakes District Hispanic Leadership Team meets monthly and is led by Pastor Ricardo Palmerin. There are around 15 Hispanic churches and churches within a church. The HLT ministry mirrors the 7 critical roles of the GLD with these specific ministries:

DISTRICT SUPERINTENDENT

- 1. Serving Hispanic Churches in transition who are seeking a new pastor.
- 2. Serving Hispanic Churches with theological education through the EFCA's "Gateway"
- 3. Facilitating an EFCA Credential for those who qualify, especially through "Gateway."
- 4. Empowering immigrants to seek legal registration with the EFCA's "Immigrant Hope."
- 5. Co-laboring with the EFCA's Hispanic Church Planting Boot Camp.
- 6. Helping Hispanic high school students participate in the EFCA Challenge Conference
- 7. Working with existing GLD Churches to add a Hispanic "church within a church"
- 8. Providing Pastor and Wife Retreats.
- 9. Organizing training events to make the churches more effective.
- 10. Organizing the GLD Hispanic Conference with national speakers.

Dr. Stephen McCausland is our new Chicago Regional Superintendent who serves many ethnic churches among the 30 churches in his oversight. Dan Sommer leads APEX missions to 4 ReachGlobal cities and 8 sites in America for EFCA high school and college students. Rick and Jan accompanied the team to Rio in Brazil and also spent time with our second son's family in Rio. We will emphasize this area in our GLD Annual Conference as we look at The Messiah's Global Mission.

6. Conferences

The annual Great Lakes District Conference connects us to new and old friends, contributes essential training, shares our story, and makes critical decisions. We are grateful to God to be back at TIU for the 2023 annual GLD conference.

7. Communications

- Mt. Morris EFC continues excellent work under Bruce McKanna. Logan Murphy completed his chaplaincy
 credentialing several months ago and is now serving in that capacity out east vacating his youth and music
 role at the church. Mt. Morris EFC has recently hired a search firm to assist with finding a youth & music
 pastor replacement.
- Ashton EFC continues faithful ministry in this community under Farrell Stauffer's leadership.
- Hope Bible Fellowship in Dixon will be voted on at the GLD Conference for full membership as an EFCA church

Peoria ministerial (13 churches) is led by Don Blasing, Brimfield EFC pastor and will resume again in September.

- I assumed the Superintendent position over this area in Sept of 2022 and am still learning some of the details
- Princeton EFC has had IPM leadership of Corbit Magby since the resignation of David Mundt about a year ago. The church is now in a position to pursue a new lead pastor and is in process.
- Farmer City under the capable leadership of Dave Ashby continues their search for an Associate Pastor as a part of their succession plan.

It is an honor to serve with these men as they faithfully shepherd the God's people.

The Apostle Peter wrote his two letters to groups of believers in five different provinces of what is now northern Turkey. The Christian church in this region of Asia Minor was beginning to experience persecution from the Roman empire for its faith in Jesus Christ. Southern Ohio and Northern Kentucky.

This year was a great opportunity to connect with the churches of Southern Ohio and Northern Kentucky. I was able to personally connect with each of the area churches. Several staff met for one-day gatherings to focus on personal leadership at Grace EFC in Cincinnati in late January and August. Many of us were encouraged and equipped through a Simeon Trust Workshop in May hosted by Faith Church in Milford, and a few of us snuck away in the early afternoon for a "critical leaders meeting" at Great American Ballpark with the Reds.

This year welcomed Jason Jahn as the new campus pastor of Grace Fellowship: Independence, KY, and Emanuel Istrate was confirmed as the lead pastor of Oxford Bible Fellowship.

Eastern Michigan

This year Michigan welcomed three new pastors to the district. Doxa Church in Rochester Hills welcomed Kevin Stuhlmann, Midland EFC welcomed Kurt Gelman, and Our Redeemer in Midland welcomed Terry Prehiem.

Area district pastors met for one-day Mini-Retreats in January at Red Cedar in Okemos, and in May at Cornerstone Church in Detroit to focus on personal leadership and connection.

Normal Pastor Network (normalpastornetwork.org)

I continue to facilitate ministry to GLD Normal Church Pastors. A Normal Church is defined as a church with a regular weekend attendance of less than 200 (including children). REGIONAL SUPERINTENDENT OF CHICAGOLAND

Steve McCausland

I've had the privilege of meeting all of the senior pastors in the Chicagoland D-region as well as attending most of their church services. We have two area ministerials that are very effectively led by Peter LeBlanc and Tim Gioia—who focus our times together on pastoral issues, prayer, and developing good relationships. About 60% of the pastors attended a ministerial this last year, which I consider very good, given that the churches are spread across a slow 90-minute, traffic-laden region—some pastors drive longer than the meetings last.

Gordy @ Harvard Ave, Jeremiah @ Agape, Steve @ Des Plaines, Matt @ First Free, Robert @ Rock of our Salvation, and Eric @ the Brook were all able to enjoy Sabbaticals this last year. I'm chasing down those that haven't taken one in the last 5-7 years and strongly urging them to get some rest. Pastoral fatigue is a common symptom in the area, as COVID knocked the wind out of many pastors and their churches, though as a general rule, most were able to absorb the setbacks and keep pressing on.

Elim EFC and Chicago International EFC are without a senior pastor, area pastors and elders have helped with pulpit supply. The talented Kevin Fiske, formerly the youth and music pastor, has been promoted to senior pastor at Faith Bible; and Bethel Community welcomed a gifted preacher, Dr. Lenard Tavernelli, as their new senior pastor. Martin Stidham retired after 25 years in Chicago, as did Bob DeKlavon after 15 years in Joliet. Several in the region are pursuing credentialing. Mark Doebler led Village Church of Oak Park in the purchase and remodel of a new facility—it is gorgeous, and they are going above and beyond to reach the community. We're excited about Ron Childers planting in Bronzeville.

Some common pastoral concerns in Chicagoland have been: high-turnover from member relocations, shortage of available/interested ministry staff, keeping up effective outreach in quickly changing neighborhoods, the perceived slow pace of ministry fruit, general spiritual hardness and wilting among the population, and rising expenses of city ministry.

- "Our church board voted to give me every February off as an annual Sabbatical ©" --Robert Stevenson, Rock of Our Salvation
- "After COVID, our services have continued to go well... the divisive issues gave us a chance to give grace to both sides and come together as a unified church." --Viju John & Brendan Webb, Chicago International

DIRECTOR OF CHURCH MULTIPLICATION

The Church at Antioch sent their very best – Paul, Barnabas, and John Mark to proclaim the gospel that resulted in the planting of churches to reach the nations with the Gospel. Likewise, the EFCA is committed to the conviction that churches plant churches and that EFCA and Great Lakes District staff are there to help in this endeavor.

DIRECTOR OF CHURCH MULTIPLICATION

District and national staff have worked together to develop and implement key church multiplication systems to accomplish this mission. First, an assessment system that serves EFCA churches by assessing the church planting potential for a candidate. Second, a coaching system that ensures that every church planter has a coach to walk with them through the church planting process. Third, a training system that gives the church planter and his team a template to develop a strategic plan for the new church. Fourth, a support system that develops strategic partnerships of churches and individuals to support and resource the new church.

But good systems, as important as they are, do not alone accomplish the mission. To accomplish the mission we must have a commitment to the continual planting of new congregations. This starts with churches renewing their commitment to the advancement of the gospel through church multiplication. It continues with churches working with like-minded partners to plant new congregations because we are stronger together than apart.

In light of this, we are praying for eighteen churches to commit to planting eighteen new congregations in the next chapter of ministry. These new congregations could be campuses of a multi-site church, new church plants, or 2nd language services. Our desire is to support a healthy culture of multiplication that advances the gospel both within the Great Lakes District and around the world. We hope you will join us in this endeavor.

DIRECTOR OF HISPANIC MINISTRIES

Ricardo Palmerín

"He (The Lord) told them, "The harvest (Cosecha) is plentiful, but the workers are few. Ask the Lord of the harvest, therefore, to send out workers into his harvest field." Luke 10:2NIV

Nationwide Survey and Hispanic Congregation Models

Our EFCA Hispanic congregations participated in a nationwide survey by the end of 2022, sponsored by Lifeway Resources and the Billy Graham Evangelistic Association. The study uncovered data about Hispanic church demographics and congregation styles. Results showed that 53% of congregations are first-generation immigrants conducting services exclusively in Spanish, while 22% are second-generation Hispanics attending bilingual services. Additionally, 12% offer English translation, and 1% are English-speaking churches with Spanish translation.

Reflecting on the survey's findings, our GLD contains most of those diverse congregation models. We have congregations conducting services solely in Spanish, established churches introducing a second Spanish service, congregations holding bilingual English-Spanish services, and established churches providing Spanish translation in their services. There is no unique model for a Hispanic congregation, but every Latino congregation and ministry is unique in each location.

And new groups of immigrants and refugees from various backgrounds are entering our GLD communities in the Chicago area and Indiana. The Hispanic congregations there are extending welcomes to some of those migrants arriving from Latin America. They are coming with their diverse needs, presenting challenges for the community and an opportunity to spread the Gospel. We pray the Lord sends workers to the harvest.

Church Multiplication

We celebrate the advances of the plant "Iglesia de Fe" in Indianapolis. The church's leadership team led by planter Jean Carlos Petit, has made intentional efforts to reach Hispanic immigrants and refugees mainly from Venezuela. Within a few months, their attendance has doubled, and they are swiftly progressing with their organization, constitution, and incorporation process.

In Illinois Trinity Church in Watseka has initiated the "Trinity Familia," a group in Spanish designed to reach out to the Latinos in the area. And the Spanish ministry at the Compass Church in Bolingbrook campus continues to experience numerical growth in recent months. The Hispanic ministry in Maywood EFC in Rockford starts to flourish with several families attending regularly on Sunday services and weekdays reunions. River Oaks in Spanish envision opening Hispanic ministries in their new campus in North Indiana.

Companionship, Mentoring, and Training

The HLT remains committed to walking, mentoring, and training new Latino leaders and planters in plants such as Round Lake, Wheeling, Indianapolis, Rockford, and Des Plaines. This, is through meetings, zoom sessions, and calls, training topics like ministry practices, preaching, discipleship processes, and doctrine.

The HLT has established connections with Christian organizations that have provided training in ministry areas like AWANA for children, Billy Graham for Evangelistic outreach, and counseling like Moody Bible Institute's Counseling Center, Meier Clinics, and White Stone Counseling. This network provides avenues for Hispanic pastors and church members to access specialized ministries.

The HLT encourages GLD pastors to engage in training opportunities provided by the EFCA. Several of our pastors took part in the Church Planting Camp in Spanish in Reading, P.A. in April 2023 and the EFCA One Leadership Conference held in Fullerton, CA in June 2023.

DIRECTOR OF HISPANIC MINISTRIES

A new theological course through GATEWAY is scheduled for the upcoming fall with leaders of River Oaks in Spanish. In preparation for this course, I worked with a translation team on the second edition of "Evangelical Convictions" in Spanish, which now is available for GLD Hispanic pastors and leaders, as a tool to teach EFCA's Statement of Faith in church membership courses.

Connection and Encouragement

GLD Latino pastors and their spouses gathered in Schaumburg, IL during the spring. These meetings provide valuable time for fellowship, mutual encouragement, and strengthening relationships. A pastors and wives retreat is planned for the fall.

The HLT keeps contact with our pastors and leaders and maintains regular meetings for refreshment, planning, evaluation, and prayer for our Hispanic pastors, congregations, and initiatives.

We celebrate the successful partnership between "Cristo es la Roca" EFC and Life Bridge Community" EFC in Wauconda, IL. In offering a community outreach day that brought together seven hundred individuals from the intercultural community of Wauconda last summer. A repeat of this joint event is planned for the fall of 2023.

Praying and Partnership

As we strive to fulfill our mission, let us continue asking the "Lord of the harvest... send out workers into his harvest field" (Luke 10:2) among Hispanics.

GLD Latino congregations are engaging in various summer outreach activities that include sports tournaments, VBS, church camps, baptism services, food festivals, immigration and citizenship orientations, health fairs, food pantries, and others. Let's pray for new contacts and new believers result of those actions.

The Hispanic Leadership Team expresses its heartfelt appreciation for the prayers and partnership that churches, pastors, missionaries, and GLD staff have extended to Latino pastors and congregations within the GLD. As an association of churches our shared mission is to glorify God by multiplying transformational churches among all people.

Third, a training system that gives the church planter and his team a template to develop a strategic plan for the new church. But good systems, as important as they are, do not alone accomplish the mission. To accomplish the mission we must have a commitment to the continual planting of new congregations. This starts with churches renewing their commitment to the advancement of the gospel through church multiplication. It continues with churches working with like-minded partners to plant new congregations because we are stronger together than apart.

In light of this, we are praying for eighteen churches to commit to planting eighteen new congregations in the next chapter of ministry. These new congregations could be campuses of a multi-site church, new church plants, or 2nd language services. Our desire is to support a healthy culture of multiplication that advances the gospel both within the Great Lakes District and around the world. We hope you will join us in this endeavor.

REPORT OF THE FINANCE COMMISSION

Bob Blahnik

The financial position of the GLD is strong and well positioned for future ministry. This year member churches have contributed \$218,147 to the ministry fund through June 30th which is a slight increase in giving of \$184 compared to 2022. However, year to date giving from member churches is 6.2.% below budget through June 30, 2023. The giving of member churches is the primary ongoing source of funding for GLD ministry as we seek to advance the mission of the EFCA by multiplying transformational churches among all people. Contributions from churches comprise 97.8% of the Ministry Fund revenues of \$223,052 through June 30th.

We anticipate receiving funding from our partnership agreement with Brotherhood Mutual later this year which will help decrease or eliminate our operating deficit and strengthen our financial position.

We strongly encourage each church to participate in Fair Share giving to support the GLD. Not all churches can give at the recommended 1.25% of their annual budget, however many churches increase the amount that they give each year with the goal of reaching 1.25% over a few years. The commitment by churches to support the GLD enables us to support every church regardless of different financial seasons that they may face.

As of June 30, 2023 the Ministry Fund Principal was \$214,364. This balance includes \$52,007 in the reserve account.

The proposed 2024 budget continues to support the ministry of our Superintendent staff, Church Planting staff, Administrative Staff and other valuable team members. As a result of our strong financial position, \$10,000 in funding has been proposed for strategic ministry initiatives and \$22,500 in funding has been proposed for an overlap period to transition to our new District Superintendent. We are looking forward to relevant conferences as well as supporting churches with resources appropriate to their size, age and ministries.

The Great Lakes District continues to actively support the church planting mission of EFCA churches. Our team supports the church planting initiatives of individual churches and church planters and also acts on behalf of all of the churches within the GLD to establish new campuses and churches. As of June 30, 2023, the GLD's Unrestricted Church Planting Fund balance was \$34,768.

We continue to praise God for the faithfulness of our membership in supporting the GLD as it serves all of the churches within our geographic boundaries. FIT Moms continues to exist as an affiliate of the Great Lakes District EFCA. First begun as Teen Moms in 1987 as a ministry for teenage moms in Waukegan, IL, it now seeks to provide education, support, and advocacy for single moms and their children in the same area.

FIT - Families In Training desires to help support the children by providing fun ways to encourage school readiness and school excellence while their moms work through a curriculum of anger management, life skills, and parenting skills. It is all taught using Biblical principles and includes time spent learning more of God and His amazing grace and love for us as those created by Him and in His image. It is our desire to see them all grow in knowledge and character.

The past school year had the moms learning about the different stages of cognitive, physical, emotional, and social development and discussing ways to positively impact their children at each stage. It was with great joy that we spent our December sessions talking with both the moms and children of the true gift of Christmas, God's own Son, Jesus Christ. Throughout the year our families have been gifted with practical and a few "pampering" items and gifts by various groups. We are also able to provide Christmas gifts for them through Toys for Tots.

When we returned in 2023, the mom's read through a book together entitled, "Overwhelmed: The Life of a Single Moms". This book touches on multiple difficult, but experiential, subjects such as overcoming abuse, playing the victim role, and surviving financial crisis.

Families had the chance to experience and enjoy fun together with a bowling outing in the early spring and a couple summer park activities including a water spray and sand park.

As a board, we ourselves have been 'overwhelmed' at times by our own inadequacies as we help walk these families through difficult times, but also in a positive way by seeing the faithfulness of God. Please keep us and these families in your prayers as we continue forward.

NEW MOMS

Celebrating 40 Years in Service

This year, New Moms celebrates 40 years in service to young moms and their children who are experiencing poverty and homelessness in Chicagoland. Using our unique Executive Skills Coaching approach, we serve ~350 young families annually, coaching young moms through our integrated housing, job training, college success, and family support programs—helping families to stabilize, set goals, and work toward lifelong self-sufficiency.

Our Programs

Unique in the country, our services are delivered through our core programs, designed to work together or separately—decreasing barriers for young moms while equipping them with critical skills and support.

Housing: young moms & children need stability to take the next steps forward. We provide transitional and permanent supportive housing, where young moms can choose to engage with a family coach and set personal goals for her family's well-being. We provide center-based housing for 40 families in Chicago and 18 families in Oak Park. Serves ~78 families annually.

Job Training: economic mobility is key to lasting change. Our paid job training program provides individualized career planning; education re-enrollment; 16 weeks of paid training & transitional jobs at our social enterprise candle company, Bright Endeavors; & permanent job placement assistance. Serves ~100 young moms annually.

Family Support: New Moms ensures that young families have all they need to thrive. Our Family Support program offers a holistic set of services, including prenatal education, doulas, home visits, peer support groups, and other parenting resources, tools, and meaningful social connections. Serves ~220 families annually.

College Success: Through monthly stipends, childcare support, and individual & group coaching, we provide a resource for young moms seeking postsecondary degrees, and find family-sustaining, living-wage jobs. This three-year pilot will be formally evaluated by Chapin Hall, and will serve 25 young moms.

Spiritual Formation: we offer opportunities for families to participate in programming designed to help them explore faith and spirituality. Our Director of Spiritual Formation teaches character classes, holds informal discussions about faith, and is available for one-on-one spiritual direction and support for families.

In addition to our direct services, we also believe in sharing what we've learned. Through The Hub @ New Moms, we train and consult with peer organizations, foundations, and social enterprises nationally using our Executive Skills Coaching strategies and best practices, to create equity-driven change.

Agency Progress and Updates

Last year, 77% of families exited to permanent housing; and 68% retained housing for 12+ months (compared to a national 60% rate for moms of all ages, exiting transitional housing). 86% of young moms receiving 6+ months of home visiting practiced positive parenting skills, as measured by the Life Skills Progression Scale. 93% of families met key health indicators around repeat pregnancy rates, breastfeeding, child immunizations, & family medical insurance. We placed 87 young moms into permanent employment. 84% of young moms increased their educational levels while enrolled at New Moms.

This year, we look forward to adding mental health resources for young moms and their children.

Flooding at New Moms

On July 2nd, we experienced a massive flood in the basement of our Transformation Center. Initial flooding created an electrical fire, which resulted in our power being disconnected—stopping power to our sump pump. The water that came in dislodged a water tank in our pump room—filling our basement with over 6 feet of water.

Our greatest concern is the wellbeing of the families who live in our Transformation Center's 40 apartments. These families have all experienced homelessness previously—ensuring their safety is vital. We worked quickly to find housing opportunities, and our team has provided food, essentials, cash assistance, transportation, and coaching and support. As we work to make the Transformation Center livable again, these families are our highest priority.

We are currently awaiting the cost of repairs, as well as what will be covered through insurance. We look forward to moving families safely back into their apartments. In the meantime, we welcome prayers.

We are deeply grateful to the Great Lakes District for your prayers, support, and encouragement.

TIU UPDATES

NEW CENTER FOR FAITH & CHILDREN

Through the leadership and initiative of Associate Professor Mimi Larson, Trinity received a \$1.25 million dollar grant from the Lilly Endowment Inc. to establish the Center for Faith and Children. Dean Pao shared the importance of this new center, saying, "As theology serves the gospel mission of the church, this center bridges the gap between theory and practice while focusing on how children live out their faith, a research area that is often ignored in serious theological reflections." The Center for Faith and Children at TEDS will provide ministry leaders with educational opportunities, research and vision; empower the local church with training, assistance, and imagination; and encourage parents by developing curated resources, tips, and encouragement through a dynamic website, podcast, research articles, and a conference.



THRIVING IMMIGRANT CONGREGATIONS INITIATIVE

Trinity continues to serve immigrant populations and church leaders through the Thriving Immigrant Congregation Initiative, a project run through the Paul G. Hiebert Center for World Christianity and Global Theology and funded by the Lilly Endowment Inc. Led by Drs. Tite Tiénou and Peter Cha, this initiative seeks to provide resources, training, and a collaborative environment for immigrant congregation church leaders to address the critical challenges and conflicts between foreign-born "first-generation" congregants and their U.S.-born "second generation" counterparts. The first co-hort of the initiative, spanning two years, has served twelve different congregations throughout the United States, and we look forward to bringing in an additional twelve churches to participate in the second cohort in December. Church leaders who want additional support beyond this project have the opportunity to enroll in our Thriving Immigrant Churches track within our Doctor of Ministry program.

UKRAINE INITIATIVE

In the fall of 2022, sixteen universities in Ukraine reached out to Trinity to assist them in providing educational opportunities and chaplaincy training. In a few short months, we were able to pull together a course taught by our faculty and translated into Ukrainian which is serving 138 Ukrainian Chaplains who are working in hospitals, the military, in churches, and on the front lines of war. A former professor and current Ukrainian army chaplain shared that chaplaincy courses have never been available to him before and everything he has learned has been from books. A pastor in the course shared how he is putting everything he has learned into practice immediately and that he is so grateful to Trinity for providing him the education and training he needs, while educational institutions in Ukraine have been destroyed or closed during the war.

Trinity faculty are also offering faculty development masterclasses to support and encourage Ukrainian faculty during this time. So far Trinity faculty have completed three of ten of these masterclasses. Trinity Global hopes to continue to develop this program into a full certificate course and continue, through the faithful support of our donors, to provide an accessible Christ-centered education to those in need internationally.



CHURCH PARTNERSHIPS: BRING THEOLOGICAL TRAINING TO YOUR CHURCH

In our conversations with pastors and ministry leaders, we've noticed a movement towards "church-based theological education." In short, people are seeking out educational opportunities—such as classes typically taken in seminaries—within their own churches or ministry settings. We are seeing staff and lay-leaders ready to go deeper with their study in the Word, and our new Certificate Programs open the door for strategic partnerships!
