RELEASE and WAIVER OF LIABILITY

IN CONSIDERATION of being permitted to participate in all studio events. I agree that I:

1. RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the Off-Broadway Performing Arts Studio, LLC or any subdivision thereof, owners and lessees of premises used to conduct the studio activities of all types and "Releases" FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
2. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY OR PROPERTY DAMAGE for myself or my child arising out of or related to the studio whether caused by NEGLIGENCE OF THE RELEASEES or otherwise.
3. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extend to all acts of negligence by the Releasees and is intended to be as broad and inclusive as is permitted by the laws of the Province or State in which the Event(s) is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
