Liability Release

In consideration for being accepted for participation in all trips and/or activities with Fairfield Christian Church.

We (I), being 18 years of age or older, (myself) (and for and on the behalf of my child-participant if said child is not 18 years of age or older) do hereby release, forever discharge and agree to hold harmless Fairfield Christian Church and the Children's Ministry Sponsors thereof from any and all loss, liability, claims or demands of any nature whatsoever which may be incurred by the undersigned and the child participant that occur while said child is participating in any and all trips and/or activities. Furthermore, we (I) (and on behalf of our [my] child-participant if under age of 18 years) hereby assume all risk of personal injury, sickness, death, damage and expense as a result of participation in recreation and work activities involved therein. Further, authorization and permission is hereby given to Fairfield Christian Church to furnish any necessary transportation, food and lodging for this participant (applies to grade school children only). The undersigned further hereby agree to hold harmless and indemnify Fairfield Christian Church, and its Children's Ministry Sponsors, for any liability sustained by Fairfield Christian Church as the result of negligent, willful or intentional acts of said participant, including expenses incurred attendant thereto. (If the participant has not attained the age of 18 years) We (I) are the parent(s)/legal guardian(s), with legal custody of this participant, and hereby grant our (my) permission for him (her) to participate fully in said activity, and hereby give permission to take said participant to a doctor, hospital or emergency treatment center, and hereby authorize medical treatment, including but not in limitation to emergency surgery or medical treatment, and assume the responsibility of all medical bills, if any. Further, should it be necessary for the participant to return home due to medical reasons, disciplinary action or otherwise, we (I) hereby assume all transportation costs.
