Each member of our KidsQuest team has a significant role in sharing God's love and the truth of His Word with our children and families each week. Regardless of where you serve within our ministry or how frequently you serve, be assured that you are the hands and feet of Jesus to the children and families of our church and community. Please pray that God will use you to draw the children in your care into a closer relationship with Him! Be mindful that as a leader within our children's ministry, our children and families are looking up to and watching you. If the things you teach on a Sunday morning, do not line up with the things you do during the week, they will notice and their walk with God could be negatively impacted. None of us who serve in ministry are perfect, but we should always endeavor to live a lifestyle that is in step with the Spirit of God and that is consistent with the truth of God's Word.

As part of the KidsQuest Children's Ministries Team, I covenant to:

1. Have a genuine heart for God, manifested in my personal relationship with Him, with my family, with my KQ peers and with Fairfield Christian Church as a whole.
2. Regularly attend a weekly worship service at Fairfield Christian Church.
