

KidsQuest/SpringHill Day Camp  
Scholarship Policies & Application for Non-FCC Attenders

The children's ministry of Fairfield Christian Church is able to provide a limited amount of scholarships to K-5<sup>th</sup> children who wish to participate in our week of SpringHill Day Camp on June 10-14, 2019, but are unable to pay the full cost of camp. Submission of an application does not guarantee that your request for a scholarship will be granted. Scholarships will be awarded based on financial need and on a first come first serve basis. Applications will be kept confidential and will be evaluated by the FCC Scholarship Committee. If you are awarded a scholarship, you will be informed by an FCC children's ministry staff member who will provide you with a scholarship code that you may use when registering your child for camp on the SpringHill website. This application must be filled out completely to be considered.

FCC Scholarship Restrictions:

- Fairfield Christian Church does not provide transportation to or from day camp.
- FCC does not provide additional financial assistance for those requesting before/after care.
- Families are responsible for providing a packed lunch for their child each day of camp.
- There is a camp gift shop. Families are responsible for any items they wish to purchase at the gift shop.

SpringHill Registration Policies:

- You will register your child for camp online at SpringHillCamps.com (*\*If you do not have internet access, FCC will provide you with a paper registration at your request.*)
- SpringHill Day Camp is for students who have just completed K-5<sup>th</sup> Grade during 2018/19 school year. *\*No exceptions!*
- The full cost of a week of SpringHill Day Camp is: \$189 February 14-28; \$199 March 1-April 30; \$219 May 1 and after
- When registering between February 14 – 28, registrations must be paid in full in order to receive the early bird price of \$189
- After February 28, a deposit of \$75 will be required, with the remaining balance due May 1.
- Cancellations made before May 1 will result in a forfeiture of the \$75 deposit
- Cancellations made 7 days or more prior to the start of camp will result in a forfeiture of \$100
- Cancellations made after the start of day camp results in a forfeiture of the entire camp fee
- Before/After Care is available if you need to drop your child off before 9:00 am or pick them up after 4:00 pm. \$25 for before care and \$35 for after care, or \$50 for both
