I give permission for any representative of Pleasantview Baptist Church to take photographs and/or videos of my child and to use and reproduce the photos and/or videos in all forms of media for educational, reporting and other non-profit purposes. I hereby release Pleasantview Baptist Church and its staff, employees, agents, members, and parents from any claims relating to the use and/or reproduction of photographs or videos taken of my child during Kidz Kamp. I understand that there is no compensation for the use or reproductions of these photos and videos.

**PERMISSION, VOLUNTARY ASSUMPTION OF RISK, AND LIABILITY WAIVER**

I freely and voluntarily give permission for my child to attend and/or participate in all Kidz Kamp activities from June 9-June 13, 2019 held at and sponsored by Pleasantview Baptist Church, Derby, KS.

I understand and acknowledge that my child's participation in Kidz Kamp activities may involve risks and dangers that are an inherent part of participating in sports activities, including but not limited to physical injury to my child, injury to another child caused by my child, and property damage. With full knowledge and appreciation of the risks, I assume responsibility for all risks and dangers associated with my child's participation in Kidz Kamp.

I voluntarily agree to waive any and all rights to sue and hereby release and hold harmless Pleasantview Baptist Church, its pastors, deacons, employees, members, and agents from all liability, loss, claims, and actions for injury, expenses, or damage to person or property resulting from my child's participation in Kidz Kamp. I further agree to indemnify and hold harmless Pleasantview Baptist Church, its pastors, deacons, employees, members, and agents against all liability, claims, losses, actions, or expenses that are sustained, suffered, or incurred by any third person caused by my child's participation in Kidz Kamp activities.

**MEDICAL RELEASE**

If my child should become ill or injured during any Kidz Kamp activity I understand that Pleasantview Baptist Church will immediately contact me or the designated emergency contact person. If illness or injury is deemed a medical emergency by Pleasantview Baptist Church or Kidz Kamp personnel, I authorize Pleasantview Baptist Church to first call 911 and then contact me or the designated emergency contact person. If Pleasantview Baptist Church is unable to reach me or the emergency contact person, they are authorized to arrange immediate emergency treatment for my child. In such instance I freely and voluntarily accept full responsibility for payment of any and all medical services rendered and costs incurred on behalf of my child.

I further consent to the administration of first aid necessitated by illness or injury resulting from my child's participation in Kidz Kamp.
