B. PERMISSION

I give this permission and release to St. Luke Lutheran Church, a Michigan ecclesiastical corporation of Haslett, Michigan (the "Church"), in consideration of allowing the Participant to participate in the Activities and Programs. I represent to the Church that I am the parent or legal guardian of the Participant and that I have the authority to give this permission on behalf of myself and the Participant. The Participant has my permission to participate in the Activities and Programs. The Participant has my permission to travel in public vehicles and in private vehicles driven by Church staff or volunteers.

There is a risk of injury, and I acknowledge and assume the risk of injury for the participant and for myself. The Church may give the Participant non-prescription medicine, routine non-surgical medical care and first aid. The Church may take the Participant or arrange for transportation to emergency care facilities, and I authorize treatment and will pay all medical and transportation bills.

The Church may use photos and video- and audio-recordings of the Participant for educational, advertising and promotional purposes in all conventional and electronic media and any future media; and may duplicate, distribute or alter any item. The Church will exercise good judgment in using all items.

C. RELEASE

I release the Church and all of its governing persons, employees, paid and volunteer staff members, agents and volunteer personnel (all of whom are included in the term "Church") and will hold them harmless from all liability, claims and demands of any nature arising from the Activities and Programs, or the participation by the Participant in the Activities and Programs, including liability for injury, sickness, death, property damage and expenses of any nature. I will make the Church whole and hold it harmless from any loss, cost or expense (including attorney fees) incurred by the Church as a result of any acts of the Participant during the Activities and Programs resulting in injury to persons or damage to property.

This Form is controlled by Michigan law and is intended to be as broad and inclusive as permitted. If any provision is held invalid, the balance is still valid.
