## 7. PRESIDENT'S REPORT - Steve Schroeder

Steve shared that we decided not to hold an orientation class for New Applicants, so they could be in the main meetings and absorb as much of our culture as possible. We give the best of ourselves to each other. We have the invitation of our Father to devote ourselves to the Word and Prayer (Acts 6:4). Your calling and anointing are from God. The way you get in is the way you are sustained.

Steve recounted how he became President of the CMA twenty years ago, and his election to Hope Town Council, where he learned the difference between the government of God and the government of man. Steve expressed thanks to the team members on the Board. The CMA Board is not an apostolic group. We have policies that have changed over time. Authority is vertical, not horizontal. Authority comes from the Lord, and how you spend time with Him.

Steve invited Jason Heffron to share about the Eastern Gathering, held in London, Ontario, in May. Jason spoke about the costs and challenges of coming from the East. Jason talked about what the CMA means to him, and about first attending the conference ten years ago, the growth we have seen since then, and the heart to provide for our President. Jason prepared the first budget for the CMA. Ontario makes up about 10% of our membership, and most come once every three years. How do you catch the culture of the CMA when you are only exposed once every three years. Jason's desire was to see the heart of the CMA shared in Ontario. Steve shared his heart and the culture of the CMA.

Steve shared about the \$20,000. we received from a foundation for 3 years during Covid. We have not received this grant last year or this year. We used this money last year to build connections within the CMA.

Steve drew attention to the QR that would enable members to connect for prayer. John Canaday will co-ordinate this.

Steve invited Niki Shelton to share about what the CMA means to them and what has changed in the last year. Niki shared about God's call to be ordained as a minister and her journey to become the National Director of Burn 24/7.

## 8. ELECTION OF OFFICERS

Steve Schroeder mentioned that In the past, when we were smaller, people were nominated from the floor. As we grew this became difficult to know who was being nominated and if they were called by the Lord to do this. We implemented a policy that was labourious and frustrating. Policies are guidelines and are changeable. Steve has recommended that we continue with the incumbents in this season of change.
