MISSION STATEMENT

The mission of Cornerstone Christian Academy is to provide for each student a comprehensive education, which is based on God's truth, while building stronger relationships among parents, staff, and students.

VISION STATEMENT

The vision of Cornerstone Christian Academy is to raise up effective leaders of godly character who will blend academic achievement and biblical truth to influence society for the glory of God.

STATEMENT OF FAITH

There is only one God eternally existing in three persons—the Father, the Son, and the Holy Spirit. The Holy Scriptures are verbally inspired of God and are our only infallible rule of faith and practice. Jesus Christ died, shedding His blood for our sins, and was bodily raised from the dead for our justification. He will return visibly and bodily with power in accordance with prophetic Scripture. Man is by nature and practice a sinner separated from God and can become God's child only by faith in Jesus Christ. Those who are thus born into God's family have eternal life in the presence of God, and those who are not remain in eternal death. The Holy Spirit lives in the believer and enables him to walk in purity of life and submission to the will of God. All believers are united in the body of Christ.

We believe that God created marriage to be between one biological man and one biological woman. Accordingly, we reject any attempt to redefine marriage as a union between people of the same sex or as between more than one man and one woman. We believe that the homosexual lifestyle and the alternative identities are contrary to the Bible. (Gen. 1:27-28, 2:15-24; Lev. 18:22, 20:13a; Matt. 19:4-6; Rom. 1:26-27; 1 Cor. 7:14)

CORE VALUES

▪ **Absolute Truth**

The Creator of the universe is also the author of absolute truth, revealed through His handiwork, the Holy Spirit, and the inerrant Word of God. (Romans 1:20; 2Timothy 3:15-16; John 15:26, 17:17) All subjects, such as literature, history, mathematics, science, music, art, and philosophy are manifestations of God’s truth, goodness, and holiness. We desire that our students develop a strong Christian worldview that will allow them to possess the firm foundation of His wisdom and knowledge (John 8:32, 36; Proverbs 2:1-7; Colossians 2:2-3). This foundation can only be built on Jesus Christ and a personal relationship with Him (John 14:6, Colossians 1:13-15).

▪ **Excellence**

As God’s creatures, we are admonished to work with all our heart, “working for the Lord, not for men” (Colossians 3:17, 23). CCA believes this should be the standard for our students in whatever they undertake, both in the classroom and in all areas of life. They are challenged by the faculty, staff, and curriculum to pursue their absolute best, for God’s glory, in academics, in respect for authority, in relationships, and in their spiritual growth to find out what pleases the Lord (1Thessalonians 4:1). Also accountable to this godly standard of excellence is our leadership—board, administration, staff, and faculty—for the best use of our resources, our curriculums, and how we are meeting God’s purposes for CCA (Ephesians 5:1, Psalm 90:17).

▪ **Love and Service**

As members of one body, we desire to exemplify and teach Christ’s example to serve one another in love (Galatians 5:13, Philippians 2:3-4). Students are given ample opportunities to develop servant heartedness in the classroom and through CCA work days and work projects, fund raisers, community outreach, Christian service, missions trips, hosting sporting events, concerts, programs, summer camps, and more. Our ministries also convey that the greatest love and service is to share God’s truth with the lost (Romans 6:23, John 6:35, 1Peter 3:15). As administration, faculty, and staff, we humbly desire to model Christ’s compassionate, selfless love (Matthew 20:26-28, Ephesians 2:10, John 15:12-13).

▪ **Bearing Fruit**

CCA is committed to academic and spiritual excellence. Just as hard work will reflect on report cards, so will living faith in action bear good fruit (John 15:5, 8). Regular devotions, weekly chapels, and Christian teachers and staff help direct students to grow in grace, character, integrity, and uprightness (Titus 2:11-12, 2Corinthians 4:5-7, 1Thessalonians 4:7). Morning faculty devotions give our teachers and staff the opportunity to be united in prayer and focus for the spiritual health of our student body (Colossians 1:9-12, 3:16). Manageable class sizes allow teachers to personally know and shepherd their students. Parental involvement, monthly board meetings, and a weekly Parents for Cornerstone prayer group also assure that CCA and its students are constantly uplifted before the Lord (Colossians 4:2, 2Thessalonians 1:11-12). “But the fruit of the Spirit is love, joy, peace, patience, kindness, goodness, faithfulness, gentleness, self-control; against such things there is no law” (Galatians 5:22-23).

▪ **Equipping to Send**

Our Vision Statement reflects our purpose at CCA: “To raise up effective leaders of godly character who will blend academic achievement and biblical truth to influence society for the glory of God.” We want to equip the next generation to merge their faith and knowledge into their daily lives in order to be leaders and ambassadors for Christ throughout the world. We seek to help them identify their God-given abilities and talents and to make them useful to the Master (Psalm 139:14). By graduation, each student has had many opportunities to discover and maximize these unique gifts for His glory (1Corinthians 12:7-11; Matthew 25:23, 29; 2Corinthians 9:8).

PHILOSOPHY OF EDUCATION

Cornerstone Christian Academy (CCA), serving students in preschool through 12th grade, is founded on the following principles:

1. God can be known properly only as He reveals Himself through the Word, His creation, and the Holy Spirit (Psalm 119:130, Romans 1:19-20, 1 Corinthians 2:10). Therefore, regular time is devoted to prayer (Colossians 4:2), worship (Psalm 95:6), and Bible study (2 Peter 3:18). Important goals of Christian education are designed to help the student know Jesus Christ as Lord and Savior and develop Christian values and thought patterns.
2. Since all truth is God’s truth (Isaiah 45:19), all subjects are taught in conformity to the Word of God (2 Timothy 3:16-17, Colossians 3:17).
3. Christian moral training is needed in order to build godly character in our students. Through discipline and counseling, the school helps the students see themselves as God sees them, submit to God-ordained authority, do God’s will, and bring glory to Him.
4. Children are unique and loved by God. The value of each student is expressed in an atmosphere of loving concern. Children are also encouraged to show respect, kindness, and love in their relationships with others.
5. CCA is committed to an academic standard that necessitates the students’ mastery of the skills and knowledge needed for life and work. Manageable class sizes allow teachers to give individual attention and to praise students, with the goal of helping them spiritually as well as intellectually and emotionally. Traditional teaching methods are utilized. CCA desires that the students receive the best of western tradition, learn it, and preserve it for future generations.
6. Teachers bring the educational philosophy of the school to life at CCA. Each one is personally committed to Jesus Christ as Lord and Savior, dedicated to the Christian view of life and education, and aware of his influence upon the students.
7. Parents and teachers form a team that educates the child in mind and heart. The Bible teaches that parents are ultimately held responsible for their child’s education (Deuteronomy 6:20, Ephesians 6:1-4). CCA continues the biblical training that the parents already have begun. CCA’s traditional approach, having our roots in the Midwest culture, supports and teaches respect for authority, family, and parental authority.

EXPECTED STUDENT OUTCOMES

Spiritual Formation

Students who graduate from CCA should:

- ✓ Recognize that the Bible is the infallible word of God and the foundation for life.
- ✓ Understand Christ as their Lord and Savior, and that He is active in their lives today.
- ✓ Demonstrate knowledge of the history, people, places, and events in the Bible and understand how they fit into God's overarching plan of redemption.
- ✓ Be able to define and defend their beliefs from a biblical perspective.
- ✓ Take ownership of their walk with God and be self-motivated to grow.
- ✓ Know how to study the Bible in a meaningful way to enrich personal devotions and prayer time.
- ✓ Be able to identify the idols of our culture and be able to biblically address temptation.
- ✓ Be capable of sharing the Gospel in personal and meaningful ways.
- ✓ Receive discipling and develop the skills to disciple others.
- ✓ Learn to love their neighbor with compassion and demonstrate it regularly with acts of service.
- ✓ Know the value of being actively involved in a local church community.
- ✓ Understand and develop servant leadership skills in order to take initiative and influence others positively toward godly living.

Academic Development

Students who graduate from CCA should:

- ✓ Be well prepared in all academic disciplines and are skilled in reading, writing, speaking, listening, and thinking.
- ✓ Be proficient in reading, writing, mathematics and science.
- ✓ Have a knowledge and understanding of people, events, and movements in history (including church history) and the cultures of other peoples and places.
- ✓ Appreciate literature and the arts and understand how they express and shape the students' beliefs and values.
- ✓ Have a critical appreciation of languages and cultures of other peoples, dispelling prejudice, promoting interethnic harmony, and encouraging biblical hospitality.
- ✓ Know how to utilize resources – including technology – to find, analyze, and evaluate information.
- ✓ Have the skills to question, solve problems, and make wise decisions.
- ✓ Be committed to lifelong learning.

Citizenship Skills Development

Students who graduate from CCA should:

- ✓ Understand, value, and engage in appropriate social (community) and civic (political) activities.
- ✓ Practice justice, mercy, and peacemaking in family and society.
- ✓ Respect, and relate appropriately with integrity to the people with whom they work and live.

- ✓ Understand the principles of healthy, godly living.
- ✓ Are good stewards of their finances, time, and all other resources.
- ✓ Understand that work has value as an expression of the nature of God.
- ✓ Have an appreciation for the natural environment and practice responsible stewardship of God’s creation.
- ✓ Exercise leadership traits that are developed through multiple opportunities at school and extracurricular activities.

STATEMENT OF PURPOSE

The primary goal of Cornerstone Christian Academy is to provide a Bible-centered and academically sound education. Cornerstone, preschool through 12th grade, is governed by an independent board and is affiliated with the Association of Christian Schools International. CCA is registered with the State of Illinois and complies with more than adequate days and/or hours of instruction per year.

CCA is not sponsored by any particular church or denomination. The school believes the Bible is inspired by God. We are conservative and biblical in our outlook and standards. CCA is built upon a solid Christian foundation, with faith in Jesus Christ as the chief Cornerstone, the Bible as the only authority, and dedicated Christian teachers as “living curriculum.” CCA offers an atmosphere of loving concern, structured discipline, small classes with individual attention, and an excellent curriculum. Our goal is to help each child lead a joyful Christian life, develop a healthy self-image, and acquire the academic skills fundamental to future success.

NONDISCRIMINATION STATEMENT

Cornerstone Christian Academy of DeKalb County Inc. (CCA) is a religious institution providing an education in a distinct Christian environment, and it believes its biblical role is to work in conjunction with the home to mold students to be Christ-like. On those occasions in which the atmosphere or conduct within a particular home is counter to or in opposition to the biblical lifestyle the school teaches (Matt. 15:19, 1 Cor. 6:9), the school reserves the right, within its sole discretion, to refuse admission of an applicant or to discontinue enrollment of a student. This includes—but is not necessarily limited to—living in, condoning, or supporting sexual immorality (1 Cor. 7:2); practicing a homosexual lifestyle or alternative gender identity; promoting such practices; or otherwise having the inability to support the moral principles of the school. (Rom. 13:13)

Cornerstone Christian Academy admits students of any race, sex, and national and ethnic origin with the purpose of educating their hearts and minds with God’s truth. Each student is given all possible rights, privileges, programs, and available activities. CCA does not discriminate on the basis of age, race, color, and national and ethnic origin in administration of its educational policies, admissions policies, scholarship and loan programs, and athletic and other school-administered programs.

REVISION POLICY

CCA reserves the right to change any policy/procedure in the family handbook when it deems it necessary for the best interest of the school.

ORGANIZATION

SCHOOL BOARD

The CCA School Board is the chief policy-making body of the school, consisting of no fewer than five and no more than nine members. In the event that the number of members is fewer than five, the board shall continue to meet and carry out the business of the school. The board members are elected for a three-year term of office. The members of the school board are given the responsibility for the establishment, guidance, and spiritual headship in the operation of the school. They are the leaders responsible to seek God's will and direction for the school and for the preservation and restoration of right relations, primarily our relations with God. Board members are nominated on the basis of their prior interest and service to CCA. The board also includes a chaplain who serves for one year.

In order to effectively govern CCA, the board is organized into standing committees. Board members and parents outside of the board serve on these committees to provide leadership and direction for our school. Committees include: education, policy, finance, facilities, development, and volunteer.

ADMINISTRATION, FACULTY, AND STAFF

The board appoints the administrators and teachers at CCA after careful consideration of their spiritual, academic, and physical qualifications. The administrators and teachers are committed to serving our Lord and the families of CCA.

- Each member of the preschool staff is personally committed to Jesus Christ as Lord and Savior, dedicated to the Christian view of life and education, and aware of their influence upon the children.
- The Preschool teachers have six hours or more of early childhood classes.
- All staff members are trained in CPR and basic first aid.
- Staff devotions are held every morning before school begins. Teachers pray together for our school, our students and their families, and our faculty and staff.
- All staff members have demonstrated dedication, warmth, sensitivity, maturity, and patience and will provide loving and understanding care for each child.
- The children will learn about the Lord Jesus Christ through the love they experience from their teachers.

PARENT-SCHOOL COMMUNICATION

As a school family, we must utilize effective communications to best achieve the goals and objectives we have established for our school. If you have questions or concerns about a specific area of our school's curriculum or program, please contact the teachers and/or administrators who can help you. Essential to the success of a child in school is the communication between the teacher and parents. Parents are urged to confer regularly with their child's teachers. Calls to the teachers will be returned as soon as possible. In urgent situations you may contact them at home.

When a parent has a concern related to the school, the following steps should be taken in resolving the issue:

1. Parents should call either the office and have the secretary set up an appointment with the teacher or set one up directly with the teacher.
2. If the problem is still unresolved, the parents should contact the preschool director.
3. As a final recourse, the board will mediate disputes. (Matthew 18:15-20).

PARENTAL INVOLVEMENT

The role of educating your child is a very important one. It is not, however, an exclusive endeavor. The faculty recognizes the importance of parental involvement and expects parents to support the authority of the faculty and staff members. We want you to be involved in Cornerstone Christian Academy and encourage your attendance in activities.

Listed below are some important elements for parents of CCA students to understand:

1. Children need a strong, Bible-centered home (Deuteronomy 6:7). Families should be involved in a church that preaches and teaches the Bible (Jeremiah 3:15).
2. Parents are responsible for the education of their children and should faithfully pray for the success of the school (Ephesians 6:4).
3. Families are expected to pay tuition on time, and when possible, cheerfully give to the expansion of the school and its programs (1 Corinthians 9:7).
4. Parents should ensure that their children are well rested and well fed. Nutrition and rest play a key role in the ability of children to learn.
5. Parents are welcome to visit their child's classroom; however, we ask that you schedule a time to visit with your child's teacher in order to accommodate classroom activities.

PARENTS FOR CORNERSTONE (PFC)

Parents for Cornerstone is a parent volunteer organization, which has several goals:

- To provide parents with an opportunity for fellowship with others who share their level of commitment to their children's education.
- To enhance communication efforts already in place among the variety of volunteer projects throughout the year.
- To ensure adequate leadership for those volunteer efforts.
- To sponsor activities and programs for students and provide additional equipment and materials for classrooms and athletics.
- To assist in efforts to increase the building fund.

Parent involvement provides a greater understanding of the blessings received at our school each day and the chance to directly impact the quality of their children's education. Please prayerfully consider where your God-given talents might best be utilized to enhance our school's environment and future opportunities.

GENERAL INFORMATION

ABSENCES

If your child will not be coming to school on a day when he or she is expected, please call the school office by 8:00 a.m.

ARRIVAL AND DISMISSAL

Parents are required to escort their child to their classroom and sign them in on the class sign in sheet. Parents are also required to pick up their child from the classroom and sign them out on the class sign in sheet. Parent picking up at 11:30 a.m. have the option of using the pickup service. Please see drive-thru pickup service.

AUTHORIZATION FOR PICKUP

An authorization for pickup form must be turned in at the time of enrollment. CCA will not release your child to a person not on the list. The parent may call and speak to the preschool administrator in an emergency. A parent may add or delete names at any time during the school year. Cornerstone Christian Academy will not release a child to any person other than those who have been designated in writing by the parent or legal guardian. In the event of an order of protection or court procedure regarding custody of your child, CCA must be notified of all changes and a current copy of the court order must be kept on file. Only the court may change this.

BEFORE AND AFTER SCHOOL CARE

Before school care is available from 6:30 a.m. to 8:30 a.m. After school care is available from 3:00 p.m. to 6:00 p.m. The cost of before- and after-school care is charged at an hourly rate. Parents do not need to pre-register. You will be billed the following month. There is a \$5.00 charge for every fifteen minutes after 6:00 p.m.

BIRTHDAYS AND SPECIAL DAYS

A birthday is a very special time for a child. Let the teacher know before the child's birthday is if you plan to send a special snack for the celebration. The teacher will try to schedule their snack day as close to their birthday as possible. To avoid any hurt feelings, we ask that party invitations be mailed to the child's home in place of handing them out at school.

CHAPEL

Chapel occurs once a month. A special speaker will lead the devotion. Each class will take turns in leading in song for worship. Parents are welcome to attend.

CLOTHING/DRESS CODE

No uniforms are required. Children should come to school wearing comfortable, washable play clothing. Girls should wear tights or shorts under their dresses. Clothing that displays slogans or insignia of questionable nature (groups or products that dishonor God or a Christian lifestyle) must not be worn. This rule applies to backpacks as well. During cold, snowy weather, the child should dress for outdoor play with a heavy jacket, hat, gloves, boots, and snow pants. All clothing should be marked with the child's name. Children are encouraged to dress and undress themselves.

COMMUNICATION

Each month, a classroom newsletter is given to each family and is also available on the school website, www.cornerstonechristianacademy.com. This newsletter will keep you updated on upcoming events in your child's classroom. The weekly Lions Line comes home on Wednesdays. This newsletter is an essential part of CCA it often includes schedule changes, announcements, and other vital information.

CONFERENCES

Parent/Teacher conferences will be held in the fall for all preschool students. There will be a sign up sheet near the classroom for time slots available. The parents and teacher will discuss the child's progress, address any concerns, and pray together for the future. At any time throughout the school year parents may set up a time to talk to your child's teacher.

CRISIS MANAGEMENT PLAN

The staff at CCA is familiar with the crisis management plan for the school in the event of an emergency such as tornado, fire, bomb threat or intruder. A copy of the plan is available in the office for review if desired.

DAYCARE – NO SCHOOL DAYS

When CCA has scheduled days off, daycare will be available from 6:30 a.m. to 6 p.m. In order to provide the proper extended care staffing, parents must sign up their children in advance. A sheet will be sent home in our weekly Lion's Line. If this is the preschool student's normal day, there is no extra charge; it is included in the monthly tuition. However, sign-up is still required.

The following lists the basic structure for these days:

- All students attending these days must bring a sack lunch.
- The children will have their scheduled nap, which will be supervised by an extended care staff member.
- A morning and afternoon snack will be provided.
- We will have fun themes and activities on these days.

DISCIPLINE

God's love and forgiveness is our foundation to all discipline. A time-out is administered in a respectful way (one minute per year of child's age). The teacher will spend a few minutes reviewing with the child what happened and why. If the child has three time-outs for the day he or she will visit the preschool administrator's office. If the child is being brought to the administrator's office repeatedly, the administrator will request a meeting with the parents and the child's teacher. A "working together" plan will be developed. Parent and teacher will be in constant communication regarding the child's progress.

Cornerstone Christian Academy disciplines:

- With respect and kindness
- Without intimidation and fear
- Without corporal, or physical punishment
- Without anger, including yelling or raising their voice
- Without sarcasm
- Without telling the child he or she is bad
- Without emotional abuse such as ignoring the child

- Without verbally abusive language
- Without comparing the child with other children

Parents should not approach another child regarding an incident that occurred with their child; CCA will take appropriate action. If it becomes necessary to question whether our preschool program is the correct placement for a child, the board reserves the right to make the final decision with regards to the child's continued involvement with the school.

DRIVE-THRU PICKUP

Half-day students are eligible for drive-thru pickup service. Parents will sign up daily on the classroom sign-in sheet if they would like to use this service. Parents will be given a card with their child's name. Parents will be asked to hold up the card when they pull through the parking lot to notify the staff member which child to bring out.

EMERGENCY CARDS

It is required that each student has a medical emergency information card on file in the school office that is filled out by the parent.

FEES

A deposit of \$35.00 is required for application fee, with a maximum \$75.00 fee per family. This will also put your child's name on the class list.

FIELD TRIPS

No child may leave for a field trip without a signed written permission slip. Under Illinois law, children under age 8 are required to use a car seat. Car seats are provided by the parent. Parents who drive to field trips must leave a copy of their valid driver's license and proof of insurance with the teacher on the day of each trip.

HALF DAYS POLICY

Whenever CCA has scheduled half days (mostly for teacher institute days), there will **not** be a drive up/pick up at 11:30 a.m. (see *DRIVE-THRU PICKUP*) due to parking lot congestion from K-12 being dismissed at the same time.

For full-day preschool students, the following procedure is in effect:

- If this is the preschool student's normal day, there is no extra charge; it is included in the monthly tuition.
- A hot lunch will be prepared and served, for preschool students only, at the normal time.
- The preschool teachers will remain in the classroom while the children are served their lunch.
- The extended care staff will stay with the children the rest of the day (to accommodate teacher meetings).
- The children will have their scheduled nap, which will be supervised by an extended care staff member.

HALLWAYS BEFORE AND AFTER SCHOOL

In order to keep the building safe and secure before and after school, we are asking all students not to roam the halls. It is important that all students are where they are supposed

to be. The school handbook explains the before- and after-school procedures. The following is being added for extra security measures:

- 6:30 a.m. – 8:10 a.m.: The students and parents must enter through the parking lot doors nearest to the gymnasium.
 - Secondary students may not go to their lockers until 8:00 a.m.
 - Primary students may not go to their lockers until 8:10 a.m.
 - Preschool parents may go to their child's cubby by entering the gym and going through the hallway by the preschool rooms.
- 3:45 p.m.: The doors in the hallways by the preschool rooms and the doors in the kitchen will be locked. All students must be with a parent, at an after-school event, or checked in to extended care.
- 4:00 p.m.: All parents picking up their children from extended care will have to buzz the intercom at the north parking lot door. An extended care staff employee will then proceed to open the door.
- Students will earn a minor if they are not where they are supposed to be at designated times. CCA staff will give a student grace if he or she has a reason for being in the hall. Roaming the halls unsupervised will not be permitted.

We are asking for everyone's help (faculty and parents) to follow these procedures, as we want to provide an environment that is secure for the entire school.

HEALTH CHECKS

If you suspect your child is having difficulty with their hearing or vision, please notify the office as the DeKalb County Health Department has an annual screening at the school in the fall. Each student may receive a head check for lice from an experienced staff member as deemed necessary throughout the school year. Parents will be notified of the checks.

HOT LUNCH

Hot lunches are included in the full day charges and are available for all children in the full day program. A lunch menu is given out each month if your child has food allergies please let the teacher know. Children are welcome to bring a sack lunch at any time.

ILLNESS

A child cannot return to school until he or she is free of fever, vomiting, and diarrhea symptoms for 24 hours. If the child returns the next day, we must have a note signed and dated from the physician stating that the child is not contagious and can return to school.

- After a child has received emergency treatment for any reason (i.e. stitches, respirator, treatments, etc.) or after a planned medical procedure (tubes, tonsillectomy, etc.), a physician's note will be needed for the child to return to school. The physician's note should state the child's name, treatment received, recommendations for care, and the date the child can return to group childcare.
- In case of an emergency, every effort will be made to notify parents or emergency contacts. Appropriate medical care, including paramedics, may be called when deemed necessary. If it is necessary for your child to go to the hospital and we are unable to reach you or the emergency contacts, a Cornerstone Christian Academy employee will accompany your child to the hospital.

- An injury report is completed and signed by the staff any time a child has any type of injury. The parent is notified of this report.

INSURANCE

All injury insurance needs to be covered by the family. The school does not provide this coverage.

MARRIAGE POLICY

Because God has ordained marriage and defined it as the covenant relationship between a man, a woman, and Himself, Cornerstone Christian Academy will only recognize marriages between one natural born man and one natural born woman. Further, the board/administration and faculty/staff of Cornerstone Christian Academy shall only participate in weddings, and authenticate marriages, between one natural born man and one natural born woman. Finally, the facilities and property of Cornerstone Christian Academy shall only host weddings and/or receptions between one man and one woman. (Gen. 2:24, Rom. 1:24-27, 1 Cor. 6:9-10)

MEDICATIONS

Preschool students requiring prescription medication, cold medication, pain medication, etc. during the school day must submit a written parent request to the teacher. Students who have asthma are to have a written note to the teacher. Medications must be brought to the school in a container appropriately labeled by the pharmacy or physician. All medications are to be kept with the child's teacher.

Parents may give permission for Tylenol/acetaminophen for pain on the student application and/or the emergency card. All medications will remain in a locked cabinet in the office. CCA will follow the guidelines set forth by the Illinois Department of Human Services and the Illinois State Board of Education.

PARKING LOT

Parents may park in the north lot when dropping or picking up their child. Do not park along the sidewalk.

PAYMENT

Tuition is paid by monthly installments. The total tuition is required regardless of personal vacation or illness. **If payment is not made by the due date each month, a late payment fee of \$15.00 will be added to your account.** When determining preschool tuition, Cornerstone Christian Academy has taken into account number of weeks in the school year to establish a monthly payment. The school has taken into account Thanksgiving, Christmas, and Easter breaks.

CCA reserves the right to remove a student from his or her classroom if an outstanding balance has not been paid after thirty days past the due date. A student may be reinstated if the bill becomes current.

PETS

Pets should not be brought into the building unless previously approved by the office and/or teacher.

PHOTOGRAPHS

Photographs of the students will be taken in the course of school activities throughout the year and will be used for CCA's promotional and advertising materials including the CCA website and Facebook. Parents are asked to sign a photography consent form provided at orientation or upon acceptance to CCA.

PHYSICALS AND IMMUNIZATIONS

All preschool students are required to have an updated physical every school year. Physical forms are kept in each student's file. A record of immunizations should be filled out on this form. If a family chooses not to immunize their child due to religious reasons or otherwise, a letter stating this must be on file in the school office by October 15th or the student will be excluded from school until proof is presented.

PLAYGROUND RULES

The following are general rules for the students to follow:

- Do not play with sticks.
- Do not climb trees.
- Do not throw snowballs.
- No rough play or wrestling allowed.
- Tagging is the only permitted bodily contact.
- Stay out of the landscaped areas.
- No playing in the middle of the bushes in the front of the building.

RELEASE OF PERSONAL INFORMATION

No personal information from a child's record will be released without the written consent of his parents or guardians.

REQUEST A CHANGE IN SCHEDULE

Parents wanting a change in daycare or preschool schedule must fill out a change of schedule form. The preschool administrator, upon availability of the classroom, will approve change of days and notify the teacher and the financial manager.

SCHOOL SECURITY

Cornerstone desires to provide a secure facility that prioritizes the safety of all students and employees. In this effort Cornerstone has installed a buzzer at the front east entrance, where CCA requires all guests who visit during the day to enter. The north door will be unlocked at the start and end of the school day to provide for drop-off and pickup, and at 11:30 a.m. for half-day pickup. All guests during the day will need to sign the visitors book and wear a visitor badge if they wish to accomplish something outside the lobby area. Your child will not be released to anyone who is not on the authorized pickup list.

SEXUAL HARASSMENT POLICY

It is the policy of Cornerstone Christian Academy to maintain a learning and working environment free of sexual harassment. All forms of sexual harassment, whether verbal, non-verbal, or physical, are prohibited. All charges of sexual harassment will be taken seriously and will be investigated promptly and in a way that respects the privacy of all parties concerned. A more detailed description of the sexual harassment policy is located in the Human Resources Handbook.

SMOKE-FREE ENVIRONMENT

Smoking is prohibited in and around facilities.

SNACK

CCA preschool is committed to promoting a healthy, nutritious environment and will be looking for foods that are high in protein, fiber, and calcium. A list of recommended snacks as well as restricted snacks due to allergies will be given to each parent.

SURVEILLANCE

CCA has invested in an electronic surveillance system to provide better protection for our students and employees, a deterrent for future break-ins, and a method for pursuing any perpetrators of vandalism or school policy violation. If a video clip is taken with a serious violation of policy or state or federal law, it can be used by authorities to pursue recompense and justice on behalf of the school.

TRANSPORTATION

Parents are responsible for providing transportation for their children to and from school. Car pools are encouraged.
