



## THE MAXINE WINTER MEMORIAL MUSIC SCHOLARSHIP

In 1998, in memory of Maxine Winter, G. Earl Winter created the Maxine Winter Memorial Scholarship Fund with a donation to one of the Faithful Servant Trust Funds. The earnings from this endowment will be used annually to fund one or more scholarships. Maxine and Earl were very involved in church music. Earl's purpose in establishing this scholarship was to encourage the faithful to further their interest and competency in music so that individuals will in turn share their musical gifts through the music and worship of the church.

This scholarship is offered to any current participant in the Music Ministry of Central Longmont Presbyterian Church who wishes to further his/her music education. This scholarship is open to anyone in high school and older, up to and including senior citizens.

This is a merit scholarship. It is not awarded for financial need. Applications may be made yearly. If a person is awarded money in one calendar year, he/she can reapply the following year. However, preference may be given to new applicants.

The scholarship will be awarded to one or more applicants in the spring of each year. The total amount to be awarded is limited to the earnings of the Maxine Winter Memorial Scholarship Fund. Specific awards are determined at the discretion of the Scholarship Committee. Multiple awards may be made each year.

Successful applicants may use the proceeds to pay for expenses related to music education such as college tuition, music camps, music conferences/workshops, as well as the purchase of instruments (with the approval of the Scholarship Committee). Award recipients are expected to be participants in the Central Longmont Music Ministry before or following the education for which the scholarship was used.

Applications are available on the website, by email, or in the Church office and **must be submitted to the Director of Music by Friday, April 17, 2026, in order to be considered.** Finalists may be interviewed by the Scholarship Committee.

(Although applicants are allowed a liberal use of the proceeds, certain uses will not qualify for income tax exclusion and may constitute taxable income to the recipient. Any resulting income tax reporting and liability is the responsibility of the recipient.)
