### **ADDITIONAL FEES & INFORMATION**

## **Deposits**

Deposits are due with submission of signed Enrollment Contracts. For re-enrolling students, deposits are rolled over from year to year until a child completes their educational experience at AIMS. Deposits are refunded only after completion of a full school year and payment of full annual tuition costs, including any incidental charges, typically in late June following the completed school year.

### **Annual Fees**

This non-refundable fee pays for program-related costs, such as consumable classroom supplies (including items for lessons/food prep), classroom materials, technology (where age-appropriate), etc. Annual fees are due with submission of signed Enrollment Contracts.

#### **Annual Tuition**

Tuition is charged on an annual basis. AIMS offers three payment plan options:

- Annual one payment due on July 1, 2024
- Two payments two equal payments due on July 1, 2024 and December 1, 2024. A finance charge of \$25.00 per payment will apply
- Ten payments ten equal payments due on the first of each month, from July 2024 through April 2025. A finance charge of \$25.00 per payment will apply

Monthly statements are issued via email, therefore, please ensure that your current email address is on file with the School.

## **Payment Methods**

AIMS accepts checks, pre-authorized ACH debits and all major credit cards (Visa, MasterCard, American Express, Discover) for tuition payments.

- <u>Checks</u>: All payments made by check in the correct amount must be delivered, via mail or in-person, to the Business Office prior to the due date. Please note that payments made by mail or through a payment service must arrive to the Business Office by the designated due date. Payments made by check are to be made payable to AIMS. A \$30.00 fee will be applied for each returned check.
- Pre-authorized ACH debits: A completed Automatic Clearing House (ACH) debit form must accompany all contracts using the Semi-Annual or Monthly payment plan option. This form designates the checking or savings account which will be debited each month on the designated date. Should the designated date fall on a Saturday, Sunday or National Holiday, the account will be charged upon the next business day. A \$30.00 fee will be applied for each returned ACH transaction.
- <u>Credit cards</u>: Please note that a Convenience Fee of 4.00% will be applied for each credit card transaction and a \$30.00 fee will be applied for each declined transaction.

Payments not received by the 11<sup>th</sup> of each month will incur a late fee of \$100.00 and a finance fee of 1.5% per month will be charged on any outstanding balance.
