Abortion Amendment

Timeline

Step

1

First Session: 2025

- The amendment has to be approved by both legislative chambers.
- Amendments cannot be vetoed by the governor.

Step

Election: Nov 2025

 An election of the House of Delegates must occur before the amendment is taken up again.

Step

3

Second Session: 2026

- The amendment is introduced again.
- The language of the amendment cannot be altered.
- The amendment must pass both chambers.

Step

4

Ballot: 2026

- The bill as passed twice goes to the ballot for the people to decide.
- People vote yes/no to add the language to the state constitution.



The abortion amendment in Virginia

"That every individual has the fundamental right to reproductive freedom, including the ability to make and carry out decisions relating to one's own prenatal care, childbirth, postpartum care, contraception, abortion care, miscarriage management, and fertility care. An individual's right to reproductive freedom shall not be, directly or indirectly, denied, burdened, or infringed upon unless justified by a compelling state interest achieved by the least restrictive means...".

Birthday Abortions

Abortion will be allowed up until the moment of birth for any reason. Currently Virginia allows abortions into the third trimester, with restrictions. That will no longer be the case under this amendment.

Babies Left to Die

Babies who survive an abortion attempt will not be given reasonable, life saving care. Abortionists will be legally allowed to deliver the baby and let it die on a medical table.

Parental Rights Undermined

Eliminates the right of parents to know about or consent to their young child's invasive abortion surgery.

Culture of Death

Under 50 years of *Roe*, the view of life decayed among Americans. Under this amendment, the respect for life will only worsen among Virginians. if we don't value life at its earliest stages, we won't value it at end of life.

Transgender Surgeries

"Reproductive Freedom" is an umbrella term that is not limited to women. Under this amendment men, women, and minors would also have a right to sterilization and therefore transgender surgeries.

Abortion Tourism

Virginia will become the Abortion Capital of the South. Since Dobbs, there has already been a 30% increase in out-of-state abortions occurring in Virginia.

Countless More Deaths

Virginia saw over 35,000 children die in 2023 from abortion, and Virginia's annual volume of abortions grew 103% in the past 6 years. With no restrictions, no limits, and no life-saving measures, the lives lost will only increase.

Exploitation of Embryos

The open-ended and undefined phrase "reproductive freedom" would allow for the unregulated sale and purchase of human embryos, and unethical research, commodifying human beings and leading to the exploitation of women.



Repeal and Replace Marriage

A Resolution to Redefine Marriage in the Virginia Constitution

That only a union between one man and one woman may be a marriage valid in or recognized by this Commonwealth and its political subdivisions marriage is one of the vital personal rights essential to the orderly pursuit of happiness.

This Commonwealth and its political subdivisions shall not create or recognize a legal status for relationships of unmarried individuals that intends to approximate the design, qualities, significance, or effects of marriage deny the issuance of a marriage license to two adult persons seeking a lawful marriage on the basis of the sex, gender, or race of such persons. Nor shall this Commonwealth or its political subdivisions create or recognize another union, partnership, or other legal status to which is assigned the rights, benefits, obligations, qualities, or effects of marriage. This Commonwealth and its political subdivisions shall recognize any lawful marriage between two adult persons and treat such marriages equally under the law, regardless of the sex, gender, or race of such persons.



Embeds Gender Ideology

The amendment's "sex" and "gender" distinction embeds gender ideology in the constitution, pressuring schools, businesses, and government to adopt policies that conflict with biological reality.



Promotes Instability

The proposed amendment reduces marriage to a source of personal happiness, and eliminates language that emphasizes the benefits and obligations of marriage that are important to children, family-building and stable communities.



Males in Female Sports

By inserting gender ideology in the constitution the amendment threatens women's rights in sports, locker rooms, and shelters, allowing biological men in women's spaces and raising safety and privacy concerns.



Threatens Pastors

The amendment has no conscience or religious exemption for clergy or members of religious organizations, businesses, and others with moral or ethical objections.


