Dear Parent,

We are extremely excited about the new year of Awana Clubs here at First Church! Thank you for allowing your children to attend. It should be a great year of fun, learning, and growing in the Lord.

In order for things to run as smoothly as possible, we would like to pass on some information. If you have any questions, feel free to discuss them with one of the directors (in the blue, red, or green shirts) or one of the commanders.

Awana begins at 6:30pm and ends at 8:00pm. Please do not drop your kids off earlier than 6:20pm or pick them up later than 8:00pm.

Our Awana program covers the following ages:

Cubbies = 3-4 years old (must be 3 by September 1st)

Sparks = Kindergarten, 1st and 2nd grades

T&T = 3rd - 6th grades

Costs: -- \$40 for the first child.

\$30 for the second child

\$25 for the third child +

We have kept the cost of Awana the same as last year.

The cost is to cover handbooks, vests, shirts, and everything else your child needs for Awana!

Payments may be made by cash or a check (made out to "First Free Methodist Church"). If the cost of the programs is a financial problem for you, please talk to the commander about other arrangements. We do not want your child to miss out on this program for any reason!

Bible Memory: -- The Awana handbooks are in the NIV. We ask that all

Clubbers to memorize from this version. We ask that parents not edit or make changes to the memorization passages.

Club Times: --The hours for Awana are 6:30–8:00 pm on Wednesdays, starting with registration from 6:20 pm.

Please, be sure to pick up your child(ren) no later than 8:00 pm. Feel free to pick up your Cubbies a few minutes earlier if you wish. Some of our leaders have small children too and understand the need to have them in bed early enough for school the next day. When picking up children, please pick them up in the foyer or their classroom. If you have Cubbies or Sparkies, you may pick them up in their classroom. The children are not allowed to leave until an authorized adult or teen sibling comes to get them. We require this for the safety of the children.

Parent Participation—It is important that your clubber comes prepared to Awana each week- bringing their handbook, vest or shirt and Bible. For your child's safety, please ensure your child wears sneakers to Awana, unless otherwise specified. To allow your child to experience all of the Awana evening, please have your child arrive no later than 6:30 (***but no earlier than 6:20***) each night.

Awana Discipline Guidelines—while we do not expect to have discipline problems with clubbers, in those rare cases that they occur, we utilize the following “3-Count” procedure:

1. If a clubber acts inappropriately, even after being reminded by an Awana leader of the expected club behavior, he/she will be given a “1-Count.”
2. If the clubber continues to create disturbances and disobey leaders, he/she will then be given a “2-Count,” which results in a conversation between the child, the leader involved, and the commander.
3. If the clubber still does not adjust his/her behavior as requested, then they will receive a “3- Count” and be suspended from Awana for at least one week. The clubber may be allowed to attend again, but only after the commander and leader have met with his/her parents to discuss the situation.
