



Facility Use Agreement

Oil Belt Christian Service Camp is a 501c3 Biblically-Based Religious Institution striving to uphold a conservative interpretation of The Bible. Our mission is to “Make Disciples of Jesus Christ through the teaching of God’s Word. The renter agrees not to use any of the Camp facilities for any purpose contrary to the mission, purpose, or beliefs of Oil Belt Christian Service Camp or its Board of Directors. A description of OBCSC, its beliefs, and mission statement are included in this agreement and posted on the website: oilbelt.com.

Oil Belt Christian Service Camp will not rent or lease the campgrounds, or any camp facilities, to any group or individuals who might teach beliefs or promote activities which oppose the interpretation of biblical principles held by the board of Oil Belt Christian Service Camp. Camp users must abide by the camp rental agreement. Furthermore, the board will not rent to any social organizations whose sole intent is to raise funds for the financial welfare of that group. Exceptions might be supporting church groups or organizations who raise funds for missions or humanitarian purposes. Rules for facility use, based on the beliefs of OBCSC, include but are not limited to the following:

- **Behaviors or attitudes which degrade or endanger others are unacceptable. Individuals have high value and are made in the image of God.** *“Then God said, ‘Let Us make man in Our image, according to Our likeness; and let them rule over the fish of the sea and over the birds of the sky and over the cattle and over all the earth, and over every creeping thing that creeps on the earth.’”(Genesis 1:26)* Therefore, people who stay at or use the camp facilities are expected to treat life and others with respect, compassion, and commitment to their health and growth. (Ephesians 4:32). Modesty and decency must prevail at all times in the dress of every guest. Oil Belt Staff will insist on changes if clothing is inappropriate.
- **No behavior or attitude which damages camp property is acceptable.** *“... it is required of stewards that one be found trustworthy.” (1 Corinthians 4:2)* Those who rent these facilities are responsible for any damages incurred during the time of rental and restitution will be required. Each group is responsible for cleaning the facilities after use.
- **Responsible adults must supervise all activities and facilities in use to reduce the risk of physical and/or sexual abuse.** At least two adults are required for supervision at all times according to camp policy. Overnights require two adults for each gender. Larger groups require a ratio of one adult supervisor for every seven school-aged participants.
- **Sexual Immorality is prohibited by God’s Word**, and, therefore, is prohibited by OBCSC, i.e. premarital sex, extramarital sex, homosexuality, pornography, or any other sexual activity outside the bounds of Biblical marriage *“Let marriage be held in honor among all, and let the marriage bed be undefiled; for fornicators and adulterers God will judge.”(Hebrews 13:4)* Those who desire to stay at Oil Belt or use its facilities will be denied privileges to rent if any of the aforementioned activities might be promoted, taught, or practiced within Oil Belt’s campus. Marriage between one man and one woman is the only marital union recognized by Oil Belt Christian Service Camp.
- **The use of illegal drugs, alcohol or any type of smoking is strictly prohibited on the campus.** Violators will be required to leave.
- **Possession/use of any weapon, firearm or fireworks is forbidden.**
- **Only approved items will be offered for sale on the campgrounds.**
- **Guests are not permitted to bring pets, unless required by physical handicaps.**
- **Guests must park only in designated areas.**
- **Snacks / Food of any kind are not to be taken into the dorms.**
- **Out of respect toward other guests and the community, an 11:00 pm camper’s noise curfew will be strictly enforced.**
- **Rental groups cannot enter any facility except those named on the accompanying rental/reservation agreement.**

- **No rental or reservation of Oil Belt's facilities will be allowed more than three months prior to the activity, unless approved by special permission of camp management and/or board.** The facility deposit is refundable until six weeks prior to scheduled arrival.
- **Those who reserve and rent any of the facilities of Oil Belt Christian Service Camp will be required to submit a copy of a Certificate of Insurance naming Oil Belt as an additional insured on the policy stating the dates the group will be at the camp. Guest groups agree to indemnify and save Oil Belt, its Trustees' and employees harmless from all damages, judgments, expenses, attorney fees, and compensation arising out of personal injury, death or property damage sustained in whole or in part by any or all persons whatsoever as a result of or arising out of any act of omission of guest group, its agents or employees, or caused by or resulting from any activity incident to the program being conducted by guest group, or use of Oil Belt facilities, or cancellation/closure due to natural disaster and/or emergency.**
- **The Board of Directors of Oil Belt Christian Service Camp retains sole authority of the camp's interpretation of Scriptures if any disputes arise.**

Pool Rules:

1. Swimmers must stay in fenced area. If someone is not swimming, they must also stay in the fenced area.
2. Only lifeguards or camp management approved people are allowed in lifeguard chairs.
3. NO using the pool as a bathroom, use the bathroom as a bathroom.
4. NO diving into the pool except from the diving board.
5. NO running on pool deck or in locker rooms.
6. NO horseplay near edges or in dive/slide tanks.
7. One at a time going down the slide. Three or less people on the slide steps at one time.
8. Feet first going down the slide only.
9. NO backflips on diving board.
10. Swim test must be taken to jump off diving board.
11. Jump straight off the diving board.
12. NO jumping into dive tank unless using diving board.
13. NO walking on island between dive tank and slide tank. Only Lifeguards may use this area.
14. NO walking or sitting on dividing wall.
15. Don't pick flecks off the deck.
16. Smile a bunch! Splash a lot, but don't splash lifeguards.
17. Hang towels up in locker room or on hooks provided.

By signing this form, the renter is agreeing to these terms and indicating agreement with God's Word concerning these matters. Violation of any of these rules might cause immediate dismissal without refund of contractual obligation.

STATEMENT OF FAITH

Oil Belt Christian Service Camp is a non-profit religious organization affiliated with the Christian Churches and Churches of Christ of the Restoration Movement. With a belief in Jesus Christ as Savior and Lord, we also hold an infallible view of the Bible as God's Word. Our goal is to *make disciples of Jesus Christ through the teaching of God's Word*.

The Bible: We believe the 66 books of the Bible are the inspired, inerrant Word of God (John 10:35; 17:17). It is therefore the authoritative source for everything done in the church (II Timothy 3:16-17).

Creation: We believe that, "In the beginning God created the heavens and the earth" (Genesis 1:1). The universe is not here by accident, but rather was spoken into existence by the power of God's Word (Genesis 1 & 2, John 1). Mankind is the special creation of God, made in His image, and not the result of animal evolution (Genesis 1:26-30; 2:7). With the creation of Adam and Eve, God instituted the covenant of marriage between one adult man and one adult woman (Genesis 2:24), of which Jesus Christ affirmed in His ministry (Matthew 19:4-6).

Jesus Christ: We believe that Jesus is the Christ, the Son of the living God (Matthew 16:16). We believe that He is the Savior of the world (John 4:42). He was born of a virgin (Matthew 1:22-23), lived a sinless life (Hebrews 4:15), was crucified for the atonement of sins for all mankind (I John 2:2), physically arose from the dead (Matthew 28:1-10; Acts 2:24-32; 13:29-38), and He is coming back again (John 14:1-3; Revelation 22:12-21). Through Him, and Him alone, is salvation found (John 14:4-6; Acts 4:10-12).

Salvation: God grants the pardon of sin, the gift of the indwelling presence of the Holy Spirit, and the reward of eternal life to those who place their faith in Him (Ephesians 2:8), repent of their sins (Acts 2:38; 3:19), confess Christ as Lord (Matthew 10:32-33; Hebrews 10:23), and are immersed into Christ (John 3:5; Mark 16:16; Acts 2:38; Romans 6:3-7; I Corinthians 12:13; Colossians 2:12; I Peter 3:21). Through the Holy Spirit, God gives us the power to live Godly lives and guidance in following His will (Romans 8:1-4, 26).

Eternity: We believe that Heaven is the real, eternal destination for all who are in Christ (John 14:1-6; II Corinthians 5:1-10). We believe that Hell is the real, eternal destination for all who are not in Christ (Matthew 10:28; 25:41-46; Revelation 20:15).
