

# PHASED RESPONSE PLAN

PHASES 3 AND 4 OF OUR PLAN FOR "RE-OPENING" OUR BUILDING (APPROVED BY THE SFCC BOARD 5/17/21)

## PHASE THREE (MAY 18, 2021 TO PRESENT)

### BUILDING IS AVAILABLE WITH SOME RESTRICTIONS

Mandatory masks for all over 2yo in groups larger than 20; smaller groups may have optional masking w/unanimous group vote if social distancing is practiced; no occupancy limits in place

**\*NOTE\*** If a serious spike in COVID-19 cases occurs, we reserve the right to go back to Phase Two.

- **WORSHIP:** in-person & live-streamed with mandatory masks and some social distancing available; no occupancy limits in place and no reservations required
- **PRAYER/CARE:** in person or online/phone, depending upon individual's preference
- **CLASSES/GROUPS/MEETINGS:** online or in person, depending on group's preference; masks required for groups larger than 20 (smaller groups may have masks optional w/unanimous group vote if social distancing is practiced)
- **NURSERY/CHILDREN'S MINISTRY:** closed
- **YOUTH GROUP:** in-person with mandatory masks
- **LARGER OUTDOOR GATHERINGS:** available without restrictions
- **OFFICE STAFFING:** office staffed from 9-Noon on weekdays for deliveries, phone calls, etc.
- **OUTSIDE GROUPS:** no occupancy limits; must schedule with church office; mandatory masks for groups larger than 20 (smaller groups may have masks optional if social distancing is practiced)
- **FOOD PANTRY:** Open on Tuesdays from 8:30-11 with indoor service (or as pantry team sees fit)

## TRIGGERS TO MOVE TO PHASE 4

### HOW WE'LL KNOW IT IS TIME

1. COVID-19 **case count remains low or continues decreasing**, according to Clay County/KC data.
2. CDC changes their guidelines on mask usage for UNVACCINATED individuals
3. Children 11 and under are able to get vaccinated
4. Communication to congregation describing protocols and expectations created and sent.

## PHASE FOUR (TO BE DETERMINED)

### BUILDING FULLY AVAILABLE WITHOUT RESTRICTIONS

#### NO MANDATORY RESTRICTIONS IN PLACE

- **WORSHIP:** in person w/out occupancy limits or masks, plus online via live-stream
- **PRAYER/CARE:** in person or online, depending upon individual's preference
- **CLASSES/GROUPS/MEETINGS:** online or in person, depending upon group's preference
- **NURSERY/CHILDREN'S MINISTRY:** open
- **YOUTH GROUP:** in person without restrictions
- **LARGER OUTDOOR GATHERINGS:** available without restrictions
- **OFFICE STAFFING:** office staffed from 9-Noon on weekdays for deliveries, phone calls, etc.
- **OUTSIDE GROUPS:** no occupancy limits; must schedule with church office
- **FOOD PANTRY:** Open on Tuesdays from 8:30-11 with indoor service (or as pantry team sees fit)
