Report from November 2nd Synod Assembly – Rev. Suzanne Malloy. Rev. Malloy shared about presentations and action from the November 2nd meeting of the Synod of Southern California and Hawaii, including the Presbyterian Chaplaincy at the USC/LA County Medical Center, Zephyr Point Conference Center (Lake Tahoe), recent Synod Grants. The Synod 2020 Budget was approved. Synod Per Capita remains at the same amount as 2019 - \$2.85. Rev. Suzanne Malloy was installed as Synod

Moderator Elect.

Treasurer's Report. CRE Bonnie Boe

-- Financial Report: Treasurer Bonnie Boe presented and explained the Presbytery Balance Sheet, as of September 30, 2019, which brings the Balance Sheet up to date, pursuant to the work by the auditors over the last 2 ½ years and the completed 2018 Audit. The Profit & Loss Financial Report to date is included in the handout with the proposed 2020 Budget. The El Montecito Dismissal funds are booked as an account receivable. The restricted ministry assets are paid on a quarterly basis.

Motion to receive the Treasurer's report, Balance Sheet as of September 30, 2019, and Profit and Loss Financial Report (shown in the proposed 2020 Budget) was made, seconded.

-- Audit Report. Auditors Chris Harris, CPA. Chung Cam, CPA were present and reported to Presbytery. The 2017 Audit and 2018 Audit are complete, and copies have been distributed to Presbyters.

Report of Presbytery Council.

- 2020 Proposed Budget. Scott Eschbach, Chair, Property & Finance Committee. Ruling Elder Scott Eschbach presented the 2020 Proposed Presbytery of Santa Barbara Budget, which has been approved by Council to go to Presbytery for approval. Scott highlighted and explained several items: (1) Front Porch and Mission Conference expenses are included in the Budget; (2) "Ministry Share" has been replace with the term "Per Capita." The budgeted amount for Presbytery Per Capita (top line under Operating Income) of \$241,878, is based on a per capita of \$57 per church member in the Presbytery. (3) Allowance for doubtful per capita is included, \$62,667. The source of funding for doubtful per capita (deficit) is from Presbytery funds set aside in reserves for operations.
- A Motion was made from the floor and seconded to Amend the 2020 Proposed Budget to remove the Administrative Pastor position and related staff expenses listed in the Proposed Budget.
- A Motion was made from the floor and seconded to Postpone further discussion and action on the original Motion on the Budget and the Motion to Amend, until later in the meeting, after the scheduled presentation of further information on the proposed Administrative Pastor position.

Election of RE Commissioner to 224th General Assembly (2020, Baltimore, MD). Nomination procedures provided for submission of Nomination forms by the November 1, 2019 deadline. One Nomination Form was received by the Stated Clerk. Ruling Elder Susan Freer was nominated by the Session of Pismo Beach Community Presbyterian Church. Susan Freer submitted her written answers to the Nominee Questions, which were provided to Presbytery. The Moderator called Susan Freer forward and she answered questions from the floor and spoke about her enthusiasm for serving in this

Motion to elect Ruling Elder Susan Freer as Ruling Elder Commissioner to the 224th PC(USA) General Assembly (2020). **Approved**

Planning Team Update.

- Celebrating the Bright Spots. Rev. Kristy LaBarge from Impact reported on the Summer 2019 mission trips. The participants are multi-generational. Phil Haik, a member at Emmanuel Presbyterian Church, shared about his meaningful experience helping special needs youth in Ukraine.
- Report from Planning Team. Rev. Dan Stevens reported that the Planning Team is focusing on committee functioning.

Presbyterian Foundation. *Maggie Harmon, Ministry Relations Officer.* Maggie Harmon shared about the Presbyterian Foundation programs and resources, including Stewardship Navigator and the online giving program.

Committee Reports and Motions

- **Personnel Committee**. Rev. Dennis Falasco.
 - Report on completion of Stated Clerk annual review and proposed hours and compensation as set forth in proposed 2020 Budget.
 - Two proposed policy documents are presented at this meeting for first reading, to come before Presbytery for approval at the February 8, 2020 Presbytery Meeting: Sexual Misconduct Policy and Child Protection Policy. Churches should be aware that these types of policies are required by the Book of Order for churches.
 - O Administrative Pastor Draft Position Description. Ruling Elder Scott Eschbach reported that the Position Description presented to Presbytery is a draft, and this is intended as a ¾ time position. It comes out of work by the Planning Team and is continuing to be worked on at the Council level. Presbytery members are asked to share feedback, comments and questions.
 - o Bookkeeper Position. The position is open and candidates are being considered and interviewed.
- **Committee on Ministry.** Rev. Jeff Holland.
 - o Rev. Jeff Holland, Chair, reported.
 - Rev. Tracy Vining (HR) has requested to be dismissed to the Evangelical Covenant Order of Presbyterians (ECO). Motion from COM to dismiss Rev. Tracy Vining (HR) has requested to be dismissed to the Evangelical Covenant Order of Presbyterians (ECO).

- Report from PC(USA) Mid-Council Leaders Gathering. Rev. Tom Stephen reported that he attended the gathering in October in Baltimore. Stated Clerk Sandy Thoits also attended for the Presbytery. Helpful information was shared and resources were gathered the presentations and workshops.

There being no further business, the meeting adjourned with prayer at 5:05 p.m.
