The 473<sup>rd</sup> Stated Meeting of the Presbytery of Santa Barbara, Presbyterian Church (USA) was convened on May 14, 2022 at 9:30 a.m., by Moderator Ruling Elder Lee Kirkpatrick, who opened the meeting with prayer.

Stated Clerk Sandy Thoits reported and referred Presbyters to the item on the Consent Agenda for approval of the Recommendation on Plan for Parity for Ruling Elders Commissioners and Teaching Elders at Presbytery Meetings. The Plan for Parity comes up for Presbytery review on an annual basis. For 2022, the Plan is based on end of year 2021 membership number reported with church statistics. One change in ruling elder number for 2022 (from 2021): Monte Vista Pres. Church (Newbury Park), change from 3 ruling elders to 2 ruling elders. This is effective beginning at the 9/17/22 Presbytery Meeting

The February 5, 2022, Presbytery Minutes were approved with the Consent Agenda.

## Presbytery Adjourned for a time of Worship, Music, Commissioning and Prayer.

- Music. Music offering provided by the First Presbyterian Santa Barbara Worship Team
- Scripture Reading. Rev. Ann Conklin read from Isaiah 58: 6-12.
- Meditation. Rev. Kristy LaBarge and Rev. Jonathon LaBarge spoke about Christ's calling to
  witness to a trinity-like oneness with others in mission and shared about plans for this year's
  Impact Teams. This year there are two teams, one going to Turkey and one going to Honduras.
  Several team members were present and introduced,
- Commissioning Impact Teams & Prayer. Rev. Tom Stephen presented the commissioning of the Impact Teams and asked presbyters to covenant to pray for the people serving on the teams.

Workshop – "Showing Jesus to the World." Small Groups (In Person). Breakout Rooms (Zoom). Rev. Jonathan LaBarge continued speaking about the focus on the plans and prayers for the Impact Teams being commissioned at this meeting. He shared about the intersection between Impact ministry and the local churches. Presbyters at FP Santa Barbara were gathered into small groups, and Presbyters on Zoom were placed on Zoom "Breakout Rooms" for small group discussion and sharing. Discussion questions: (1) How does Jesus challenge and call your church to witness a trinity-like

oneness in to others? (2) What steps might the Lord be asking you to engage in to share the trinity-like image of Jesus to others? Rev. Stephen then closed this session with prayer.

Report of Presbytery Council. Rev. Tom Stephen, Council Chair, reported.

- In Person Committee and Commission Meetings. Rev. Stephen reported that Presbytery
  Council has approved that committees and commissions may meet by Zoom, or in person, or as
  a hybrid meeting (in person and by Zoom), with suitable Covid 19 safety measures.
- Treasurer's Report. Ruling Elder Scott Eschbach, Treasurer, reported that a written financial report is not available for this meeting due to computer issues at the Presbytery office. The 2020 draft audit has been received from the Presbytery CPA firm. The completed audit is expected to be presented to Presbytery at the next Presbytery Meeting.
- Ratification of Amendments to Presbytery Standing Rules and Bylaws for Electronic and Teleconference Meetings and Voting; Ratification of Actions taken at Presbytery Meetings. Rev. Stephen announced that this action item is deferred to the next Presbytery Meeting, September 17, 2022.
- Recommendation from Council. Rev. Stephen, Chair of Presbytery Council, reported that the Agenda for this meeting includes the text of three (3) motions regarding Church at the Collection, New Worshipping Community (NWC): One (1) motion from Presbytery Council and two (2) motions from Oxnard First Presbyterian Church. Rev. Stephen reported that Presbytery Council, after thorough review of the history, background and the current status, approved recommending to Presbytery a Motion from Presbytery Council for Approval by Presbytery. Rev. Stephen read out loud the text of the motions listed on the Agenda:
  - A. Motion From Presbytery Council. That Church at the Collection NWC be officially closed and that all unencumbered funds be returned to the Presbyterian Mission Agency; and furthermore, that we commend the Church Development Committee (CDC) on their work.
  - o B. Motions from Oxnard First Presbyterian Church.
    - First Motion: That Common Table be affirmed as the continuation of Church at The Collection for ministry in Riverpark, and that funds raised for ministry in Riverpark, along with future opportunities for funding, be made available to Common Table for use in that community.
    - Second Motion: That Presbytery approve two grant applications for GA
       Unassigned Funds for Presbytery approval and to pass on to Synod for their
       review by June 1.
  - The Moderator announced that Presbytery would address these Motions in the order as set forth on the Agenda. The Moderator then acknowledged a Ruling Elder presbyter present at First Presbyterian, Santa Barbara, who stood and stated a **Motion**, as follows:

- The Moderator then called on presbyters for verbal discussion on the First Motion listed on the Agenda from Oxnard First Presbyterian Church be a substitute motion for consideration by Presbytery, in place of the Motion from Presbytery Council. The Moderator instructed presbyters attending by Zoom to use the raise hand feature to be recognized and to speak out loud. Discussion occurred and concluded. The Moderator announced closure of discussion.
  - The Moderator then called the question on this Motion. The Moderator asked for "yes" and "no" votes by raised hands from presbyters attending both In Person and by Zoom attendance, on the motion The Moderator announced confirmation that voting concluded.

The Moderator then announced that "no" votes outnumbered the "yes" votes and the **Motion to substitute failed (not approved).**

    Presbyterian Mission Agency; and furthermore, that we commend the Church
    Development Committee (CDC) on their work.
    - The Moderator called on presbyters for verbal discussion from in person attendance and Zoom attendance. The Moderator instructed the presbyters attending by Zoom to use the raise hand feature to be recognized and to speak out loud. Discussion occurred and concluded. The Moderator announced closure of discussion. The Moderator then called the question on the Motion and asked for "yes" and "no" votes by raised hands, from presbyters from both In Person and Zoom attendance.   - Nominations and Elections of Committee Members. Reverend Loughry, Chair of CORN, referred to the written Nominations Report with the Committees listed, which was provided with the packet of reports for this meeting. New nominations to be voted on for this meeting are indicated by the Yellow Highlights. The Rev. Rev Loughry reported that the list includes the election of 1 new committee chair: Ron Urzua (CPM). Rev. Loughry asked for nominations from floor, none given. Rev. Loughry explained that the Report includes the listing of the Standing Rules to be set aside. Presbytery's vote on the Nominations report includes a vote to set aside the Standing Rules as listed on the report.

**Motion to elect** the persons nominated as listed on the Nominations Report (Attachment 2 to these Minutes), including Committee Chairs, and to approve setting aside the Standing Rules as listed in the Nominations Report. **Approved** 

- Description of Moderator-Elect (2022-23). Rev. Loughry reported that one (1) written nomination form was received for the 2022-2023 Moderator-Elect position. The deadline for nominations closed on May 1, 2022. Nominee: CRE Diane Kirkpatrick. Rev. Loughry stated the Motion to elect CRE Diane Kirkpatrick as Presbytery Moderator Elect (2022-22). Approved (Unanimous)
- o **Committee Chairperson Election**. Rev. Loughry announced that this item was approved as part of the approval of the full Nominations list.

commissioner to 225th General Assembly. Rev. Loughry reported that the Presbytery previously elected the Presbytery's Teaching Elder Commissioner to this year's PC(USA) 225th General Assembly, Rev. David Anderson. Rev. Anderson is no longer able to serve. Rev. Loughry reported that the Stated Clerk notified the Presbytery seeking nominations. One nomination was received by the Stated Clerk. Nominee: Rev. Jennifer Fraser. Rev. Fraser confirmed her nomination and that she is able to serve. Rev. Loughry asked for nominations from the floor. None given. Motion to elect Rev. Jennifer Fraser as the Presbytery's Teaching Elder Commissioner to the 225th General Assembly.

## Committee on Ministry. Rev. Jeff Holland

Examination for Presbytery Membership. Rev. John Burnett (HR). Rev. Holland presented the Committee's recommendation to examine Rev. John Burnett for membership in the Presbytery of Santa Barbara, as Honorably Retired member. Rev. Burnett is currently a minister member in good standing in San Fernando Presbytery. Rev. Burnett shared about his faith background and call to ministry. He then read his Statement of Faith and responded to questions from presbyters.

**Motion** to cease examination made, seconded and **approved.** Rev. Burnett was excused from the room.

It was moved and approved that Rev. John Burnett be enrolled as an active Honorably Retired member of the Presbytery upon his dismissal from San Fernando Presbytery. Rev. Burnett returned to the room and Presbyters welcomed him and Presbytery members welcomed him and asked for God's blessing on his ministry.

Examination for Presbytery Ordination, Membership. Anthony Jones. Rev. Jeff Holland, Chair, presented the Committee's recommendation to examine Candidate Anthony Jones for ordination in the PC(USA) as a Teaching Elder in the Presbytery of Santa Barbara, to serve as Associate Pastor at Ojai Presbyterian Church. Candidate Jones attended the Presbytery Meeting by online Zoom. He shared about his faith background, journey and call to ministry. He then read his Statement of Faith and responded to questions from presbyters.

A **Motion** to cease the examination was made, seconded and **approved.** Candidate Jones was excused to the Zoom waiting room. Rev. Holland presented a **motion** from the committee that that Anthony Jones be ordained as a Teaching Elder in the PCUSA, and that following ordination, he be enrolled as an active member of the Presbytery of Santa Barbara, serving as Associate Pastor at Ojai Presbyterian Church.

Candidate Jones returned from the Zoom waiting room and Presbytery members and friends then welcomed him and asked for God's blessing on his ministry. Rev. Holland stated that Ojai Presbyterian Church will submit the terms of call and ordination plans to the Committee on Ministry.

- Presbytery Membership Transfer. Rev. Chelsea Leitcher. Rev. Holland reported that Rev. Chelsea Leitcher has requested to transfer back to the Presbytery of Santa Barbara, from her recent transfer to the Pittsburgh Presbytery. Rev. Holland reported that nothing has changed in her Statement of Faith. Motion from COM: To receive Rev. Chelsea Leitcher into membership of the Presbytery of Santa Barbara in a validated ministry as a chaplain.
   Motion Approved
- Church Triumphant. Rev. James Bain (1929-2022). Rev. Bain was a former Pastor at Oxnard First Presbyterian Church. Ruling Elder Sue Meagher (on behalf of Oxnard First Pres.) spoke about Rev. Bain's life and ministry.
- Designated General Presbyter Search Committee. Rev. Sean Chow reported that the Committee is continuing its work.
- Other Committee Reports. Due to the extended length of the meeting, the remaining Committees waived giving verbal reports. Property & Finance. Clergy Support. Church Development Committee. Church in the World.
- Front Porch Campus Ministry. Rev. Mickey Fenn reported on a successful fundraiser, Front Porch Day.

There being no further business, Moderator Lee Kirkpatrick gave the closing prayer. The meeting adjourned at 1:30 p.m.

Recommendation on Plan for Parity between Teaching Elders and Ruling Elders at Presbytery Meetings For Presbytery Approval – May 14, 2022

Effective as of the September 17, 2022 Presbytery Meeting

**Note** – Plan for Parity between Teaching Elders and Ruling Elders at Presbytery Meetings was last approved by Presbytery on September 18, 2021.

## General Provisions:

G-3.0301 of the Book or Order: THE PRESBYTERY - Composition and Responsibilities.

The presbytery is the council serving as a corporate expression of the church within a certain district and is composed of all the congregations and ministers of the Word and Sacrament within that district. The presbytery shall adopt and communicate to the sessions a plan for determining how many ruling elders each session should elect as commissioners to presbytery, with a goal of numerical parity of ministers of the Word and Sacrament and ruling elders. This plan shall require each session to elect at least one commissioner and shall take into consideration the size of congregations as well as a method to fulfill the principles of participation and representation found in F-1.0403 and G-3.0103. Ruling elders elected as officers of the presbytery shall be

enrolled as members during the period of their service. A presbytery may enroll, or may provide by its own rule for the enrollment of, ruling elders during terms of elected service to the presbytery or its congregations. (Emphasis added).

Presbytery of Santa Barbara Standing Rules 2.10 MEMBERS:

The members of the Presbytery consist of all teaching elders duly enrolled, ruling elders elected as officers of the Presbytery during their period of service and, at least two ruling elder commissioner elected by church session in accordance with G-3.0202a, and enrolled at a Presbytery meeting, with the following additional provisions: ENROLLED: At a Presbytery meeting, Ruling Elders elected by session as commissioners shall be enrolled as voting member commissioners of the Presbytery upon the filing an enrollment card with the Stated Clerk whereon the person certifies their election. Said card shall comprise the roll of the meeting. Chairs of each standing committee, as well as honorably retired members also have voting rights. Corresponding members may have the privilege to deliberate and advice, but will have no vote. Honorably retired teaching elders who have not attended a meeting of Presbytery in the past year will not be included in establishing a plan for parity between teaching and ruling elders at a meeting of the Presbytery.

\*\*Electronic Meetings: Roll is taken by pre-meeting online registration and video confirmation of attendance. The roll of the Presbytery is constituted by those who registered for the meeting and whose attendance during the Zoom meeting is confirmed by the Stated Clerk.

The Stated Clerk recommends that Presbytery <u>approve</u> the following method of correcting any imbalance of Ruling Elder Commissioners to Teaching Elders of the Presbytery at Presbytery Meetings, based on Section 2.10 of the Presbytery Standing Rules and G-3.0301 of the Book of Order:

The members of the Presbytery shall be:

- A. All teaching elders and commissioned ruling elders duly enrolled and when Presbytery meets, including honorably retired members;
- B. Ruling elders elected as officers of the Presbytery during their period of service;
- C. Chairs of each Standing Committee;
- D. Each church, regardless of the size of the congregation, shall be represented by two ruling elders commissioned by the Session and duly enrolled at the Presbytery Meeting, with the following additional provisions:
  - 1) For churches with membership under 200, no additional ruling elder commissioners
  - 2) For churches with membership of 200-400, one additional ruling elder commissioner
  - 3) For churches with membership of 400-600, two additional ruling elder commissioners
  - 4) For churches with membership over 600, three additional ruling elder commissioners

Annually, the Stated Clerk of the Presbytery shall ascertain the number of resident Teaching Elders who are members of Presbytery and the number of Ruling Elders which the churches are entitled to send as commissioners to Presbytery Meetings pursuant to this recommendation. The Stated Clerk shall bring any imbalance to the attention of the Presbytery at its May Stated Meeting.

Application of this Recommendation for Presbytery as of May 14, 2022 to take effect as of the September 17, 2022 Meeting:

As of May 14, 2022, there are 80 Teaching Elder members of Presbytery, 41 of these are honorably retired. Of these honorably retired members, 9 have actually attended a Presbytery meeting in the past year. In accordance with the Standing Rules, honorably retired teaching elders who have not attended a meeting of Presbytery in the past year will not be included in establishing a plan for parity between teaching and ruling elders at a meeting of the Presbytery: 41 - 9 = 32. This leaves a potential attendance of Teaching Elders: 48 (80 - 32 = 48) Teaching Elders.

RATIONALE for Assignment of Ruling Elder representation to Presbytery. In order to serve compliance with the Book of Order requirement that the size of congregations be considered in determining how many Ruling Elders each Session should elect as commissioners to Presbytery, a method of proportional representation based on membership is recommended in this proposal, as shown in the Chart below.

Objectives: (1) Create an opportunity for parity in numbers of Ruling Elder and Teaching Elder representatives at Presbytery, (2) Follow the Book of Order and Presbytery of Santa Barbara Standing Rules minimum guidelines, (3) Allow each church to have at least two ruling elder representatives as required by the Presbytery Standing Rules, while not disenfranchising members in larger churches.

Change in Presbytery Total Membership: 12/31/2020 Total = 3650. 12/31/2021 Total = 3528. Difference: --122 members
