The Mission of the Presbytery of Santa Barbara:

The 469th Stated Meeting of the Presbytery of Santa Barbara, Presbyterian Church (USA) was convened on May 15, 2021 at 9:30 a.m. via Zoom audio/video teleconference call platform, by Moderator Rev. Tom Stephen, who opened the meeting with prayer.

Moderator Stephen introduced Elder John Losey, ruling elder from Monte Vista Presbyterian Church, acting as administrator host for the Zoom online meeting platform. RE Losey explained the functions on Zoom, including voting.

Stated Clerk, Sandy Thoits, confirmed the presence of a quorum.

- Music. Video Hymn from First Presbyterian Church Oxnard. Virtual Chancel Choir. "Praise My Soul the King of Heaven."
- Meditation. Rev. Keenan Barber, Pastor at Moorpark Pres. Church, led a time of mediation;
 scripture from Genesis 40 and Philippians 4:13, with a time of reflection on this pandemic year and remembering with gratitude our spiritual gifs as we move forward.
- Breakout Rooms. The Moderator announced that the Zoom "Breakout Rooms" option will be used as an opportunity for presbyters to be placed in Zoom small groups for sharing with each other in answer to the question: This is a season of my life when ... At the conclusion of the Breakout group discussion time, presbyters returned to the full meeting. Rev. Barber closed the worship time in prayer.

Report of Presbytery Council. Rev. Janet Loughry, Council Chair, reported.

- Introduction of Council Members. Rev. Loughry introduced the Presbytery Council Members and their committees.
- September 18 Presbytery Meeting Hybrid In Person & Livestream. Rev. Loughry reported on planning for the September 18, 2021, Presbytery meeting, as a hybrid of in person and online meeting. Location: First Presbyterian Church Santa Barbara.
- Designated General Presbyter Position. Rev. Loughry reported that Rev. Rene Myers from the Presbyterian Mission Agency attended the April 28 Council meeting. Rev. Myers shared helpful information on presbytery leadership and staffing models from the western region and church revitalization programs and resources within the denomination. Rev. Loughry reported that Council has considered and discussed in several meetings over the last several years leadership and staffing formats and models, survey results and feedback from Presbytery. A Special Meeting on the topic occurred on March 9, 2021.
 - O Rev. Loughry reported that Council approved a motion at the April 28 Council meeting: (1) That the Presbytery of Santa Barbara hire someone into a position of General Presbyter Designated under the standards of our polity for a term of 2-4 years, as a ¾ time position. (2) That an Ad Hoc Committee be appointed by Council to work, in conjunction with the Personnel Committee, to develop a definitive job description for this position. (3) Council appointed the Ad Hoc Committee: Council members Rev. Matt Elam and CRE Diane

Kirkpatrick and the Personnel Committee. The process has begun on preparing a position description. Involvement in church revitalization to be included.

**Note for Minutes: After the conclusion of Rev. Loughry's report, Rev. Ted Brandt, attending the meeting by Zoom, contacted the Stated Clerk utilizing the Zoom "Chat" feature. The following is the text from the Chat record:

- Rev. Ted Brandt (TB): Are we discussing and acting on the DGP motion from Council?
- RE Sandy Thoits (ST): Janet gave the report on the DGP position. There isn't any action item on it for this meeting.
- TB: So we'll get to discuss and vote on this position at the next meeting?
- ST: The business for the next meeting isn't planned yet.
- TB: As I interpret the actions of Presbytery, we have not removed the placeholder status on the funds for designated general presbyter and so I would think we would need to discuss and approve the position as a Presbytery before a search begins. Hopefully something will be said about status of this because otherwise it would be confusing to commissioners.
- Treasurer's Report. Ruling Elder Scott Eschbach, Chair of the Presbytery Property & Finance Committee, shared on the Zoom screen the Presbytery Meeting Financial Statement as of May 15, 2021 and Summary of Statement of Financial Position (May 15, 2021), included in the documents packet for the meeting. Elder Eschbach explained selected items. The annual Per Capita submitted by churches are appreciated by the committee and Presbytery Council. RE Eschbach expressed appreciation for CRE Bonnie Boe for her faithful service as Presbytery Accountant, including putting in putting together the written financial reports.
 - o Net Operating Income through March 31, 2021: \$50,732
 - o Total Liabilities & Net Assets, March 31, 2021: \$6,316,933
 - o **Motion** to receive the Treasurer's report, was made, seconded.

- Election of Presbytery Moderator Elect (2021-2022). Rev. Loughry reported that no nominations have yet been submitted for the 2021-2022 Moderator Elect position. She encouraged presbyters to submit nominations for this important role.
- Nominations and Elections of Committee Members. Reverend Loughry referred to the written Nominations Report with the Committee lists and members, provided with the packet of reports for this meeting. New nominations to be voted on for this meeting are indicated by the Yellow Highlights. The Report includes the listing of the Standing Rules to be set aside. Presbytery's vote on the Nominations report includes a vote to set aside the Standing Rules as listed on the report.
 - A Motion was made and seconded to elect the persons nominated as listed on the Nominations Report (Attachment B to these Minutes) and to approve setting aside the Standing Rules as listed in the Nominations Report.

Committee Reports

 UMB Front Porch Update. Rev. Tom Stephen reported that meetings of the Group of 6 are ongoing with good progress, including conversations on planning and reconciliation. UMB is the Presbytery related corporation for the Casa Veranda apartments and Front Porch ministry building next to Cal Poly San Luis Obispo. The group has been working on communications and toward a healthier system. Rev. Stephen shared on the Zoom screen "Our Collective Commitment:

- o "We acknowledge that past members of boards, councils, committees, task forces and staff have spoken words both intentionally and unintentionally that have brought hurt, pain and/or anger and that words spoken have not been received both intentionally and unintentionally in the spirit in which they were intended. There has been both misconception and mis-reception in the communication between the Presbytery, the UMB Board and Front Porch Ministries. We deeply regret that this has occurred and lament any word spoken that brought about misunderstanding and pain. We acknowledge the hurt, repent of any part we each held and resolve to completely let go of past resentment(s) in order to move forward, united in purpose and in the love of Christ, which is at the center of all we strive to do."
- **Committee on Ministry.** Rev. Bruce Lethbridge, COM member, reported for the Committee.
 - Examination for Presbytery Membership. Rev. Rev. Sean Chow. Rev. Lethbridge presented the Committee's recommendation to examine Rev. Sean Chow for membership in the Presbytery of Santa Barbara, as Member at Large. Rev. Chow is currently a minister member in good standing in the Presbytery for Southern New Jersey. Rev. Chow shared about his faith background and call to ministry. He then read his Statement of Faith and responded to questions from presbyters.

Motion to cease examination made, seconded and **approved.** Rev. Chow was excused to the Zoom waiting room.

It was moved and approved that Rev. Sean Chow be enrolled as an active member of the Presbytery as Minister at Large, upon his dismissal from Presbytery for Southern New Jersey.

Rev. Chow returned from the Zoom waiting room and Presbyters welcomed him and Rev. Lethbridge prayed for God's blessing on his ministry.

- o **Church Triumphant.** Rev. Lethbridge expressed blessings and appreciation for service in ministry on the passing of Rev. Art Beals (HR).
- o **Minister Changes.** Rev. Lethbridge presented **motions** from the Committee on Ministry:
 - o To dismiss Rev. Megan Babayco to the Presbytery of Western Colorado, upon their request.
 - o To dismiss Rev. Tyson Babayco to the Presbytery of Western Colorado, upon their request.
 - o To dismiss Rev. Cynthia Purvis Presbytery of Coastal Carolina, upon their request.
 - Motions Approved
- Property and Finance Committee. Ruling Elder Scott Eschbach, Chair, referred Presbytery to Treasurer's Report, reported earlier in the meeting. No further report.
- Church in the World. CRE Chuck Curtis, Chair, reported. The 2022 Santa Barbara Mission Conference dates are set for January 28-29, 2022. The theme is "Called to be Reconciled." The "Rising to the Moment" program in January 2021 went well, with 80 people taking part in the program. A new "Rising to the Moment" Curriculum for small groups (teens and adults) has been developed and will be made available.

- Clergy Support Committee. Rev. Mickey Fenn, Chair, introduced the committee members. The committee continues to work to support pastors, including a regional presence.
- Church Development Committee. Rev. Matt Elam, Chair, introduced the members of the committee. Ruling Elder Vera Rhimes is coming on as the new Chair in July. Rev. Elam shared about the ministry of the committee, including supporting the Presbytery New Worshipping Communities and New Church Development. Rev. Elam highlighted some items from the written report. New committee members are welcome.
- Personnel. Ruling Elder Scott Eschbach, committee member, reported. The committee completed positive annual reviews of Stated Clerk Sandy Thoits and Accountant Bonnie Boe.
- Committee on Preparation of Ministry (CPM). Rev. David Anderson, Chair, reported that the committee has enrolled two new Inquirers.

Closing Meditation. The Moderator called on Ruling Elder, Moderator Elect Lee Kirkpatrick, to lead a time of Mediation as a closing to the meeting. Elder Kirkpatrick shared an image of a painting "The Prodigal Son" by Rembrandt van Rijn and a poem reflection on the paining from the book "Drawn to the Light" by Marilyn Chandler McEntyre.

Moderator Stephen asked Elder Kirkpatrick to lead the closing prayer. The meeting adjourned at 11:40 a.m.

Recommendation on Plan for Parity

Recommendation on Plan for Parity between Teaching Elders and Ruling Elders at Presbytery Meetings
For Presbytery Approval – May 15, 2021

Effective as of the September 18, 2021 Presbytery Meeting

Note – Plan for Parity between Teaching Elders and Ruling Elders at Presbytery Meetings was last approved by Presbytery on May 18, 2019.

General Provisions:

G-3.0301 of the Book or Order: THE PRESBYTERY - Composition and Responsibilities.

The presbytery is the council serving as a corporate expression of the church within a certain district and is composed of all the congregations and ministers of the Word and Sacrament within that district. The presbytery shall adopt and communicate to the sessions a plan for determining how many ruling elders each session should elect as commissioners to presbytery, with a goal of numerical parity of ministers of the Word and Sacrament and ruling elders. This plan shall require each session to elect at least one commissioner and shall take into consideration the size of congregations as well as a method to fulfill the principles of participation and representation found in F-1.0403 and G-3.0103. Ruling elders elected as officers of the presbytery shall be enrolled as members during the period of their service. A presbytery may enroll, or may provide by its own rule for the enrollment of, ruling elders during terms of elected service to the presbytery or its congregations. (Emphasis added).

Presbytery of Santa Barbara Standing Rules 2.10 MEMBERS:

The members of the Presbytery consist of all teaching elders duly enrolled, ruling elders elected as officers of the Presbytery during their period of service and, at least two ruling elder commissioner elected by church session in accordance with G-3.0202a, and enrolled at a Presbytery meeting, with the following additional provisions: ENROLLED: At a Presbytery meeting, Ruling Elders elected by session as commissioners shall be enrolled as voting member commissioners of the Presbytery upon the filing an enrollment card with the Stated Clerk whereon the person certifies their election. Said card shall comprise the roll of the meeting. Chairs of each standing committee, as well as honorably retired members also have voting rights. Corresponding members may have the privilege to deliberate and advice, but will have no vote. Honorably retired teaching elders who have not attended a meeting of Presbytery in the past year will not be included in establishing a plan for parity between teaching and ruling elders at a meeting of the Presbytery.

The Stated Clerk recommends that Presbytery <u>approve</u> the following method of correcting any imbalance of Ruling Elder Commissioners to Teaching Elders of the Presbytery at Presbytery Meetings, based on Section 2.10 of the Presbytery Standing Rules and G-3.0301 of the Book of Order:

The members of the Presbytery shall be:

- A. All teaching elders and commissioned ruling elders duly enrolled and when Presbytery meets, including honorably retired members;
- B. Ruling elders elected as officers of the Presbytery during their period of service;
- C. Chairs of each Standing Committee:
- D. Each church, regardless of the size of the congregation, shall be represented by two ruling elders commissioned by the Session and duly enrolled at the Presbytery Meeting, with the following additional provisions:
 - 1) For churches with membership under 200, no additional ruling elder commissioners
 - 2) For churches with membership of 200-400, one additional ruling elder commissioner
 - 3) For churches with membership of 400-600, two additional ruling elder commissioners
 - 4) For churches with membership over 600, three additional ruling elder commissioners

Annually, the Stated Clerk of the Presbytery shall ascertain the number of resident Teaching Elders who are members of Presbytery and the number of Ruling Elders which the churches are entitled to send as commissioners to Presbytery Meetings pursuant to this recommendation. The Stated Clerk shall bring any imbalance to the attention of the Presbytery at its May Stated Meeting.

Application of this Recommendation for Presbytery as of the May 15, 2021 to take effect as of the September 18, 2021 Meeting:

As of May 15, 2021, there are 89 Teaching Elder members of Presbytery, 45 of these are honorably retired. Of these honorably retired members, 7 have actually attended a Presbytery meeting in the past year. In accordance with the Standing Rules, honorably retired teaching elders who have not attended a meeting of Presbytery in the past year will not be included in establishing a plan for parity between teaching and ruling elders at a meeting of the Presbytery: 45 - 7 = 38. This leaves a potential attendance of Teaching Elders: 51 (89 - 38 = 51) Teaching Elders.

RATIONALE for Assignment of Ruling Elder representation to Presbytery. In order to serve compliance with the Book of Order requirement that the size of congregations be considered in determining how many Ruling Elders each Session should elect as commissioners to Presbytery, a method of proportional representation based on membership

is recommended in this proposal, as shown in the Chart below. The potential attendance of Teaching Elders per the formula in 2.10 of the Standing Rules **(51)** compares to the maximum possible Ruling Elder attendance **(60)**.

Objectives: (1) Create an opportunity for parity in numbers of Ruling Elder and Teaching Elder representatives at Presbytery, (2) Follow the Book of Order and Presbytery of Santa Barbara Standing Rules minimum guidelines, (3) Allow each church to have at least two ruling elder representatives as required by the Presbytery Standing Rules, while not disenfranchising members in larger churches.
