The Mission of the Presbytery of Santa Barbara:

We, the PCUSA churches and ministries of Ventura, Santa Barbara, and San Luis Obispo counties, join together to foster vibrant worshipping communities who proclaim and live out the love of Jesus Christ for one another and our neighbors.

The 474rd Stated Meeting of the Presbytery of Santa Barbara, Presbyterian Church (USA) was convened on May 14, 2022 at 9:30 a.m., by Moderator Ruling Elder Lee Kirkpatrick, who opened the meeting with prayer.

Hybrid Presbytery Meeting with attendance by commissioners and Presbytery Members:

- At Monte Vista Presbyterian Church, Newbury Park (In Person attendance), or
- Via Zoom audio/video teleconference call platform (Online attendance)

Roll was taken by:

- In Person: Determined at Monte Vista Presbyterian Church, Newbury Park, by Registration Cards and sign in sheets filled out by presbyters and submitted to the Stated Clerk at the physical location of the meeting.
- Online Zoom: Determined by pre-meeting online Zoom registration and video confirmation of attendance during the Meeting, confirmed by the Stated Clerk.

Moderator Kirkpatrick introduced Ruling Elder John Losey, from Monte Vista Presbyterian Church, acting as administrator host for the Zoom online meeting platform. RE Losey explained the functions on Zoom, including voting. Presbyters were instructed to vote on Zoom by checking the green check mark for "yes" and the red X mark for "no." The In Person attendance site for the meeting was held in the sanctuary at Monte Vista Presbyterian Church, Newbury Park. The Moderator announced information regarding the room set up for the meeting, including locations of the podium, microphones available for Presbyters, video screens and restrooms.

Stated Clerk, Sandy Thoits, confirmed the presence of a quorum of the TE and RE Commissions, counting both the attendance In Person and the attendance on Zoom. In Person attendance only: The Stated Clerk determined that a quorum was not established of RE Commissioners registered and attending the meeting at the In Person site only (without including RE Commissioners attending by Zoom). The Presbytery Standing Rules specify the quorum of RE Commissioners at a Presbytery meeting is: No fewer than 10 ruling elders representing at least one-third (1/3 = 7) of the 10 congregations. S.R. 2.23. Only 6 congregations were represented by Ruling Elder Commissioners at the In Person meeting site.

Installation of Moderator, Rev. Sean Chow. Moderator RE Lee Kirkpatrick introduced Rev. Sean Chow, Moderator- Elect, to be installed as Presbytery Moderator for the coming year (9/17/22 - 9/9/23). RE Kirkpatrick asked the Installation Questions of Rev. Chow. Rev. Chow answered the questions in the affirmative. RE Lee Kirkpatrick presented the ceremonial cross and Moderator's gavel to Rev. Chow. Presbytery members prayed for and affirmed their support of Rev. Chow in this office and ministry.

Installation of Moderator-Elect, CRE Diane Kirkpatrick. Moderator Rev. Sean Chow, introduced CRE Diane Kirkpatrick, to be installed as Presbytery Moderator-Elect for the coming year (9/17/22 – 9/9/23). Rev. Chow asked the Installation Questions of CRE Diane Kirkpatrick. CRE Diane Kirkpatrick answered the questions in the affirmative. Presbytery members prayed for and affirmed their support of CRE Diane Kirkpatrick in this office and ministry.

Acknowledgement of Outgoing Moderator. Rev. Janet Loughry expressed appreciation and gratitude for the outgoing Moderator, RE Lee Kirkpatrick, who served faithfully and will continue to serve the Presbytery as the Chair of Presbytery Council. Rev. Loughry then offered a prayer.

Moderator Rev. Sean Chow asked for the Introduction of First Time Ruling Elder Commissioners: RE Jane May-Ahearn, Summerland; RE Marcia Reed, Moorpark.

Introductions and Seating of Corresponding Members: Rev. Shawn Kang, PC(USA) New Worshipping Communities, member of New Covenant Presbytery.

Motion to grant privilege of the floor to Corresponding Members, Committee Members, Candidates Under Care and Inquirers. **Approved**

Motion to Adopt the Agenda (Revised Tentative Agenda) as distributed.

Report of the Stated Clerk. Stated Clerk Sandy Thoits referred to the written Stated Clerk Report and Consent Agenda distributed for this meeting and attached as **Attachment 1** to these Minutes.

The May 14, 2022, Presbytery Minutes were approved with the Consent Agenda.

Report from Designated General Presbyter Search Committee. Rev. Sean Chow, Chair

 Description and Outcome of Committee Process. Rev. Chow reported and described the background and steps taken in the process. The Ministry Information Form (MIF) was completed and posted in December 2021. The application period was 90 days. Applications were received from 17 applicants. There was a diversity of applicants and COR guidelines were followed. Interviews took place with 6 candidates, with a diversity of candidates. Interviews took place by Zoom, for 1 hour interviews for each candidate. The committee determined to advance and interview 3 of the candidates in person. The Synod rules for the process were followed. Rev. Chow called upon two committee members, RE Karen Washburn and Rev. Jon Saur, to report on their experiences with the process and the candidate. The committee then selected one of the candidates to present to Presbytery for election at this meeting: Rev. Jason Micheli

- Affirmation from Committee Members. Rev. Chow expressed gratitude and thanks for the Search Committee members, their faithful service, discernment and giving of their time and energy Committee Members: Rev. Garrett Andrew, Rev. Ted Brandt, Rev. Sean Chow, Rev. Jenifer Fraser, Rev. Jon Saur, RE Tamara Skov, RE Karen Washburn. Alternates participated throughout the process: CRE Kristy Clark, Rev. Bob Crouch. Synod Representative, Rev. Mark Hong.
- Introduction and Invitation to Speak: Candidate, Jason Micheli. Rev. Chow introduced Rev. Jason Micheli to Presbytery. Rev Micheli spoke to Presbytery and shared about his background, education, experiences in ministry, and his outlook for serving as Designated General Presbyter, and getting to know Presbytery members, staff and churches.

Presbytery Adjourned for a time of Worship, Music and Prayer.

- Music. O Worship the King. King of Heaven. Music offering provided by the Monte Vista Worship Team
- Scripture Reading. Rev. Tom Stephen read from Romans 8:26-39, Matthew 13:31-33; 44-52.
- Meditation. Rev. Jason Micheli preached on the topic of the Kingdom of God becoming a reality to us and considering our part in ushering in God's Kingdom.
- Prayer. Rev. Mickey Fenn offered the closing prayer of thanksgiving.

Continued Report of DGP Search Committee. Rev. Sean Chow continued with the report from the Designated General Presbyter Search Committee and nomination of Rev. Jason Micheli.

- Examination for Presbytery Membership. Rev. Jarrett Johnson, COM Chair, reported the Committee on Ministry met with Rev. Jason Micheli. Rev. Johnson announced the Committee's recommendation for Presbytery to examine Rev. Micheli for membership in the Presbytery of Santa Barbara. Rev. Micheli is currently a minister member in good standing in Los Ranchos Presbytery. Rev. Micheli shared about his faith background and call to ministry. He then read his Statement of Faith.
 - Presbyters then asked questions of Rev. Micheli related to his background, service in the church, interests, plans and other topics related to serving as the Designated General Presbytery. Rev. Micheli answered the questions from presbyters.
 - O A Motion to cease examination was then made, seconded and approved. Rev. Micheli was excused from the room. Discussion by Presbyters. It was then moved and approved that Rev. Jason Micheli be received into membership and enrolled as an active member of the Presbytery of Santa Barbara as of September 19, 2022, and upon his dismissal from Los Ranchos Presbytery.
- Motion from DGP Search Committee. Rev. Sean Chow asked Moderator Elect Diane Kirkpatrick come forward to moderate this item. Rev. Sean Chow, on behalf of the DGP Search Committee, presented a motion from the Committee as follows: Motion to elect Rev. Jason Micheli as the

Designated General Presbyter of the Presbytery of Santa Barbara beginning on September 19, 2022, at the terms of call provided with the reports for this meeting.

- o CRE Moderator Elect Diane Kirkpatrick read the Terms of Call:
 - This is a ¾ time Designated Exempt Position for 2-4 years with the ability to become the General Presbyter. The DGP position has some requirement for in office meetings (frequency to be determined by the Personnel Committee and Rev. Micheli)
 - Salary \$75,000
 - Travel/ Professional Expenses (or equivalent) \$6,000
 - Full Board of Pension participation
 - Pro- rated ¾ time vacation and continuing education
- Motion from DGP Search Committee to approve the Terms of Call. Approved (unanimous).
- Election of Designated General Presbyter & Installation.
 - CRE Moderator Elect Diane Kirkpatrick announced the Motion for Election. Motion to elect Rev. Jason Micheli as the Designated General Presbyter of the Presbytery of Santa Barbara beginning on September 19, 2022, at the approved Terms of Call. CRE Diane Kirkpatrick asked for questions or further discussion from Presbyters. None. CRE Kirkpatrick asked for requests for a paper ballot. No requests for paper ballot were made. Vote by raised hands was announced. Motion Approved (unanimous)
 - Rev. Micheli returned to the room and Presbyters welcomed him and asked for God's blessing on his ministry.
- <u>Installation</u>. Moderator Sean Chow presented and read the Installation Questions to Rev, Micheli, which were answered in the affirmative by Rev. Micheli. Moderator Elect Diane Kirkpatrick asked Presbyters to acknowledge their acceptance, assurance and prayers for Rev. Micheli as he serves as the Designated General Presbyter, chosen by God through the voice of the presbytery. Affirmed.
- Prayer. Rev. Tom Stephen. Rev. Stephen asked Presbyters to come forward for laying on of hands for Rev. Michelli. Rev. Stephen then prayed for Rev. Micheli, his ministry, his family and the Presbytery.
- Dismissal and Appreciation of Search Committee. Rev. Janet Loughry read the names of the Search Committee and expressed gratitude to Presbytery members and the members of the Search Committee. Rev. Loughry offered a prayer of gratitude for God's presence and guidance throughout the process and moving forward.

Report of Presbytery Council. Ruling Elder Lee Kirkpatrick, Chair of Council reported. He encouraged ruling elders and ministers to consider serving on Presbytery Committees.

Treasurer's Report. Ruling Elder Scott Eschbach, Treasurer, reported, RE Treasurer Eschbach acknowledged and expressed gratitude for the exceptional work of Presbytery Accountant Bonnie Boe, who keeps track of all the numbers, prepares the checks and the financial reports. A written detailed financial report is included in the reports distributed for this meeting. RE Eschbach highlighted and explained some of the items from the written report: Statement of Financial

Position and Statement of Activities. The 2020 draft audit has been received from the Presbytery CPA firm. The completed audit is expected to be presented to Presbytery at the next Presbytery Meeting.

Committee of Three. Ratification of Amendments to Presbytery Standing Rules and Bylaws for Electronic and Teleconference Meetings and Voting; Ratification of Actions taken at **Presbytery Meetings.** Stated Clerk Sandy Thoits reported on the status of the process to update and amend the Presbytery Standing Rules and Bylaws, specifically for Zoom and hybrid Presbytery and committee meetings. These amendments are recommended by the Presbytery's attorney. In order to vote on the ratification, there must be a quorum of Teaching Elder and Ruling Elder commissions on site at the In Person location of the Presbytery Meeting. (A quorum to vote on these amendments cannot be based on the Zoom attendance). Section 2.23 of the Standing Rules sets the quorum at: No fewer than 10 Teaching Elder members AND 10 Ruling Elders representing at least 1/3 of the congregations, which is 7 churches (20 churches x 1/3 = 6.33 (7)). The Stated Clerk announced the need to confirm the in person attendance and read the names of registered Ruling Elder Commissioners present in person. The Stated Clerk determined that the *in* person quorum for Ruling Elder Commissioners was not met. The Stated Clerk announced that vote on Ratification of Amendments is deferred to the next Presbytery Meeting. The Stated Clerk requested ministers and Ruling Elder Commissioners to attend the next Presbytery Meeting in person so that Presbytery can complete the Amendment process.

The Moderator recognized a Presbyter, who made a **Motion** to move the Report from the 225th General Assembly and the 1001 New Worshipping Communities Report to the end of the Agenda. **Approved**

Committee Reports

- **CORN.** Rev. Janet Loughry.
 - Nominations and Elections of Committee Members. Reverend Loughry, Chair of CORN, referred to the written Nominations Report with the Committees listed, which was provided with the packet of reports for this meeting. COR guidelines were followed. New nominations to be voted on for this meeting are indicated by the Yellow Highlights. Rev. Loughry asked for nominations from floor, none given. Rev. Loughry explained that the Report includes the listing of the Standing Rules to be set aside. Presbytery's vote on the Nominations report includes a vote to set aside the Standing Rules as listed on the report.

Motion to elect the persons nominated as listed on the Nominations Report (Attachment 2 to these Minutes), including Committee Chairs, and to approve setting aside the Standing Rules as listed in the Nominations Report. **Approved** (unanimous)

- Committee on Ministry. Rev. Jarrett Johnson reported that the Summerland Presbyterian Church has hired Rev. Steve Jacobsen as its Interim Pastor. Rev Johnson then reported the following minster changes:
 - Rev. Garrett Andrew, Nipomo Community Pres. Church. The congregation at Nipomo, on August 14, 2022, approved to move Rev. Andrew from the position of Designated Pastor to called and installed Pastor.
 - Ojai Presbyterian Church will have and Installation Service on September 18, 2022 for Anthony Jones, to be ordained as a Minister of Word and Sacrament, and Installed as Associate Pastor for Youth.
 - o Motion to Dismiss Rev. Erik Wiebe to Presbytery of San Gabriel. Approved

- Church Triumphant. Rev. Johnson recognized the passing and ministry of Rev. Aahmes E.
 Overton, Phd, (1941-2022)
- Personnel Committee. Election of Stated Clerk. RE Karen Washburn. Chair of the Personnel
 Committee reported that the committee recommends to Presbytery the re-election of RE Sandy
 Thoits as Stated Clerk, with recommendation of a 2-year term. RE Washburn reported that the
 Presbytery Standing Rules specify a five-year term for the Stated Clerk. With that in mind, RE
 Washburn read two Motions from the Committee:
 - Motion to set aside Standing Rule 3.23, specifically the five-year term for Stated Clerk.
 Approved (unanimous)
 - Motion to elect current Stated Clerk, Ruling Elder Sandy Thoits, to a two-year term as
 Stated Clerk of the Presbytery, through September 17, 2024.

 Approved (unanimous)
- Committee on Preparation of Ministry. Election of Exam Reader. Rev. Ron Urzua, Chair, reported that CPM has a recommendation for an Ordination Exam reader for this year. Rev. David Anderson. Motion to elect Rev. David Anderson as Exam Reader for 2022. Approved
- Property & Finance. RE Scott Eschbach reported that the Committee has no further report to add to the Treasurer's report.
- UMB/Front Porch Update & Motion to add Board Member. Rev. Mickey Fenn reported on the recent Board activities. Motion: The combined Front Porch/University Ministries Board moves to add Rev. Jim Pazan as a full member of the Board. Approved. Rev. Fenn gave a reminder about the Front Porch Fundraiser Event on October 15.
- Clergy Support. Rev. Jennifer Fraser, Chair, reported on upcoming workshops for clergy, to be held on Zoom. October 19: Bringing Joy to Nursing Home Folk, leader Rev. Jim Seeber. November 10: All day in person retreat, "Quiet in the Chaos." At FPC Santa Barbara. Leader Rev. Keenan Barber. January program, Rev. Tom Stephen as leader, title "Experiencing the Kingdom of God at a Session Meeting."
- Church in the World Committee. Rev. Matt Elam, Chair, reported. Presbytery in May commissioned Impact teams to Honduras and Turkey A video was shown and several team members shared about their experiences from the trips. Rev. Elam asked for continued prayers for Nita Hanson and the people at God's Hidden Treasures in Ukraine, as they continue to help and pray for each other and others in need in the community.
- Presbyterian Women. CRE Diane Kirkpatrick reported that on November 5, Presbyterian
 Women will be having a Gathering at First Presbyterian Church, Santa Barbara, with Michelle Jackman, motivational speaker.

Report from 225th **General Assembly.** Rev. Jennifer Fraser, RE Jenifer Rabenaldt. Rev. Fraser shared about her experience at the General Assembly in June. She served on a committee putting forth options on how to hold the next General Assembly in 2 years. The committees met in person in Louisville and the plenary meetings were held on Zoom. Rev. Fraser's committee decided that the 2024 General Assembly will have the committee meetings on Zoom and the plenary meetings in person. RE Jenifer Rabenaldt reported (by video) about her very positive experience at the GA. She served on the Moving Forward Committee, which has been working hard for several years on a guiding statement for the PC(USA.)

1001 New Worshipping Communities. Rev. Shawn Kang. Rev. Kang reported that he is the Western and Central Region Associate for 1001 New Worshipping Communities. Rev. Kang shared about the a training event that took placee on September 16th, and about what 1001 New Worshipping Communities is and does. Over 700 New Worshipping Communities have been started by the program to date.

There being no further business, Moderator Sean Chow called upon Rev. Jason Micheli to give the closing prayer. The meeting adjourned at 12:45 p.m.
