Annual Plan

- Full tuition payment is due August 5, 2016, via automatic bank withdrawal processed by the FACTS Tuition Management Company. FACTS will charge an annual \$10.00 fee for their services which will be deducted from your account approximately 14 days after FACTS receives or renews your contract.
- If payment is made on August 5, 2016, a discount will be applied to your total tuition payment.
- To be eligible for this plan, new students must be fully registered by July 5th.
- In addition to the tuition, this plan also includes a **non-refundable** continued enrollment fee of \$550.00 per student for the 2017-2018 school year, which will be processed by FACTS in February 2017. This fee applies to K4-7th grade students only.

- The **non-refundable** continued enrollment fee of \$550.00 per student for the 2017-2018 school year, will be processed by FACTS, in lieu of tuition, in February 2017. This fee applies to K4-7th grade students only.
