MOTHERS MAY ENTER OUR HOME AT ANY POINT DURING PREGNANCY AND STAY WITH US FOR UP TO SIX MONTHS AFTER THE DUE DATE. IN FY2016, GABRIEL NETWORK PROVIDED OVER 5,400 NIGHTS OF HOUSING TO MOTHERS AND CHILDREN, 34% MORE THAN THE YEAR BEFORE. GABRIEL NETWORK PROVIDES A SAFE FAMILY ENVIRONMENT, ENCOURAGING HEALTHIER PREGNANCIES AND BIRTHS. WE ALSO PROVIDE INDIVIDUAL LIFE COACHING TO EACH RESIDENT, SUPPORTING THEIR PROGRESS IN LIFE SKILLS AND HEALTHY RELATIONSHIPS.

THESE CHURCHES FORM ANGEL FRIEND TEAMS, WHICH ARE GROUPS OF TRAINED VOLUNTEERS WHO PROVIDE LONG TERM, IN-PERSON, PRACTICAL, EMOTIONAL, AND SPIRITUAL SUPPORT FOR PREGNANT MOTHERS. IN FY2016, OUR ANGEL FRIEND TEAMS TRIPLED THE NUMBER OF WOMEN AND CHILDREN THEY SERVED, IMPACTING THE LIVES OF 432 OF OUR BROTHERS AND SISTERS ACROSS MARYLAND AND WASHINGTON, DC. THIS GROWTH CAME FROM A SIGNIFICANT ADDITIONAL INVESTMENT IN STAFFING TO BETTER RECRUIT, TRAIN, AND SUSTAIN OUR ANGEL FRIEND TEAMS.
