

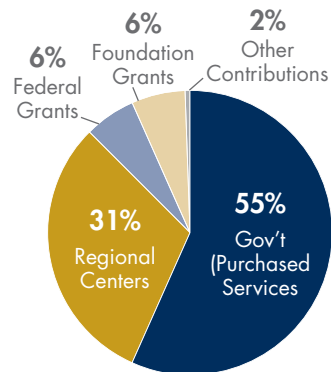

## Bringing Back the Smile...

Over 35 years ago my sister Darlene and I walked into an abandoned nursing facility in East Pasadena. It was to be the home of what we later came to call TLC, which was the acronym of Therapeutic Living Centers for the Blind. A grand name for what was going to become the home for the first residents. The old and decrepit nursing facility had been standing vacant for some time.



It required so much work to make it habitable. The founding families pooled all of their resources and came up with \$5,000, which was the capital that allowed them to secure the property and begin renovations. Having exhausted most of their initial funds, much of the work was done by the parents. And yet they were ecstatic because, for the very first time in their children's lives, they had the hope that they could give them a true home, a place where they could live a full life and be well-cared for and happy.

Most of the first residents had come from either their parents' homes or from placements that provided horribly inadequate care. People and institutions, in their unease, and lack of understanding, largely ignored individuals like our residents. In fairness to them, this was new territory and there just was not any comprehension of their special needs. As the community at large continued to ignore them, the families knew that something had to be done. Quite fitting, then, the parents thought, that an abandoned nursing home to house the children whom many believed had likewise been abandoned and forgotten by the community at large. Most of those original children had forgotten how to smile. The parents' mission was to bring their smiles back.

My purpose in describing these beginnings is to put the achievements, and leadership of TLC in the proper perspective. So many wonderful individuals, whether they were house parents, TLC staff and administrators, the Board of Directors, TLC Foundation Trustees, individual donors, or corporate sponsors have all played a significant part.

*Everyone who is familiar with the development of the infant and young children program at TLC is aware that the Hilton Foundation not only provided major financial support for these and other programs at TLC, but they also gave us so much more support to acquire the tools to become a true leader in the care of the Developmentally Disabled Blind, whether they be newborns, young children, young adults, and our elderly population. Hopefully, it will become TLC's mission to carry the message to other parts of the world who so desperately need to acquire the training and understanding of how to insure that these special individuals are supported and cared for so that they too can live a life to their fullest potential. They deserve the right to enjoy their lives... to be able to appreciate the special joys of life, to be able to smile again.*

## An Update of the TLC Early Intervention Program from Diana Dennis, Director of Children's Programs

As the summer is upon us, it is a delight to look back at the past 3 years and share the recent highlights of our Children's Programs. We want to welcome our new staff including Program Assistant Daniela Villanueva, Speech & Language Pathologist, Patricia Schallert and Physical Therapist, Angie Jedlicka. I'm excited to announce the new position of Sally Walbert as our EIP Outreach Coordinator who has been busy building community partnerships. We are truly gaining momentum in our Early Intervention Program (EIP) as we have developed a dynamic Parent-Professional Advisory Committee, a bi-monthly family group, and an active vision screening program. All the while we continue to provide best practices in our comprehensive home based services to children birth to 5.

Recently, Theresa Lund, one of our parents, facilitated the second Parent Support Group. Theresa has a special touch as she has "been there". As a parent of a child with special needs, she has a deeper understanding where families are at this stage in their new journey. We have learned that having the tools and unique strategies to take care of yourself so you can be present for your child may be the greatest gift of all. Finding time to just love your baby and have fun is critical to working through these difficult times. It is evident that the stresses placed upon caregivers can often make these times seem unimaginable and out of reach, but they can be achieved. Our goal is to provide opportunities for caregivers to develop satisfying relationships with others where they learn to communicate and express emotions in a healthy and positive way.

Lastly, and most importantly, we are thankful to all of the community support and generous donations we've received over the past year. Each day we are looking forward to the construction of the Child Development Center and as our services evolve we are truly building the foundation for the future.

## "If We Fail, Who Will Take Our Place?"

From the Desk of Cyndi McAuley, Executive Director

Each time I prepare an article for a TLC publication, I find myself trying to balance the various aspects of the difficult work we do with the impact our work has on the individuals and families served by our programs. The best way for me to clear out the "Administrator" role is to walk the campus and visit our program participants. It is because of them that we, as staff, are here day in and day out, helping to ensure that our residents and program participants are getting every opportunity to excel and gain their highest level of independence.



This most recent walk led me to the Woman's Club where members of the Mid-Valley Lions Club were hosting a surprise St. Patrick's Day Party for our children's Afterschool program. Everyone - volunteers, children, and staff - had broad smiles on their faces as they decorated hats and enjoyed snacks.

I moved on to the Day Program where the interactions ranged from a touch of the hand to a question about weekend plans, and more pointedly, a question about the California Budget and why the representatives thought it was alright to cut our programs, and even more importantly, what are we going to do about it. It's a reasonable question in light of the cuts being made to services for our constituents, and one that, quite frankly, I find extremely difficult to answer. It's the same question that was posed in a full-page "Los Angeles Times" ad on February 7th by the Coalition of Service Providers, a group of local agencies, including TLC, organized on behalf of our respective program participants, their families and the Lanterman Act.

TLC's mission is to provide LIFETIME care for very deserving individuals and we are being challenged more and more by limited resources. It's imperative that we continue to be pro-active, to educate our family and friends, our elected representatives, and others in our community. We have doubled our efforts to make sure we are heard and recently participated in a letter-writing campaign with agencies similar to TLC. Our goal as an agency was to write 250 letters. Clients, families, and staff sent close to 1,200 letters to Governor Brown as well as members of the Assembly and the Senate, and our colleagues across the state helped us exceed the statewide goal of 100,000 letters by an additional 75,000!

We couldn't begin to do what we do without each of you. Thank you for helping us continue our mission of providing lifetime care for everyone currently in our programs. We want to make sure that we are here for the next generation who need our support and services. We want to ensure that we don't have to answer the question; "if we fail, who will take our place?"

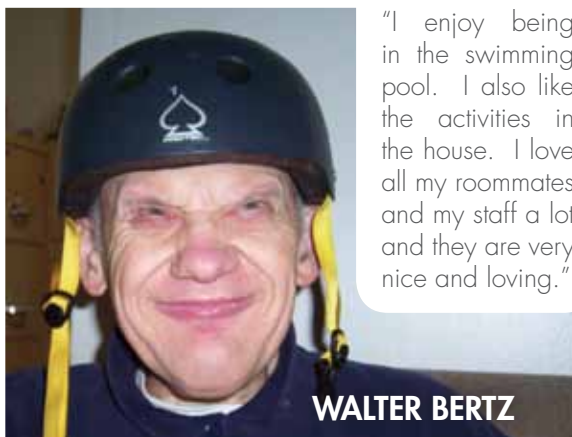

Now Burt and Brandon are frequent visitors to TLC - volunteering 3 times a week - and have made an incredible impact on the lives of everyone they spend time visiting.

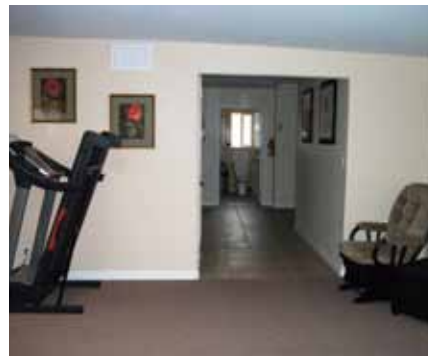

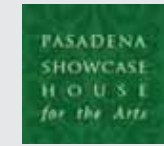
