Many of you will already be aware of the faithful efforts to challenge the Food and Drug Administration's (FDA) new rule allowing drug stores to dispense mifepristone, the first drug in the abortion pill regiment. It is wise for us all to realize that pro-life efforts are likely to be an ongoing battle, since every victory won, as in the Supreme Court's overturning Roe V Wade last year, is likely to be met with new efforts by abortion supporters.

We thank God that 12 states challenged the FDA's recent decision. The Supreme Court then agreed that the changes the FDA made to relax the rules for prescribing and dispensing this drug should be put on hold.

**Sadly, the Justices voted to allow the FDA's ruling to stand. Please continue to pray that God will turn this around by His miracle!**

Clearly, this fight for life must continue on many fronts, and we consider it such a privilege to receive your faithful and generous support.

As you know, our Hispanic ministry completed a very successful marriage-strengthening outreach in recent months, and we plan two seminars a year in the future to meet the need. 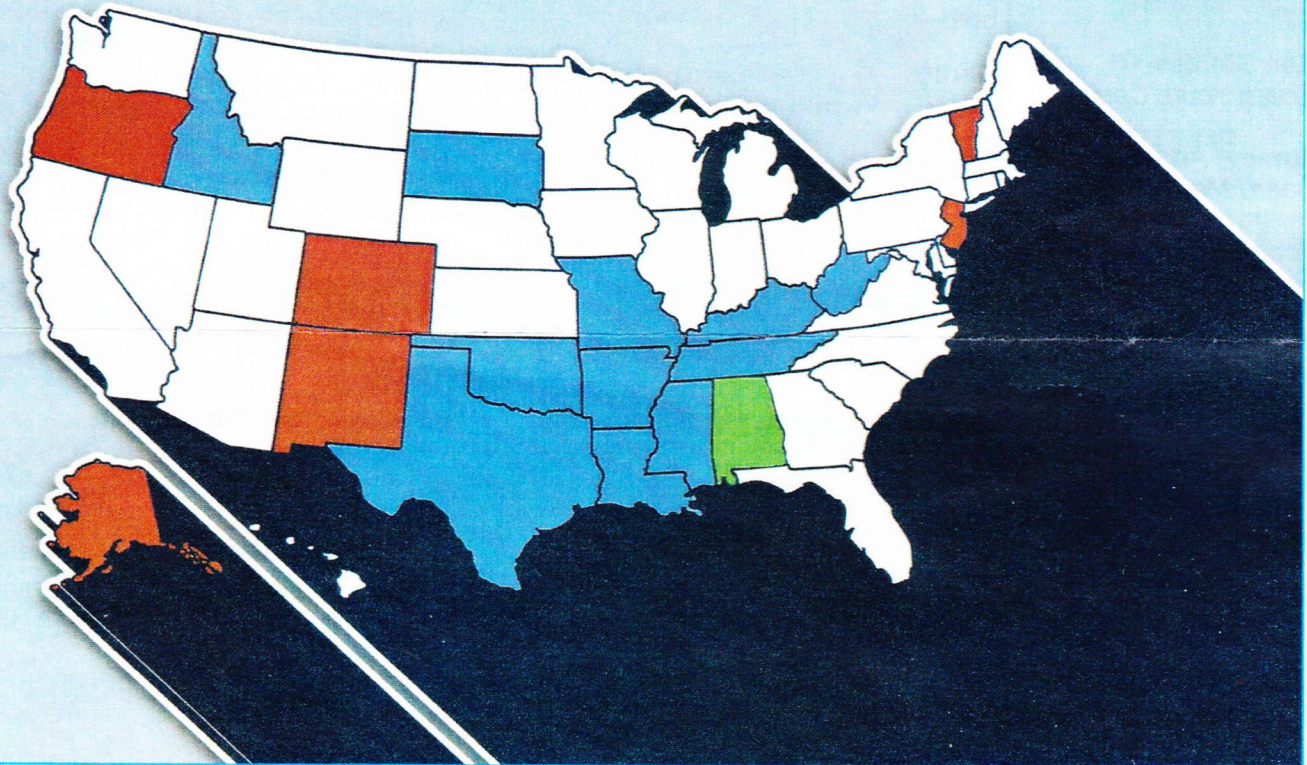

## **ABORTION BAN EXCEPTIONS**

Most states that have banned abortion still have some exceptions in which it remains legal to kill an unborn child. These restrictions usually fit into the following categories:

- 1** Life of the mother is at risk
  - 2** Health of the mother is at risk
  - 3** Baby is not expected to survive
  - 4** Pregnancy was the result of rape or incest.
- Arkansas (life of the mother at risk)
  - Oklahoma (life of the mother at risk)
  - Kentucky (life or health of the mother at risk)
  - Missouri (life or health of the mother at risk)
  - South Dakota (life or health of the mother at risk)
  - Texas (life or health of the mother at risk)
  - Idaho (life or health of the mother at risk or if the pregnancy is the result of rape or incest)
  - Louisiana (life or health of the mother at risk or if baby isn't expected to survive)
  - Mississippi (life or health of the mother at risk or if baby isn't expected to survive)
  - Tennessee (life or health of the mother at risk or if baby isn't expected to survive)
  - West Virginia (life or health of the mother at risk or if baby isn't expected to survive)
