 - a. Alternate concrete mix design for polished concrete (slabs-on-grade) floors for the entire floor area under the mezzanine (separate pour):
 - 1) Concrete to be IDOT C-4WR mix.
 - 2) Provide uniform aggregate gradation of fine, intermediate, and large aggregates.
 - 3) Materials per Iowa DOT standard specification sections 4110, 4112, and 4115.
 - 4) Coarse aggregate to be limestone 3/4" maximum from Martin Marietta Ames Mine Lime Creek ledge (bed 47-49) or approved equal.
 - 5) Fine aggregate must come from a source that limits the quantity of objectionable materials per lowa DOT standard specification sections 4110, 4112, and 4115.
