Seller Information:

Set up will be available beginning from **6-8 pm on Friday, April 24, or 7:30-8:30 am on Saturday, April 25, 2020.**

Sellers must **FIRST** check in at the doorway of the main church building before proceeding to their table for set up. Once checked in, sellers do not need to check in again when arriving for the sale.

Sellers must arrive on Saturday by 7:30 AM if not set up on Friday night. If sellers have set up on Friday night, they must be in the doors by 8:25 AM on Saturday. Doors will lock promptly at 8:30 AM. No refunds will be given for no shows/late arrivals.

From approximately 8:30 AM to 9:15 AM sellers will be allowed to "presale" at each others' tables when seller is present at their table. After that, sellers need to be at their table to sell their items to the outside shoppers.

Seller Expectations

For the sake of other sellers and shoppers, please, no strong scents or perfumed products that could affect allergies or other health concerns. Be aware that health concerns may cause some items to be removed from the sale.

All sellers are expected to stay at their tables until **1:30 PM**. Do **NOT** start packing up prior to the end of the sale as a courtesy to shoppers who may come later. When packing up, please take with you all boxes, bags you brought. We do not have the capability to dispose of empty boxes. The Breakfast with Baby program will gladly accept any clothes, toys, or gear donations you may wish to make from your unsold items.

Sellers are expected to provide their own change, their own bags, and are responsible for the collection and payment of all taxes, which may be due and payable as a result of sales made. Holland Mom 2 Mom Sale will not provide these items. Sellers are also expected to act as their own security for items that they bring to sell. Holland Mom 2 Mom Sale cannot be responsible for any losses, damages, or theft.

A "seller space" is 8x3 ft, or equivalent to the size of an 8 ft banquet table with seating behind. Cost for the space is \$15 if the seller provides their own table, and \$25 if we, Holland Mom 2 Mom Sale, provide the table. Direct Sales Vendors can rent space for a fee of \$30 to participate in the sale. Vendors must supply their own table. We will only allow 1 vendor per direct sales company. The types of vendors allowed at the sale include direct sales companies, home based or craft businesses only. This will be determined by date of received registration. Sellers **must keep their items in the area assigned** to them and not have items protruding out into the walkways where they may cause someone to fall or trip.

Sellers may also rent a 4x3 ft. space (\$5) for a **clothing rack**, which **they must provide** themselves. The rack must fit into the space provided. Additional racks, shelving or other items are not allowed behind the table.

A maximum of two adults (15 & older) per table will be admitted for set-up and running of the table.

If sellers bring children with them to the sale, they are responsible for their own child-care and for keeping the children supervised at their table. Unsupervised children must not be permitted to roam through the sale unattended.

Sellers are responsible for pricing and tagging their own items and arranging them in an attractive and orderly manner. This will help them sell their items.

Large Items

There will be a "large item" area where sellers can place items for \$1.00 per item. Anything larger than 1' x 1' must be placed in the Large Item Room, to maintain clear pathways in the shopping areas, and for greatest visibility, hence sale-ability for items.

PLEASE take the time to think about how many large items you will have and register an estimated number. We cannot GUARANTEE that we will be able to accept more items the day of the sale. Large items MUST be checked into the large item area by 8:30 AM to allow the organizers time to prepare the area.

Sellers are required to provide our volunteers a detailed list of each large item and price during set-up. Large items need to be **clean with working batteries**. We reserve the right to refuse items not in good repair.

Each seller will be responsible for attaching a form with their name, price and description of the item. Forms **will be in seller packets** which you will receive when you register.

No car seats manufactured before 2014 or recalled items. Sellers must sign a form releasing Holland Mom 2 Mom Sale from any responsibility should the seller be found to have sold items that have been recalled.

Please be sure to enter your e-mail address on the form below. This will be our main method of communication if we have to postpone the event due to extreme weather.

Refunds:

The above fees are used to help cover the cost of putting on the sale. Breakfast With Baby and Harderwyk Ministries must assure that these costs are covered before the sale date; therefore, refunds will only be given 7 days prior to sale date or unless the event is cancelled by Harderwyk Ministries or Breakfast With Baby Ministries.

We will gladly refund your money if we cancel the event in some unforeseen circumstance. If you find that you cannot attend the sale, you are more than welcome to find a replacement, and your replacement can reimburse you. Your replacement must fill out this contract as well. We need to have a contract for each seller prior to the start of the sale. We hope you understand why we have this policy.

Lead Law:

NOTICE: THE U.S. Consumer Product Safety Commission has issued a new law on the resale of children's items (for children up through age 12. The new law took effect February 10, 2009. The new law makes it unlawful to sell recalled products or any item that exceeds new lead limits. Resellers need to pay special attention to certain products like, cribs, play yards, children's jewelry, or stuffed toys with small parts. Please go to www.cpsc.gov for more information.

I have been made aware of the law and am not selling any recalled or illegal items to the best of my knowledge. If an item that I sold is found to have been recalled or illegal, it is my responsibility and not the responsibility of any Holland Mom 2 Mom organizers.
