

# Holland Mom2Mom/ Maker's Market Sale

### **Seller/ Sale Information:**

This is an outdoor sale. In case of rain we will hold the event in the Anchor building on the ministry campus. Set up will be available from **7:00-8:30 am on Saturday, April 20, 2024.**

This sale is for those selling their own baby/kids items, crafters, and vendors. It will be held in the parking lot of the church (in case of rain, we will move the event indoors to the Anchor building). Each seller will get 1 – 11ft wide x 20 ft deep parking lot space that you can fill with whatever tables/racks you need to sell your items. All sellers will also keep their large items with them in their assigned space. **If you are selling both Mom2Mom items, and craft items you may rent 1 space for each if you wish.** Cost of a seller space is \$30. If you need to rent a table from us, it is an additional \$10 cost per table with a max of 2 - 8 ft tables per seller. Seller spaces will be marked with a number prior to 7 am the morning of the sale. We will send you your space number by email a couple of days prior to the sale. If we need to move indoors due to rain, the seller spaces will be slightly smaller spaces so we can ensure that there is space for everyone. We will know the exact size of those spaces once we have a final count of sellers. We will notify you by email with that information.

Direct sales vendors – we have a limited amount of space for direct sales vendors. Those spaces are 12 ft wide x 6 ft deep with a cost of \$20 per space. If you are a vendor, please contact us by email prior to sending in this form to confirm availability.

We will have a “presale” for sellers from approximately 8:30 AM to 9:00 AM. To allow this and give everyone as much time for set up as possible, please try to arrive early enough (not before 7 am) so you have time to set your space up.

We will be selling some snack items available for purchase during the sale.

All sellers are expected to stay at their tables until **1:00 PM**. Do NOT start packing up prior to the end of the sale as a courtesy to shoppers who may come later. When packing up, please take with you all boxes and bags that you brought. We do not have the capability to dispose of empty boxes. The Breakfast with Baby program will gladly accept any clothes, toys, or gear donations you may wish to donate from your unsold items for those selling the baby/kids items.

Sellers are expected to provide their own change, and their own bags. Holland Mom 2 Mom Sale will not provide these items. Sellers are also expected to act as their own security for items that they bring to sell. Holland Mom 2 Mom Sale cannot be responsible for any losses, damages, or theft.

If sellers bring children with them to the sale, they are responsible for their own child-care and for keeping the children supervised at their table. Unsupervised children must not be permitted to roam through the sale unattended.

## Refunds:

The above fees are used to help cover the cost of putting on the sale. Breakfast With Baby and Harderwyk Ministries must assure that these costs are covered before the sale date; therefore, refunds will only be given 7 days prior to sale date or unless the event is cancelled by Harderwyk Ministries or Breakfast With Baby Ministries.

We will gladly refund your money if we cancel the event in some unforeseen circumstance. If you find that you can't attend the sale, you are more than welcome to find a replacement, and your replacement can reimburse you. Your replacement must fill out this contract also. We need to have a contract for each seller prior to the start of the sale. We hope you understand why we have this policy.

## Lead Law:

NOTICE: THE U.S. Consumer Product Safety Commission has issued a law on the resale of children's items (for children up through age 12. The new law took effect February 10, 2009. The law makes it unlawful to sell recalled products or any item that exceeds new lead limits. Resellers need to pay special attention to certain products like, cribs, play yards, children's jewelry, or stuffed toys with small parts.
