- Classroom enrollment for each class is small.
- Registration Fee \$95.00.
- Monthly Installment Payment of \$195.00. Families with more than 1 child enrolled will have a discount rate for 2nd child.

CLASS REQUIREMENTS

- Ages are 18 months to 5 years of age.
 - Little Caterpillars - 18 mths. to 3 years old. Children must be 18 mths. by August 1 to enroll. Children must be walking and able to feed themselves.
 - Honey Bees - Children must be 3 & 4 years by August 15 and **COMPLETELY** potty trained.
 - Doodle Bugs - Children must be 4 years by August 15 and **COMPLETELY** potty trained.

Please see our Potty Trained checklist if your child meets the age requirement to be in an older class.

A FAMILY GUIDE

to preparing your child for preschool.

1. **READ** - If we were only allowed to give one piece of advice to families it would be, "Read to your child." Read everyday. Have books in every room, in your purse, and in the car. Read favorite books so often that you and your child have them memorized. Visit the library as often as you can.
2. **TALK** - Developing your child's **oral language skills** is a crucial part of preparing them for preschool. Turn off the movie, phone or ipad and engage your child in a discussion about the world around them. Ask questions. Talk about nature, and colors, and letters, and feelings. Put down your phones and listen when your child talks to you. Encourage your child to make eye contact and greet others with a "Hello" and a "Good Bye."
3. **PLAY** - Spend time every day on the floor **playing** with your child. Encourage pretend play and role playing. Get messy. Laugh and have fun together. Offer your child time to play by themselves, give them the opportunity to decide what to do.
4. **ENCOURAGE INDEPENDENCE** - Children who are able to take care of some of their personal needs do better at the beginning of preschool than children who rely on adults for everything. Make sure to encourage your child to try things for themselves, like putting on shoes, coats or jackets, handwashing, etc. Support your child in taking care of their own bathroom needs when they are potty training. If they ask for help try walking them through it first rather than doing it all for them. These are not glamorous, but these are important independent skills.
5. **PRACTICE** - Give your child time away from you. Practice **separating** and giving your child a little bit of space. Invite other children over for play dates and allow your child to go on short play dates as well.

Registration Fees (non-refundable):
\$95.00 per child

Tuition Installment Payments (non-refundable):
Installments - \$195.00 (1st child)
\$190.00 (2nd child, of the same family)

We are a non-profit ministry of Farragut Christian Church.

We are attempting to keep our fees reasonable.

The Registration Fee is due upon application. All Registration Fees are non-refundable. Registration Fees are for school equipment, operational & class supplies and reservation of your child's enrollment. Parents will also be required to purchase a limited amount of school supplies.

Tuition Installment Payment amount is divided into equal installments (same value each month). Each installment is one-tenth of the total session's tuition and NOT the payment to cover just the month. Tuition Installment Payments is paid in 10 equal payments. Payment is due the 1st of each month (August - May) and is non-refundable.

To ensure that your account is in good standing, we ask that you make your payments in a timely manner. Tuition Installment Payments that are not received by the 5th of each month, will be assessed a \$15.00 late fee. If your account is not in good standing, Farragut Christian Church Mother's Day Out can request your child not return to the program. We do not make adjustments due to illness, vacations, school closings or holidays.

With the signed agreement, I understand and accept responsibility for Installment Payments. I also understand that Registration Fees & Installment Payments are non-refundable.

*For children enrolling in the middle of a session, a prorated Registration Fee will be worked out by the director.

POTTY CHECKLIST

Please complete if your child could be enrolled in one of our older classes. For a child to be in any of our 3 year and up classes they **must meet** the following requirements...

- Must be 3 years old by August 15.
- Must be able to inform teachers that they need & are going to the potty.
- Must be able to take themselves to the potty.
- Must be able to manage their own clothing, with minimum to no assistance.
- Must be able to manage personal hygiene on their own.
- Must be able to wash their own hands.

We do understand that accidents will happen on occasion. However, if a child has consistent accidents (daily or several times a day) they will be moved to our Little Caterpillars class (based on space availability) until they become more consistent in their potty skills.

Dear Parents,

To alleviate any misunderstandings about the licensing regulations in the state of Tennessee for a program such as our Mother's Day Out, we have been asked to have you read the following information and then sign on the designated line.

Such programs are exempt if they meet the following criteria: (7) "Parents' Day Out" or similar programs carried on by churches or church organizations that provide custodial care and services for children of less than school age for not more than two (2) days in each calendar week for not more than six (6) hours each day.
