

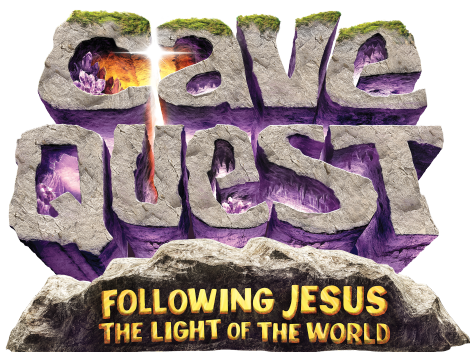

I am the parent, legal guardian, or the care giver who is a relative of, and who, under Section 6550 under the California Family Code, may authorize medical and dental care for Minor. I give permission for Minor to take part in any and or all Children Ministry events and all activities involved with each event between the dates of July 18, 2016 and July 22, 2016. I hereby authorize Grace Community Church, into whose care Minor has been entrusted, to consent to medical or dental treatment or care for Minor under Section 6910 of the California Family Code. The authority granted by this authorization includes the authority to consent to any x-ray examination, anesthetic, medical or surgical diagnosis or treatment, or hospital care under the general or special supervision and upon the advice of or to be rendered by a physician or surgeon licensed under the Medical Practice Act and to any x-ray examination, anesthetic, medical or surgical diagnosis or treatment or hospital care by a dentist licensed under the Dental Practice Act. It is understood that this authorization is given in advance of any specific diagnosis or treatment being required, and is given to provide authority and power to render care which the aforementioned physician, in his or her best judgment may deem advisable. I further authorize Grace Community Church to receive physical custody of Minor under Section 1283(a) of the California Health and Safety Code upon completion of any treatment, and I specifically instruct any treating health facility to surrender the physical custody of Minor to Grace Community Church. I understand the nature of the event and do hereby release, on behalf of myself and Minor, Grace Community Church and its employees, staff and volunteers from all liability or claims arising from or related to the event.
