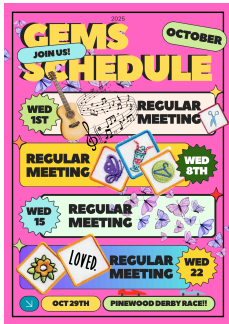

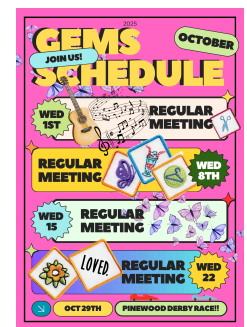

## Library Update

Greetings from your library! We have two NEW books to complete the Lake City Heroes series by Lynette Eason. I also have books to encourage you in your faith walk and be prepared to share the Gospel with your neighbors and non-believers.



**Lake City Heroes** series by Lynette Eason:

#3: Serial Burn: Jesslyn McCormick, the fire marshal of Lake City, is determined to find the person who started the fire that robbed her of her family when she was just seven years old. As the twentieth anniversary of the tragedy approaches, a string of fires--including at Jesslyn's church--brings up all those old feelings and offers new evidence.

#4: Final Approach: FBI Special Agent Andrew Ross and Air Marshal Kristine Duncan thwarts an attempted hijack of the plane they are on. But as the investigation into the incident gets underway, Kristine and Andrew are confused at every step. Nothing about the investigation goes as it should, and each layer they peel back just reveals another layer of perplexity.

The Case for Faith by Lee Strobel: In The Case for Faith, bestselling author, journalist, and former atheist Lee Strobel turns his investigative skills to the most persistent emotional objections to belief in God--the eight "heart barriers" to faith. This bestselling book is for those who may be feeling attracted to Jesus but who are faced with difficult questions standing squarely in their path. For Christians, it will deepen their convictions and give them fresh confidence in defending their faith to skeptical friends, or during the hardest of times, when they have to defend their faith to themselves in moments of doubt.

The Resurrection Factor by Josh McDowell: Does the historical evidence support the resurrection of Jesus Christ? Can the resurrection be proven beyond any reasonable doubt? Josh McDowell spent hundreds of hours over 13 years combing the annals of history. He presents comprehensive and compelling evidence to answer those questions.

Jesus: A Biblical Defense of His Deity by Josh McDowell & Bart Larson: History is filled with men who have claimed they came from God, that they were God, or that they bore messages from God. 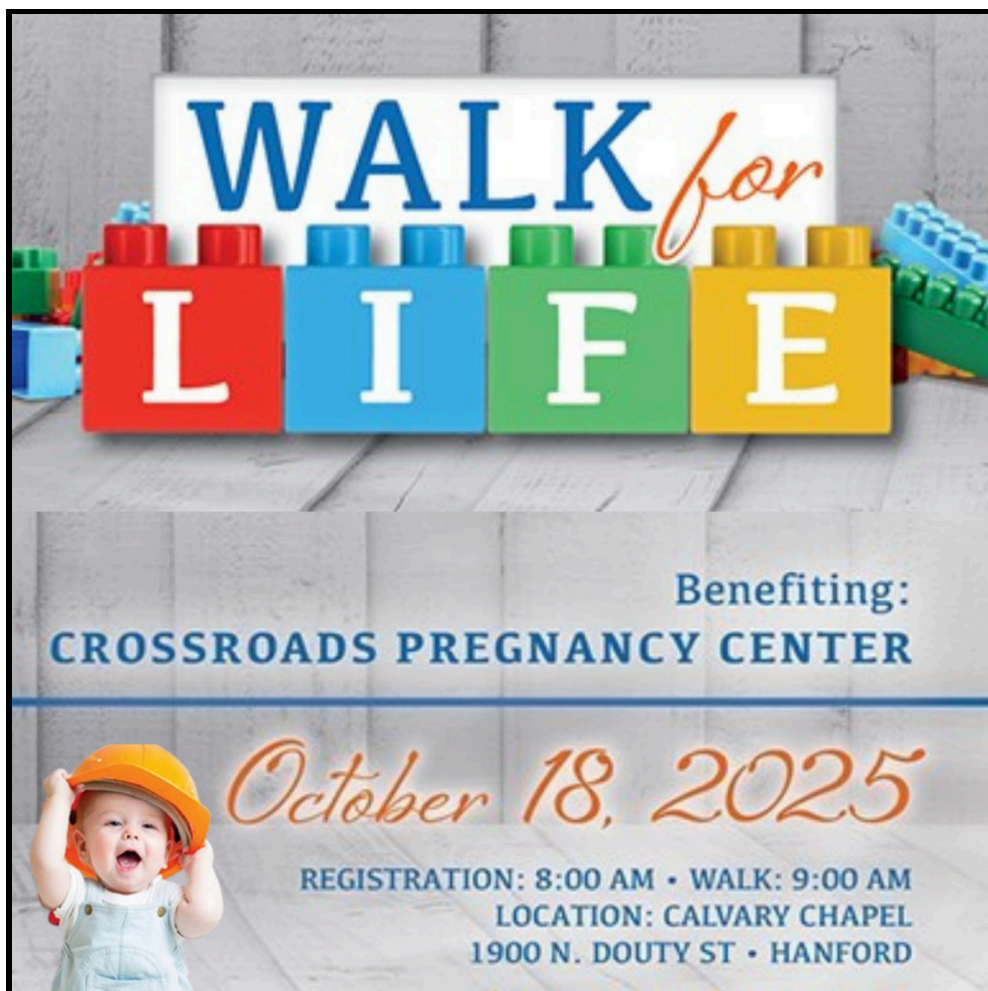
