Library Update

Greetings from your library! We have two NEW books to complete the Lake City Heroes series by Lynette Eason. I also have books to encourage you in your faith walk and be prepared to share the Gospel with your neighbors and non-believers.

Lake City Heroes series by Lynette Eason:

#3: <u>Serial Burn</u>: Jesslyn McCormick, the fire marshal of Lake City, is determined to find the person who started the fire that robbed her of her family when she was just seven years old. As the twentieth anniversary of the tragedy approaches, a string of fires--including at Jesslyn's church--brings up all those old feelings and offers new evidence.

#4: <u>Final Approach</u>: FBI Special Agent Andrew Ross and Air Marshal Kristine Duncan thwarts an attempted hijack of the plane they are on.
