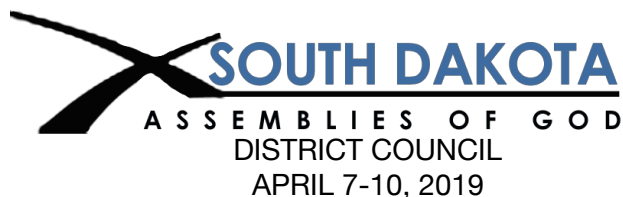

Set up: Set-up begins at 8:30 am on April 8th and must be completed by 11:00 am.

Security and Insurance: SDAG, Rapid City First Assembly, and their respective agents and employees, shall not be responsible for the safety of the property of the Exhibitor and its agents or employees from theft, damage by fire, accident, or any other cause. It shall be the Exhibitor's responsibility to maintain such insurance against personal injury and property damage liability, in such amount as the Exhibitor deems appropriate.

Exhibit Design and Amenities: All exhibits must remain within the confines of their own space, and no Exhibitor will be permitted to erect signs or display products in such a manner as to obstruct the view, cause injury, or affect the display of other Exhibitors. Arrangements for electricity can be made available at no additional charge. Wi-Fi will be accessible to Exhibitors; however, due to constraints of facility, SDAG does not guarantee high-speed Internet access. Any additional expenses incurred in association with special arrangements are the responsibility of the Exhibitor.

Compliance: Exhibitor agrees to adhere to and be bound by all (1) applicable fire, utility, and building codes and regulations; (2) any rules and regulations of Rapid City First Assembly; (3) the terms of all leases and agreements between SDAG and said facility; (4) the Americans with Disabilities Act, to the extent required to make Exhibitor's exhibit accessible to persons with disabilities; and (5) the terms of all leases and agreements between SDAG and any party relating to the Exhibit. Exhibitor shall not do or permit others to do anything in the facility which would in any way increase insurance premiums payable by SDAG or the facility.
