

## **Bible Baptist Church Refund Policy:**

Bible Baptist Church is registered with the IRS as a 501(c)(3), non-profit organization, and making donations to this ministry tax deductible. The IRS requires control of the funds be released to Bible Baptist Church for the donation to be tax deductible. The donor absolutely and irrevocably divests himself of title, dominion and control of the gift. All designations are treated as non-binding suggestions. **Funds that are given as a charitable contribution are non-refundable.**

## **Bible Baptist Church Privacy Statement:**

Bible Baptist Church is committed to protecting your privacy and providing you with a safe online experience. The Privacy Statement applies to the Bible Baptist Church website ([www.bbsav.org](http://www.bbsav.org)) and governs data collection and usage. By using the Bible Baptist Church website, you consent to the data practices described in this statement.

### **Collection of Personal Information**

Bible Baptist Church may collect personally identifiable information, such as, but not limited to, your email address, name, home or work address or telephone number. Anonymous demographic information, which is not unique to you, such as, but not limited to, your zip code, age, gender, preferences, and interests may also be collected.

### **Use of Personal Information**

Bible Baptist Church collects and uses your personal information to operate the Bible Baptist Church website and deliver the services you have requested. Bible Baptist Church also uses your personally identifiable information to inform you of other services available from the Church or its ministries. You may be contacted via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Bible Baptist Church does not sell, rent or lease its customer lists to third parties. The Church does not use or disclose sensitive personal information, such as race, religion, or political

affiliations, without your explicit consent. Bible Baptist Church websites will disclose your personal information, without notice, only if required to do so by law or in good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Bible Baptist Church or the site; (b) protect and defend the rights or property of Bible Baptist Church; and (c) act to protect the personal safety of users, or the public.

### **Security of Personal Information**

Bible Baptist Church secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information is transmitted to other websites, it is protected through the use of encryption, such as Secure Socket Layer (SSL) protocol.
