As a Participant in the activity of paintball and activities organized or conducted by One Hope Canada and Lake Of The Trees Bible Camp (collectively the "Events"), the undersigned, being the Participant and the Parent/Guardian of the Participant (collectively the "Parties") acknowledge and agree to the following terms:

### Disclaimer

2. One Hope Canada, Lake Of The Trees Bible Camp and its directors, officers, committee members, members, employees, volunteers, participants, agents and representatives (collectively the "Organization") are not responsible for any injury, personal injury, damage, property damage, loss of income, or loss of any kind suffered by a Participant during, or as a result of, participating in the activity of paintball and/or in any Events, caused by the risks, dangers and hazards associated with the activity of paintball and/or the Events.

### Description of Risks

3. The Participant is participating voluntarily in the activity of paintball and/or in the Events. In consideration of the Participant's participation in with the activity of paintball and/or in the Events, the Parties hereby acknowledge that they are aware of the risks, dangers and hazards and may be exposed to such risks, dangers, and hazards. The risks, dangers, and hazards include, but are not limited to, injuries from participating in the activity of paintball and/or in the Events:
  - a) Executing strenuous and demanding physical techniques
  - b) Vigorous physical exertion, strenuous cardiovascular workouts and rapid movements;
  - c) Being shot by a paintball
  - d) Failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment
  - e) Contact, colliding, falling or being struck by other participants, equipment or the ground
  - f) Failing to comply with the rules established for participation
  - g) Bad weather conditions including hypothermia, sunstroke, or dehydration
  - h) Failing to remain within designated areas and supervised activities
  - i) Insect bites, stings, etc.
  - j) Blindness, deafness, spinal cord injuries which may render me permanently paralyzed and death
  - k) Travel to and from Events which are an integral part of the Organization's Events
4. Furthermore, I am aware:
  - a) That injuries sustained can be severe;
  - b) That I may experience anxiety while challenging myself during the activity of paintball and/or the Events;
  - c) That my risk of injury is reduced if I follow all rules established for participation; and
  - d) That my risk of injury increases as I become fatigued.

### Release of Liability

5. In consideration of the Organization allowing the Participant to participate, the Parties agree:
  - a) To freely accept and fully assume all such risks, dangers and hazards and possibility of personal injury, death, property damage, expense and related loss, including loss of income, resulting from participating in the activity of paintball and/or the Events; and
  - b) To forever release the Organization from any and all liability for any and all claims, demands, actions and costs that might arise out of the Participant's participation in the activity of paintball and/or in the Events, or from the physical risks associated with same.

6. The Parties acknowledge that they have read this agreement and understand it, that they have executed this agreement voluntarily, and that this Agreement is to be binding upon themselves, their heirs, executors, administrators and representatives.
