In compliance with our church bylaws:

4.3.1(a) The senior pastor and/or chairman of the board, in September, will disburse or cause to be disbursed a letter to all men eligible to serve as director.

4.3.1.(b) Any eligible man sensing Gods call upon his life to serve as a director may submit his name for nomination in response to the letter.

4.3.1.(c) Each request for nomination shall be received by the senior pastor and the board of directors and the eligibility of each candidate shall be established or refused.

4.3.1.(d) Each established nomination shall be interviewed by the senior pastor and the board of directors, resulting in an approved nomination list to be presented to the church for vote two (2) weeks prior to the annual member meeting. (Questionnaire can be used in lieu of personal interviews if time does not permit.)
