Medical Release

In the event that I, the parent/guardian, cannot be reached in an emergency I do hereby authorize the Calvary Baptist Church of Lompoc as agents for the undersigned minor to consent to any procedures which may be performed which may included, but is not limited to: x-ray examination, laboratory procedures, anesthesia, medical or surgical diagnosis or treatment and hospital care which is deemed advisable by, and its to be rendered under the general or special supervision of any physician or surgeon licensed under the provisions of the Medical Practice Act on the medical staff of a licensed hospital, whether such diagnosis or treatment is rendered at office of said physician or at hospital. It is understood that this authorization is given in advance of any specific diagnosis, treatment or hospital care being required but is given to provide authority and power on the part of Calvary Baptist Church to give specific consent to any and all such diagnosis, treatment or hospital care which the aforementioned physician in the exercise of his or her best judgement may deem advisable. This authorization is given pursuant to the provisions of Section 25.8 of the Civil Code of California.

This authorization shall remain in effect through midnight December 31, 2021.

Liability Release

While action will be taken to ensure the safety of your student while they are with us, no activities are without possible unforeseen hazards. It is impossible to list all such activities, but does include participation in recreation games, outdoor activities (including by not limited to water sports, snow sports, ocean/beach activities, boating, hiking, bicycling, high rope adventure courses, rock climbing, broom hockey, ice skating, riding in vehicles driven by the staff, and other church sponsored actives away from the church campus. Accidents, injury and property damage may result from activities that we don't allow or in the normal course of group activity. The intent of this Liability Release is to prevent Calvary Baptist Church and its agents from being held liable for injuries to person and property when students are injured as a result of their being present on our grounds or engaging in an activity away from the grounds. Your signature on this Liability Release constitutes you and your students' agreement not to hold Calvary Baptist Church of Lompoc and its staff, volunteer or paid, liable for damages, losses or injuries of person or property. The parents/guardians and youth understand that this release constitutes a full and complete release from liability and an agreement to hold Calvary Baptist Church and its staff, paid or volunteer, harmless and relieved of any responsibility for injury or damage to your child.
