**PRESCHOOL FINANCIAL POLICY 2018-2019**

**Yearly Registration Fee for New Students:** (per child) is \$100.00. This is non-refundable and is due at the time of enrollment.

**Yearly Registration Fee for Returning Students:** (per child) is \$100.00. This is non-refundable and is due by April 1.

**Summer Registration** is \$35 for a child that is already enrolled and is due by April 1. The fee is \$50 for a student who is attending for the summer session only and is due at time of enrollment. Registration fees are non-refundable.

The registration fees cover the cost of setting up student records, supplies, and membership in the Association of Christian Schools International, etc. If the fee is not received by the dates indicated the student's position may be filled by another student from the waiting list.

Daily Fees: Children that are already enrolled on a daily basis during the regular school year may occasionally stay for an additional morning or afternoon. This can only be done if the Director is aware that there is an opening on that day and has given prior permission. The fee to be charged will be \$30 for a half day and \$40 for a full day.

Summer rates will be given out yearly in March.

**All 2017-2018 school year registration fees and tuition will be paid using FACTS Tuition Management. If you do not have an account with FACTS, you will receive an email invite from FACTS with instructions of how to set up your account. If you already have an account with FACTS you can simply log in to pay registration.**

In recognition of the fact that the First Assembly of God church membership shares part of the costs of operating SCS by providing the school facilities, a tuition credit of 15% will be given to active, tithing (10% undesignated contribution) members and adherents in good standing of First Assembly who have children enrolled at Stockdale Christian Schools. An application is available upon request.

Payments are due on the first of each month. A late fee of \$30 will be assessed to any account if tuition is not paid by the 5th of each month. Returned checks will result in a \$30.00 charge for reprocessing. After two returned checks, tuition must be paid in cash or by money order.

Upon failure to comply with the financial agreement, parents may receive a letter from the school stating that all outstanding balances must be paid for the student(s) to continue in school. S.C.S. reserves the right to refuse academic continuation at the first month's tuition delinquency or if no prior arrangement has been made with the administrator.

The preschool program offered at Stockdale Christian Schools is funded on a strict operating budget. For the school to maintain fiscal stability, it is important that each family responsibly remit tuition payments on a timely basis.

## **TIME**

Preschool hours are 7:00 AM to 6:00 PM. Children not picked up by 6:00 PM **SHARP** will be charged a **minimum** of \$5 and \$1 per minute after 5 minutes. This amount will be added to your monthly statement or may be paid and receipted the same day. Children in the half day session must be picked up by 12:30 PM. A fee of \$20 will be charged if your child is picked up past this time.

## **MAKE-UP DAYS**

Make-up days are not allowed due to the number of children enrolled each day. The State of California requires that we enroll no more students than our licensed capacity. Tuition credit for **extreme** illness will be at the discretion of the Administration and School Board.

## **IMPORTANT NOTICE**

Children who attend Stockdale Christian Preschool are not guaranteed admission into Stockdale Christian School. They must go through the application and interview process. Children do not automatically go from the SCS Preschool to the SCS Elementary School. Those who have applied to the SCS Elementary or Preschool are considered for enrollment with the following priorities.

1. Brothers and sisters of students already attending Stockdale Christian Schools. (Elementary & Preschool)
2. First Assembly of God church member's children. (Elementary & Preschool)
3. Christian families who regularly attend a church in agreement with our Statement of Faith and Meet the application requirements. (Elementary & Preschool)
4. All other applications on the waiting list are set up according to the date that they were submitted. (Preschool ONLY)

## **WITHDRAWAL FROM SCHOOL**

All parents wishing to drop their child from the preschool must give the preschool a two-week notice, in writing. If you do not give the written two week notice, you will be required to pay the full month's tuition.
