Payment of Tuition and Registration

Monthly tuition is due on the 1st of each month. All tuition & registration fees must be paid through FACTS Tuition Management.

Delinquent Tuition & Fees

Upon failure to comply with the financial obligation to the school, parents may be contacted by school personnel stating that all outstanding balances must be paid for the student(s) to continue to attend school. SCS reserves the right to refuse academic continuation at the first month's tuition delinquency if no prior arrangement has been made. Furthermore, student(s) whose accounts are delinquent may not participate in field trips or extracurricular activities.

Registration Fee

Covers the cost of the following:

- ♦ Some electives (7th and 8th grade only)

Tuition Refund Policy for Paid-in-Full Tuition

Semester 1 tuition

- ♦ June 1-August 14—75% of 1st Semester tuition & all of 2nd Semester tuition
- ♦ August 15-October 20—50% refund of 1st Semester tuition & all of 2nd Semester tuition
- ♦ October 20-end of Semester 1—no refund of 1st Semester tuition, but a refund of 2nd Semester tuition.

Semester 2 tuition

- ♦ Prior to December 1—100% refund of 2nd Semester tuition
- ♦ December 1-January 8—75% refund of 2nd Semester tuition
- ♦ January 9-March 9—50% refund of 2nd Semester tuition
- ♦ March 10—end of school year—no refund
