FINANCIAL CONTRACT for the 2019 – 2020 School Year

Mr./Ms./Mrs. _____ agrees that as the parent or guardian of

_____, I am responsible to pay Miramonte Christian School (hereafter called "Miramonte") the application fees, registration fees, tuition charges, and all other related costs that my child(ren) incur while attending Miramonte during the 2019 – 2020 school year. I understand and agree that:

- Application fees are paid prior to my student(s) being enrolled
- Enrollment fees are paid prior to school starting and before my student(s) begin classes
- Tuition payments are due by the 15th & past-due on the 20th of each month
- There will be a late charge of \$25.00/account for each month payment is overdue
- All expenses are to be paid within 30 days of invoice
- My child(ren) will not be allowed to continue attending Miramonte if my payments are overdue beyond 60 days, unless an acceptable payment plan is created and approved by the principal. Each part of the payment plan must be completed on time.
- Returned checks are subject to an NSF charge of \$30.00, if applicable, I must then pay by cash, cashier's check, credit card or money order
- After School Care charges, instrument rental fees, after school sports programs, and other special classes/services/clubs are additional charges that are due and payable at the time of the charge;
- In the event that my child(ren) is/are no longer attending Miramonte:
 1. I have an obligation to pay off my total account balance within 60 days of my child(ren) withdrawing from Miramonte;
 2. If I fail to pay off my account balance within 60 days of my child(ren) withdrawing from Miramonte, I am responsible for any and all costs that Miramonte may incur in attempting to collect my debt.

I have read the financial policies as outlined in the current Miramonte student handbook and agree to comply with the procedures in the following manner.

- I will pay before the 15th of each month, for 10 months from August, 2019, through May, 2019, the monthly tuition of \$_____, plus my child(ren)'s aforementioned additional charges.
- I will pay at the beginning of each semester – by August 20, 2019 and by January 20, 2020 – the semester tuition of \$_____. In addition, I will pay by the 15th of each month, my child(ren)'s aforementioned additional charges.
