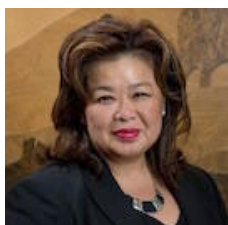
Michael McAllister has been named president while **Greg Givens** has been appointed chief operating officer of **Encana Corporation**. In addition, **Brendan McCracken** has
