# Resolutions and Petitions Resolutions

# A. Regular

#### 1. Prayer

WHEREAS, JESUS is The Supreme Model of praying to GOD THE FATHER (Matthew 6:9-13; Luke 5:12-16; John 17:1-26), and

WHEREAS, JESUS paid the price of time of praying to GOD THE FATHER, morning and evening (Mark 1:35; Luke 6:12), and

WHEREAS, the praying of JESUS TO GOD THE FATHER shows victories in The Kingdom of God (Matthew 14:19-21; Mark 5:1-20; John 11:38-45), and

WHEREAS, JESUS shows us to be persistent in praying to GOD THE FATHER (Matthew 7:7-11; Luke 18:1-8), and

WHEREAS, THE HOLY SPIRIT and JESUS pray to GOD THE FATHER in our behalf (Romans 8:26; 8:34), and

WHEREAS, faithful praying by the disciples of JESUS, His mother, His brothers, and some devoted women helped to spark a flaming Pentecost and powerful Church (Acts 1:12-14; 2:1-47), and

WHEREAS, praying to GOD THE FATHER as JESUS prayed is a way of showing dependence upon the HOLY SPIRIT (Luke 4:1-5), and

WHEREAS, Bishop James E. Swanson, Sr would welcome our prayers for his many needs and for his family, and

WHEREAS, all our clergy with their families, all our laity with their families, and all our children and youth are standing in need of praying, and

WHEREAS so many of our clergy, congregations and communities are struggling for the devastation of flooding and storms, and

WHEREAS, the vital power of prayer has long been a tradition and discipline of all of those clergy and lay whose lives have been influenced by Rev. Johnny A. Dinas, who historical has presented this petition,

#### THEREFORE BE IT RESOLVED:

- 1. That we continue our 12:00 o'clock noon daily prayer time for The United Methodist Church in Mississippi and beyond; whether our prayers are several seconds, minutes or longer in THE NAME OF JESUS: and that we depend upon THE HOLY SPIRIT to direct us in our praying for THE BODY OF CHRIST, and
- 2. That we earnestly ask our HEAVENLY FATHER'S help for the continued recovery and restoration of our brothers, sisters, youth, children, and churches effected by the many storms, and
- 3. That we ask our pastors to inform The Church briefly from time to time about the 12:00 o'clock hour, urging their praying, and
- 4. That any time during the last two weeks prior to Annual Conference each pastoral charge have some type of prayer meeting GLORIFYING GOD THE FATHER, GOD THE SON, AND GOD THE HOLY SPIRIT: asking His help as we face Annual Conference with faith, hope, and love; and to give power to live the life of CHRIST in the world.

# 2. Housing/Rental Allowance For Retired and Disabled Ministers

WHEREAS, the religious denomination known as The United Methodist Church has and functions through ministers of the Gospel who are ordained or licensed; and

WHEREAS, the practice of The United Methodist Church is to provide a parsonage or a rental allowance as part of the gross compensation for each of its active ordained or licensed ministers; and

WHEREAS, pensions paid to retired and disabled ordained or licensed ministers of The United Methodist Church are considered as deferred compensation and are paid to said retired and disabled ordained or licensed ministers in consideration of previous active service; and

WHEREAS, the Internal Revenue Service has recognized that the Mississippi Annual Conference is the appropriate organization to designate a housing/rental allowance for retired and disabled ordained or licensed ministers who are members of this conference;

NOW THEREFORE BE IT RESOLVED:

- 1. An amount not to exceed 100 percent of the pension payments received during the year of 2020 be and is hereby designated as a rental/housing allowance for each retired and disabled ordained or licensed minister of The United Methodist Church who is or was a member of the Mississippi Conference at the time of his or her retirement:
- 2. This rental/housing allowance shall apply to each retired and disabled ordained or licensed minister who has been granted the retired relation or placed on disability leave by the Mississippi Conference and whose name and relationship to the conference is recorded in the Journal of the Mississippi Conference and in other appropriate records maintained by the conference;
- 3. The pension payment to which this rental/housing allowance applies shall be the pension payment resulting from all service of such retired and disabled ordained or licensed minister from all employment by any local church, annual conference, or institution of The United Methodist Church, or of any former denomination that is now a part of The United Methodist Church, or from any other employer who employed the minister to perform services related to the ministry and who elected to make contributions to the pension funds of The United Methodist Church for such retired minister's pension.

# 3. Petition On Human Sexuality (Subtitled: Petition Concerning the Practice of Homosexuality)

WHEREAS, this has been the third consecutive year that the Mississippi Annual Conference has been presented similar petitions on human sexuality without any of the petitions being voted on; and

WHEREAS, the 2019 General Conference meeting in session in St. Louis, Missouri, from February 23-26, passed the Traditional Plan, which upheld the 2016 Discipline's language regarding human sexuality; and

WHEREAS, the Biblical stance on the practice of homosexuality will be a continuing battle in years ahead, I petition the 2019 Mississippi Annual Conference to makes its stance known by the passage or non-passage of the following petition on human sexuality:

WHEREAS, the Scripture contained in the Old and New Testaments is the final authority that establishes the conditions in which all men and women can have a harmonious relationship with God, our Creator (Genesis 1:26-28; 2:7, 18-25, esp. 24; Matthew 5:17; Romans 15:4; II Timothy 3:16; Hebrews 4:12); and

WHEREAS, the Scripture teaches us that God is love (John 3:16; Romans 5:8; I John 4:8, 16) and holy (Leviticus 19:2; 20:7; I Peter 1:16), and He (God) never changes (Malachi 3:6; Hebrews 13:8); and

WHEREAS, all of us are sinners (Psalm 53:1-3; Isaiah 53:6; Ezekiel 18:4; Romans 3:23), and yet, none of us are beyond the embrace of God's grace, mercy, forgiveness and love through Jesus Christ (Isaiah

53:4-5; John 3:17-19; Romans 3:22; 5:8; Ephesians 2:8-9), leading us to become holy in all of our conduct (I Corinthians 10:13; Ephesians 1:3-6; Philippians 1:6; I Peter 1:13-15); and

WHEREAS, the purpose of Christ's death on the Cross was not only for the forgiveness of sin (Matthew 26:28; Acts 13:38-39; I John 1:7; 2:1-2), but also to make us new, holy creatures in Christ (Romans 6; II Corinthians 5:17; Galatians 2:20; Ephesians 4:17-24; I Peter 2:24-25; I John 3:9); and

WHEREAS, Christ's words to the woman taken in the act of adultery, "Neither do I condemn you; go your way; from now on sin no more" (John 8:11b), should be our words to all individuals who desire to experience God's love, forgiveness and power; and

WHEREAS, love without Truth is not Divine Love, and truth without Love is not Divine Truth (Ezekiel 33:8-9; Matthew 28:19-20; John 7:24; 8:32; 14:15); and

WHEREAS, anyone, who desires to experience this newfound freedom and cleansing power in Christ, must first acknowledge his/her sinfulness and confess it before God (Psalm 32:5; Proverbs 28:13; Joel 2:18; John 16:7-11; I John 1:9); and

WHEREAS, in every reference to the practice of homosexuality in the Scriptures such practice is deemed contrary to God's holy character and unnatural in its behavior (Genesis 19; Leviticus 18:22; 20:13; Romans 1:24-27; I Corinthians 6:9-11; I Timothy 1:8-11); and

WHEREAS, the consistent Christian practice through the centuries has affirmed the Biblical judgment of homosexuality (St. Augustine, St. Thomas Aquinas, and Martin Luther); and

WHEREAS, the founder of our United Methodist Church, John Wesley, writes: "I am not afraid that the people called Methodists should cease to exist either in Europe or America. But I am afraid, lest they should only exist as a dead sect, having the form of religion without the power. And this undoubtedly will be the case, unless they hold fast both the doctrine, spirit, and discipline with which they first set out. What was their fundamental doctrine? That the (entire) Bible is the WHOLE AND SOLE RULE BOTH OF CHRISTIAN FAITH AND PRACTICE" ("Thoughts Upon Methodism" by John Wesley, emphasis added; see also II Timothy 4:1-4); and

WHEREAS, The 2016 Discipline of the United Methodist Church says, "The practice of homosexuality is incompatible with Christian teaching" (Paragraph 304.3), and some annual conference Boards of Ordained Ministry do not even ask the questions concerning human sexuality; and

WHEREAS, the issue of homosexuality has been an on-going struggle causing confusion within our own United Methodist Church for the past 47 years resulting in pastors and bishops officiating at same-sex ceremonies and the election of a practicing lesbian as a bishop (Karen Oliveto, Western Jurisdiction - 2017), without experiencing meaningful repercussions for their disobedience; and

WHEREAS, our homosexually inclined brothers' and sisters' rights to this liberating Truth of the Gospel are being denied due to the ambiguity of previous actions and most recently the overt defiance of *The Book of Discipline* by our leadership on all levels of our Church.

THEREFORE, BE IT RESOLVED, that the 2019 Mississippi Annual Conference confirm the actions of the 2019 General Conference, which confirmed the Traditional Plan upholding the provisions in our 2016 Book of Discipline and the repeated actions of previous General Conferences in regard to human sexuality. That the General Conference hold our leadership accountable (in light of the recent decisions, especially 1341, of the Judicial Council), mandating them to fulfill their responsibility in implementing these provisions. That the General Conference mandate that each individual Board of Ordained Ministry ask the disciplinary questions on human sexuality to each and every candidate, as we in Truth compassionately minister to the LGBTQI community and the world with God's love, grace, mercy and justice. Furthermore, that the General Conference affirm the biblical truth that the practice of homosexuality is contrary to God's standard of holiness and reaffirm Paragraphs 304.3 and 310.2(d) of not allowing the certification or ordination of "self-avowed practicing homosexuals" to serve as an ordained minister or as an appointee to serve in the United Methodist Church.

BE IT FURTHER RESOLVED, all immorality is sin that hinders us from experiencing God's redemptive love found only in Jesus Christ, and because of the confusion regarding the morality of homosexuality within our culture and Church, let it be known the practice of homosexuality (not the inclination) misses the mark of holy conduct commanded by God in His Word, which is the FINAL AUTHORITY on what

is HOLY AND UNHOLY behavior. Furthermore, as to those who are unable to adhere to these Scriptural teachings on the practice of homosexuality and the statutes established in our 2016 Book of Discipline, may they part amicably with a reasonable and fair solution, and may the parting be one of mutual respect, so that the United Methodist Church may have and act as a unified voice concerning the Scriptural Truth regarding the practice of homosexuality.

# 4. Remove Age Limits on Licensing School Enrollment For Those Serving as Local Pastors

WHEREAS, The 2016 Book of Resolution 3161111, 2, and 3 states," John Wesley was a unique and remarkable educator (who) gave to the whole Methodist movement a permanent passion for education"; and

WHEREAS, "Wesley believed that persons develop their full God-given potential when they educate their mind as well as nurture their spirit;" and

WHEREAS, "the historic United Methodist concern for education is witnessed through commitment to educational opportunity for all persons regardless of gender, sexual orientation, ethnic origin, or economic or social background;" and

WHEREAS, the 2016 Book of Discipline (BOD) authorized several groups of people, including licensed local pastors and commissioned pastors (11316, 339, 340) to preside at Eucharist and the Sacrament of Baptism in the charge(s) in which they are appointed;

WHEREAS, the 2016 Book of Resolutions policy on Worship and Liturgy, Article 8032 entitled, This Holy Mystery, states, "Some of these provisions have been in effect since 1976, to enable the sacraments to be served regularly in many small congregations that do not have elders as their pastors. The church continues to seek the best ways to meet this need and still uphold the historic linkage of ordination and administration of the sacraments."

WHEREAS, continuing decline in membership in the United Methodist Church is leaving increasing numbers of small congregations who cannot (afford) have elders as their pastors and rely solely on local licensed pastors and commissioned pastors to preside at Eucharist and the Sacrament of Baptism.

WHEREAS, the number of ordained and provision elders has decreased from 15,806 in 2010 to 14,614 in 2015. At the same time, local pastors appointed to churches climbed from 6,193 in 2010 to 7,569 in 2015, making them extremely valuable in the growth of the denomination and to fulfilling its purpose in making disciples.

WHEREAS, human life span is longer, and many older adults retain their physical, emotional and mental health and working abilities well beyond age 72.

WHEREAS, qualified and certified candidates for ministry, in accordance with the requirements in 11310.1-2 and 11315 of the 2016 Book of Discipline are not permitted to.

attend Licensing School if or they are deemed to be too near retirement age (no later than 72) or post-retirement (after age 72) ..

WHEREAS, while focal clergy (pastors) may be newly assigned to and/or continue to serve one or multiple churches post retirement, they may not seek nor attend licensing school after age 72 and are, therefore, unable to perfom the sacraments.

WHEREAS, local clergy (pastors) who are not permitted to be licensed due to age nor allowed to perform the sacraments through absolutely no fault, other than age, together with the lack of ordained elders in close proximity, results in congregations that will not be able to partake of Communion on a regular basis nor enjoy the Sacrament of Baptism performed in their church by the clergy serving the church.

THEREFORE, BE IT RESOLVED that all age limits imposed on licensing school be removed for full-time and part -time local pastors.

FURTHER, BE IT RESOLVED that older qualified candidates, meeting all other requirements of candidacy, in accordance with the requirements in 1J310.1-2 and 1J315 of the 2016 Book of Discipline, be allowed to enroll in and complete Licensing School. If assigned or appointed, the candidate will be granted a License regardless of age.

It is requested that this Resolution be presented for approval to the Mississippi Conference of the United Methodist Church. Should this Resolution pass and be approved by the Mississippi Conference of the United Methodist Church that it be forwarded to the 2020 General Conference of the United Methodist Church.

#### 5. A Resolution to Do No Harm

WHEREAS John Wesley taught three General Rules that all who sought to be members of a Society Meeting in the early Methodist movement were required to adhere. The primary rule being "First: By doing no harm, by avoiding evil of every kind, especially that which is most generally practiced, such as: The taking of the name of God in vain. The profaning the day of the Lord...Slaveholding; buying or selling slaves. Fighting, quarreling, brawling, brother going to law with brother; returning evil for evil, or railing for railing;...Uncharitable or unprofitable conversation; particularly speaking evil of magistrates or of ministers." 1; and

WHEREAS the author of the Letter to the Romans, writes, "Love does no wrong to a neighbor" 2; and

WHEREAS Jesus taught us the greatest commandments: "The first is, 'Hear, O Israel: the Lord our God, the Lord is one; you shall love the Lord your God with all your heart, and with all your soul, and with all your mind, and with all your strength.' The second is this, 'You shall love your neighbor as yourself.' There is no other commandment greater than these." 3; and

WHEREAS there are numerous references throughout scripture that remind us to do no harm to others 4; and

WHEREAS in Wesleyan theology there is the understanding that the law of love means that we are required to act out of genuine love for our God and our fellow human beings even when our understanding of what that means is subject to ignorance, limits, confusion, disagreement, mistakes, and errors; and

WHEREAS ¶162 of The Book of Discipline of the United Methodist Church 2016 speaks specifically to the rights of all persons, and states "we affirm all persons as equally valuable in the sight of God" 5; and

WHEREAS ¶4 of The Book of Discipline of the United Methodist Church 2016 states "the United Methodist Church acknowledges that all persons are of sacred worth" 6; and

WHEREAS the recent actions and decisions arising from the February 2019 Special Called General Conference and the subsequent rulings during the April 2019 meeting of the Judicial Council of the United Methodist Church do not affirm all persons as being of equal value in the sight of God, and have caused harm to clergy and laity of the United Methodist Church, including those in the Mississippi Conference; now,

THEREFORE, BE IT RESOLVED that the Mississippi Conference of the United Methodist Church: 1. seeks to be in holy conversation with all persons as beloved children of God with sacred worth and equal value;

encourages all clergy and laity of Mississippi United Methodist congregations to refrain from words and actions that cause harm to others;

- asks all United Methodists of Mississippi to love God and one another as unconditionally as we human beings can;
- 4. affirms that all persons are equally valuable in the sight of God, and in the Mississippi Conference of the United Methodist Church; and
- 5. invites us to confess our sin before God and each other when we cause harm to one another, either by word or action.

#### 6. Petition to Discontinue Karen Oliveto as a Bishop of the UMC

THE UNDERSIGNED, The Administrative Board of Shipman UMC, and The Administrative Board of Winborn Chapel UMC, and James Hall, Clergy, all of Seashore District, of the Mississippi Conference of the United Methodist Church, DO HEREBY PETITION, MEMORIALIZE, AND MOVE the 2019 Mississippi Annual Conference to resolve, petition, memorialize, and move THE GENERAL CONFERENCE OF THE UNITED METHODIST CHURCH, IN ALL ITS REGULAR, SPECIAL, AND CALLED SESSIONS ENSUING HEREAFTER, SPECIFICALLY GC2020, but not limited thereto, AS FOLLOWS, to-wit:

WHEREAS, the Judicial Council ["JC"] of the United Methodist Church ["UMC"] upheld and ruled in JC Decision No. 1341 that "Paragraph 304.3 [of the Book of Discipline of the UMC] prohibits the consecration as bishop of a self-avowed practicing homosexual." And,

WHEREAS, the JC also ruled in Decision No. 1341 that "It is not lawful for the college of bishops of any jurisdictional or central conference to consecrate a self-avowed practicing homosexual bishop." And,

WHEREAS, the consecration by the Western Jurisdiction of Karen Oliveto to be a bishop of the UMC was the precipitating event underlying JCD 1341, and such prohibited and unlawful act by the Western Jurisdiction has not been corrected. And,

WHEREAS, Division Two - Section II - Article IV of The Constitution of The United Methodist Church, being ¶16 of *The Book of Discipline* (2016), provides, inter alia,:

The General Conference shall ... have authority as follows:

5. To ... provide for the discontinuance of a bishop because of ... unacceptability.

NOW, THEREFORE, the General Conference of the UMC is hereby petitioned, resolved, memorialized, and moved to "provide for the discontinuance" of Karen Oliveto as a bishop of the UMC for unacceptability, by removing such person from such position and declaring such position vacant.

#### 7. Petition to Require General Conference Ratification of Bishops

THE UNDERSIGNED, The Administrative Board of Shipman UMC, and The Administrative Board of Winborn Chapel UMC, and James Hall, Clergy, all of Seashore District, of the Mississippi Conference of the United Methodist Church, DO HEREBY PETITION, MEMORIALIZE, AND MOVE the 2019 Mississippi Annual Conference to resolve, petition, memorialize, and move THE GENERAL CONFERENCE OF THE UNITED METHODIST CHURCH, IN ALL ITS REGULAR, SPECIAL,

AND CALLED SESSIONS ENSUING HEREAFTER, SPECIFICALLY GC2020, but not limited thereto, AS FOLLOWS, to-wit:

- A. That Book of Discipline (2016) ¶ 27. containing Article V. 2. of The Constitution of The United Methodist Church be amended by insertion of the following symbols and words reflected in underlined italics:
  - 2. To elect bishops subject, however, to the ratification of the next ensuing regular, special, or called General Conference, failing which the election of any bishop whose election is not ratified by a majority of such General Conference present and voting shall forthwith be vacated and held for naught and to cooperate in carrying out such plans for their support as may be determined by the General Conference.
- B. These changes are shown as follows:
  - Book of Discipline ¶ 27 (2016). Article V. of The Constitution of The United Methodist Church
  - 2. To elect bishops subject, however, to the ratification of the next ensuing regular, special, or called General Conference, failing which the election of any bishop whose election is not ratified by a majority of such General Conference present and voting shall forthwith be vacated and held for naught and to cooperate in carrying out such plans for their support as may be determined by the General Conference.
- C. Thus the UMC 2016 Book of Discipline ¶ 27. Article V. 2. shall read
  - 2. To elect bishops subject, however, to the ratification of the next ensuing regular, special, or called General Conference, failing which the election of any bishop whose election is not ratified by a majority of such General Conference present and voting shall forthwith be vacated and held for naught and to cooperate in carrying out such plans for their support as may be determined by the General Conference."

# 8. Petition to Merge Western Jurisdiction into South Central Jurisdiction

THE UNDERSIGNED, The Administrative Board of Shipman UMC, and The Administrative Board of Winborn Chapel UMC, and James Hall, Clergy, all of Seashore District, of the Mississippi Conference of the United Methodist Church, DO HEREBY PETITION, MEMORIALIZE, AND MOVE the 2019 Mississippi Annual Conference to resolve, petition, memorialize, and move THE GENERAL CONFERENCE OF THE UNITED METHODIST CHURCH, IN ALL ITS REGULAR, SPECIAL, AND CALLED SESSIONS ENSUING HEREAFTER, SPECIFICALLY GC2020, but not limited thereto, AS FOLLOWS, to-wit:

A. That ¶ 37. Article I. of The Constitution of The United Methodist Church be amended by insertion and deletion of the following words, symbols, and characters: Immediately following the word "Texas", insert a comma — "," and then delete the following: ". Western—" B. These changes are shown as follows:

Section VII. Boundaries

 $\P$  37. Article I.—The United Methodist Church shall have jurisdictional conferences made up as follows:

Northeastern—Bermuda, Connecticut, Delaware, District of Columbia, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont, the Virgin Islands, West Virginia.

Southeastern—Alabama, Florida, Georgia, Kentucky, Mississippi, North Carolina, South Carolina, Tennessee, Virginia.

North Central—Illinois, Indiana, Iowa, Michigan, Minnesota, North Dakota, Ohio, South Dakota, Wisconsin.

South Central—Arkansas, Kansas, Louisiana, Missouri, Nebraska, New Mexico, Oklahoma, Texas.

Western—, Alaska, Arizona, California, Colorado, Hawaii, Idaho, Montana, Nevada, Oregon, Utah, Washington, and Wyoming and the territory of the United States in the Pacific region.

C. Section VII. ¶ 37. Article I. would then read as follows:

Section VII. Boundaries

 $\P$  37. Article I.—The United Methodist Church shall have jurisdictional conferences made up as follows:

Northeastern—Bermuda, Connecticut, Delaware, District of Columbia, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont, the Virgin Islands, West Virginia.

Southeastern—Alabama, Florida, Georgia, Kentucky, Mississippi, North Carolina, South Carolina, Tennessee, Virginia.

North Central—Illinois, Indiana, Iowa, Michigan, Minnesota, North Dakota, Ohio, South Dakota, Wisconsin.

South Central—Arkansas, Kansas, Louisiana, Missouri, Nebraska, New Mexico, Oklahoma, Texas, Alaska, Arizona, California, Colorado, Hawaii, Idaho, Montana, Nevada, Oregon, Utah, Washington, and Wyoming and the territory of the United States in the Pacific region.

D. All other references in the UM Book of Discipline to "Western Jurisdiction" shall be and hereby are deleted and all boards, councils, agencies, bishops, and other groups, officials, matters, or items, presently pertaining or allocated to or coming therefrom shall be allocated to and be part of the South Central Jurisdiction.

#### 9. A Conscientious Dissent from the Traditional Plan

WHEREAS, by passing the Traditional Plan, the denomination has done great, and perhaps irreparable harm to our LGBTQ+ siblings.

WHEREAS, Today's findings of medical science have shown that misunderstandings and fears of sexual orientation that led to the condemning language and restrictive rules on non-heterosexuals in the *Discipline* are without merit and should be removed. For example, most current science agrees that non-heterosexual orientation is neither a disease nor is it a perversion of heterosexuality. Rather, it is now known to be "a form of sexual orientation established in the womb; it cannot be chosen or transmitted. It cannot be changed, and therefore has its own destiny." (2018 Report on the Science of Human Sexuality, Parts IV. & V.) For more on these and other findings, see *The 2018 Report of the Task Force on the Science of Human Sexuality*. An Official Document commissioned (2017) and produced (2018) by the Mississippi Annual Conference of the United Methodist Church.

THEREFORE, BE IT RESOLVED, the Mississippi Annual Conference (MAC) condemns the decision of the 2019 General Conference to pass the Traditional Plan and apologizes for the harm that it has caused LGBTQ+ persons, their families, their friends, and the body of Christ. "We affirm that all persons are individuals of sacred worth, created in the image of God," but we also assert and affirm that no human being is incompatible with Christian teaching.

BE IT FURTHER RESOLVED, that longing for a time when all shall "sit under their own vines and under their own fig trees, and no one shall make them afraid," we ask that the Mississippi Conference make every faithful effort to insure that no funds or monies (either directly through payments or indirectly through the time of employees of the conference) shall be expended for the purpose of background investigations, complaints, just resolutions, or clergy trials pertaining to LGBTQ+ ordination and marriage.
